2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)

3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).

4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.

5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.) 6. You may then provide testimony.

a. Include only information relating to the above license application.

b. Include only information you have personally witnessed or seen.

c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.

d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.

7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.

8. Business Competition is not a valid basis for denial or non-renewal of a license.

This report is written by Police Officer Corstan D. COURT, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- On 10/12/22 at 2:21pm, Milwaukee Police conducted follow up to a shooting which occurred outside and down the street from the premise located at 418 E. Center Street. A subject was shot after a small altercation by a vehicle that arrived on scene. The day of the shooting, the store was cooperative with police and allowed access to the cameras. The business was not the caller to the shooting.
- 2. On 10/31/22 at 11:34am, Milwaukee Police were dispatched to 2611 N. Holton Street for a fight compliant which occurred at 418 E. Center Street. Investigation revealed that multiple individuals entered the store and began fighting over money. The employee tried to break up the fight and allowed officers to review surveillance video of the incident.
- 3. On 11/03/22 at 2:06pm, Milwaukee Police, the Wisconsin Department of Revenue, Milwaukee Neighbor Services, and a Milwaukee Environmental Health Inspector conducted a license premise check at 418 E. Center Street. The reason for the check was because of an earlier investigation (Item #2) which surveillance video captured people playing gambling machines inside the store prior to the fight. The DOR agents instructed an employee to remove the gambling machines and seized tobacco products that did not have invoices. The DNS Inspector conducted a fire inspection and issued the applicant building code violations (no citations found in system). The MEH Inspector discovered food products that were not cooked at the right temperature and order employees to discard the food. The MEH inspector also

discovered animal droppings in the basement and mice droppings on the ground level in the rear storage area. He issued multiple health code violations (no citations found in system).

On Wednesday, October 12th, 2022 at 2:21 PM, while in full duty uniform equipped with an Axon Body Worn Camera activated and in a marked squad, I conducted follow up at 418 E Center St. (Tittu Rehmat Food), which is located in the City and County of Milwaukee, to conduct a License Premise Report.

This License Premise Report was a follow up to a shooting that occurred outside of the store and down the street on Tuesday October 4th, 2022. A subject was shot after a small altercation by a vehicle that arrived on scene.

I interviewed a store employee, Vikramjit SINGH. SINGH stated the store has 3 employees. SINGH stated the store is opened everyday of the week from 8:00 AM to 9:00 PM. SINGH showed me where all of the licenses were posted inside the store. They were not the callers of the shooting.

On 10-31-2022, at approximately 11:34 AM, (While in full duty uniform equipped with a Axon Body Worn Camera activated an in a marked Squad) We were dispatched to a Fight complaint located at 2611 N. Holton St. which is located in the City and County of Milwaukee. Squad 5190 (PO August FARKAS and PO Marquan ELLISON) responded to the scene to assist.

Upon arrival, officers spoke with individuals involved in the fight and later discovered that the fight occurred at 418 E. Center St. (Tittu Rehmat Food Mart). I spoke with an employee later identified as Ranjit SINGH A/M 12-02-57 414-236-2862 who stated at approximately 11:36 AM there were multiple individuals who entered the business, SINGH stated the subject's were arguing over \$20.00 (US currency). SINGH stated he heard one female subject state "my money" multiple times. The individuals involved began to get into a physical fight with a different citizen in the store and SINGH stated he tried to break up the altercation.

SINGH allowed officers to review surveillance video of the incident, I observed the physical fight occur and SINGH attempting to break up the fight.

We informed SINGH that an incident report was going to be filed regarding the incident

On 11-02-2022 at 5:28 PM, I (PO ALAMO) attempted to reach the license holder Parminder KAUR 414-394-0814 via telephone regarding the incident and left a voicemail.

This report was submitted by PO Keith GARLAND, assigned to District 5, Early Power Shift, CPU (Community Partnership Unit).

On Thursday, November 03, 2022, at approximately 2:06PM, PO Jocelyn KALMANSON (Squad 5264), PO Chauncy HARRIS and Jacob BRYANT-POVLETICH (Squad 5261), and I, PO GARLAND (Squad 5266) responded to 418 E. Canter St(Tittu Rehmat Food) to conduct a License Premise Investigation. Agents Ashley SCHNERING and Erin DORN (Department of Wisconsin Revenue, Alcohol and Tobacco Enforcement) also responded to the scene. Robert LANNIN (Inspector for the Department of Neighborhood Services) and Brian WEINBERG (Environmental Health Inspector for the City of Milwaukee Health Department) later responded to the scene.

Prior to this investigation, Officers David LETTEER and Sophia ALAMO (Squad 5141) were dispatched to 2611 N. Holton St on the date of 10/31/2022 to investigate a Battery Complaint (CAD# 22-304-0661). During the investigation, PO LETTEER and PO ALAMO discovered the battery occurred inside of 418 E. Center St. PO LETTEER and PO ALMO spoke to the business agent, who was identified as Ranjit (NMI) SINGH (I/M, 12/02/1957) who allowed them to view video surveillance footage of the incident. During the investigation, PO LETTEER observed there were multiple gambling machines located inside of the business. PO LETTEER, later, viewed the video surveillance footage and observed that the suspect was playing on the gambling machine prior to assaulting the victim, and after the assault occurred assault, the suspect continued to play on the gambling machine.

Upon my arrival, on today's date, I spoke to two cashiers who were identified as Avula (NMI) SRINU (I/M, 03/10/1998) and Dayala (NMI) VANDANA (I/F, 09/04/1996). VANDANA stated she called the owner who was enroute to the business. The owner/ business agent was identified as SINGH who arrived on scene, shortly after VANDANA called him. The primary business agent was identified Parminder (NMI) KAUR (I/F, 03/19/1998) who did not report to the scene. An additional business agent was identified as

I observed that three gambling machines were located near the front entryway of the business.

Agents SCHNERING and DORN, instructed SINGH to have the three gambling machines removed from the business, and they seized tobacco products that the business did not have invoices for. Agent SCHNERING provided me copies of the following documents:

PO KALMANSON and I observed that the business was selling hot food items (Ground Beef Nachos). I observed a large silver colored pot, contained ground beef that was on top of a countertop hot plate. I observed that the ground beef was partially cooked and the ground beef appeared to be old. WEINBERG conducted a full health inspection. WEINBERG discovered that the food products were not cooked at the right temperature so he ordered SINGH and the business's butcher to discard the food. The butcher was identified as Troy L. MOORE (B/M, 05/13/1996). WEINBERG also discovered animals dropping in the basement and mice dropping in the ground level, rear storage area. WEINBERG issued the business multiple health code violations.
