

Dear Ms. Hinkle:

We have received your claim in the amount of \$382.44, regarding damages sustained to your 2019 Toyota Avalon, on April 18, 2022, when your vehicle hit a pothole located at 4404 W Hampton Avenue.

Our investigation revealed that the Infrastructure Services Division completed a search of call center records from January 18, 2022 through April 18, 2022, between the 4400 blocks and 4500 blocks of W. Hampton Avenue. The Infrastructure Services Division did not have prior knowledge of a hazard in the roadway, when your damages occurred. As such, the City is not liable for damages and we are denying your claim.
