If you feel the garbage or litter was not on your property or feel this letter was issued in error, please call 414-286-5771 to have this matter reviewed. A review does not extend the time to appeal.



Your property has been found to be in violation of having bulky waste exceeding one cubic yard (Sec. 79-6.5-3c-1).

You have <u>5 days</u> of the date of this letter to correct this condition or incur a special charge for removal.

Bulky Waste obstructing the public right of way (sidewalk, street or alley) poses an immediate danger to public health, safety, or welfare and is subject to immediate removal, the property owner will be charged accordingly.

The cost for collection by the City will be \$50 for bulky waste in excess of on cubic yard, but not in excess of 4 cubic yards and \$150 for bulky waste in excess of 4 cubic yards, but not in excess of 6 cubic yards (Sec. 81-15.5). This is the only mailed notice you will receive this calendar year regardless of the number of violations which occur and may result in multiple charges throughout the year. All future violations will be posted and e-mailed if you have enrolled in email notifications through e-notify.
