This report is written by Police Officer Corstan D. COURT, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- On 09/07/22 at 8:00pm, Milwaukee Police were dispatched to 103 E. Keefe Avenue for a reckless use of a weapon complaint. Investigation revealed that a "problem customer" entered the store with a BB gun and shot at employee, striking him in the stomach, causing pain and discomfort. The incident was captured on video surveillance and the employees were extremely cooperative with police on scene.
- 2. On 10/16/22 at 3:51am, Milwaukee Police were dispatched to 103 E. Keefe Avenue for an entry complaint, which later resulted in a shooting investigation. Surveillance video depicted a subject breaking into the business and making his way into the enclosed counter. He then becomes alert that the applicant and another subject had entered the establishment. As the subject is attempting to exit the enclosure, he is shot by the subject who entered the store with the applicant. The subject is then struck several times with several blunt objects all over the body and is pinned down by the subject who shot him until police arrive.

This report is written by Police Officer Zachary RAMION, assigned to Milwaukee Police Department District Five, furthermore assigned as a member of the Captain's Car, Squad 5267 on Early Power Shift.

On Thursday, September 8th, 2022, Squad 5268, Police Officer Ryan MAXCEY and I were dispatched to the address of 103 E Keefe Ave, City and County of Milwaukee, WI regarding a Reckless Use of Weapon call for service. The caller stated that a subject the night prior had come into the store with a BB gun. As this subject was leaving, he brandished the BB gun, firing towards the victim. The pellets struck the victim in the stomach which caused pain and discomfort.

Upon arrival, I met with Kamaljit SINGH (I/M, 09/12/97) who was the store employee that was struck. SINGH stated that the individual is a problem customer who constantly comes into the store. On September 7th, 2022, at approximately 8PM, the suspect came into the store and then as he was leaving, the suspect pulled the BB gun out and fired towards the victim striking him in the stomach. The victim had a visible bruise/welt on his stomach. SINGH also stated that they still had the BB pellets in their possession. SINGH turned the BB pellets over to me. SINGH described the suspect as a B/M, 19-20 YOA wearing a black hooded sweatshirt.

Follow up will be conducted to retrieve the video of the incident.

Upon returning to District Five, I placed the pellets onto Milwaukee Police Department Inventory# 22033331.

There were working video cameras which captured the incident.

This supplemental report is written by Police Officer Romulo MUNIZ-HERRERA, assigned to District Two, Late Shift.

On Sunday, October 16th, 2022 at approximately 3:51 A.M., Squad 2330 (P.O. Nathan ENK and I) responded to an Entry Complaint at the address of 103 E. Keefe Ave., located in the City and County of Milwaukee. This investigation later resulted in a Shooting Investigation.

Upon arrival, I observed the front entrance door of Happy Food Mart damaged, with the secondary screen lock door bent from the bottom but still locked. We were met by Raibin BHULLAR (A/M 4/10/95) and Kamaljit SINGH (A/M 9/12/1997) who unlocked the secondary door with a set of keys.

Upon entering the business, I observed a black male on the ground near the entrance later identified as Darrell L. BROWN (B/M 11/30/1982) who was complaining that he had been shot. A male later identified as Jagroop SINGH (A/M 04/25/1994), had BROWN detained on the ground. My partner and I placed BROWN into custody and walked him over to our squad car.

While my partner was conducting basic medical assessment/interview of BROWN, it was confirmed that he had been shot.

I then asked BHULLAR where the firearm was located, to which he then directed me to the location of the firearm. BHULLAR handed me the firearm, a black Taurus G3 (Serial #ADG439030) semi-automatic handgun that was located under the counter between two cash registers. I then secured the firearm in the trunk of our squad car.

#### Interview of Jagroop SINGH

I interviewed SINGH who stated that he had entered the business first followed by BHULLAR and Kamaljit. SINGH stated that he observed BROWN behind the counter of the business. SINGH stated that through the opening of the bullet proof glass, the he pointed his black Taurus G3 (Serial #ADG439030) telling him to put his hands up. SINGH stated that he does not recall if BROWN attempted to grab his gun or attempted to hit him, which then caused him to shot BROWN once in the leg(right thigh). SINGH stated that after he shot BROWN, BROWN then proceeded to unlock the door and walked out from behind the counter.

#### Video Surveillance Video Depiction

I then reviewed the surveillance camera's video which depicted BROWN breaking into the business and making his way into the enclosed counter space through a small window. BROWN then proceeded to check the cash registers for money and upon becoming unsuccessful; he proceeded to check the tobacco area. BROWN then becomes alert that BHULLAR, SINGH and Kamaljit arrived and are now inside the business. As BROWN is attempting to exit the enclosure, he is shot once by SINGH. Upon BROWN opening the door, he is then struck several times with several blunt objects all over the body and is pinned down by SINGH until police arrive.

This completes my license premise report.
