This report is written by Police Officer Corstan D. COURT, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- On 10/22/2021 at 7:46pm officers were dispatched to a Subject with Gun at Wingstop, 7335
  W. Good Hope Rd. The officers spoke with the victim, who stated an employee of the
  restaurant pointed a gun at him while threatening to shoot him. The officers arrested the
  employee but did not locate a firearm. On 10/29/2021 the officers went to the store to view
  video of the incident. The video showed the customer in an argument with the victim. The
  employee is seen with a gun in his hand but did not appear to point it at the victim. The staff
  was cooperative with the investigation.
- 2. On 03/07/22 at 6:18pm, Milwaukee Police were dispatched to 7335 W. Good Hope Road for a call for police compliant. Investigation revealed that two employees got into a verbal altercation with a customer and had to be physically restrained by two managers in order to keep them from physically fighting the customer. The customer left before police arrival and the employees were asked to leave the store due to the physical altercation they were attempting to engage in with a customer.

This report is submitted by Officer Kevin Becker assigned to District Four, Early Shift.

On Monday, March 7th, 2022, I, Officer Kevin Becker and Officer Jose Ramirez were assigned to Squad 4240 in full duty uniform, a marked Milwaukee police squad and affixed with AXON worn body cameras. At approximately 6:59 PM we were dispatched to a "Call for Police" at the address of 7335 W. Good Hope Rd. which is located in the City and County of Milwaukee. This location is a "Wing Stop" restaurant which is affixed with interior and exterior surveillance cameras.

Upon arrival we were greeted inside the restaurant by the two parties involved. One of which was identified verbally as Brianna D. MOSBY (F/B 02/23/2005), including many of her family members, and Mahaginey J. SEMONS (F/B 11/12/2004) also accompanied by her family members. Both parties informed me that a customer earlier had entered the restaurant and ordered food from MOSBY (who was acting cashier). The customers inquired about the amount of time spent to cook the food and the wait time. A verbal argument ensued between the customer and MOSBY after the customer "snatched" the food from MOSBY's hand. SEMONS and MOSBY continued the argument and were being physically held back from fighting by the two supervisors that were inside the restaurant. One of which was still on scene and identified as Wanda J. LAVENDER (F/B 08/22/1981). LAVENDER was holding SEMONS back while another manager (not on scene) held back MOSBY. At some point during this incident, MOSBY stated she started to push and shove the manager holding her back away out of frustration and may have been pushing his chest area according to MOSBY. MOSBY admitted to striking a nearby picture frame shattering the glass. MOSBY refused medical regarding but was icing her fist. After striking the picture frame, both SEMONS and MOSBY were requested to leave the store due to the physical altercation they were attempting to engage in with the customer. Officers would arrive shortly after with MOSBY and SEMONS both inside the store.

I then spoke with the manager on scene, LAVENDER who gave the same incident statement however stated they were both good employees but has to abide by her manager (DETLOFF) who wanted them to leave the restaurant. LAVENDER stated that the other manager who was shoved left the store due to having chest pains from MOSBY pushing him. LAVENDER did not have access to the cameras inside the restaurant.

I would notify the District Manager of this situation via telephone (number provided by LAVENDER). The District Manager was identified verbally as Matthew T. DETLOFF (M/W 01/18/1988). I informed DETLOFF of the statements I received from all parties and informed him that all parties were inquiring about a corporate phone number. DETLOFF provided me with the manager above his position which I would later relay to all parties regarding. DETLOFF agreed to meet with the parents the following day to review surveillance cameras. DETLOFF requested at that present time all parties involved leave the restaurant with pending termination for the two employees involved.

Two City of Milwaukee Community Contact Cards were issued to both parties of the employees and were informed of DETLOFF's decision.

DETLOFF made no mention or request for any charges regarding the shattered picture frame and just requested the two employees leave the facility.

"Guest stated she and other customers had a horrible experience and this was her first visit to a Wingstop. She stated first she witnessed the female cashier, wearing a hat that said 'Blessed' in rhinestones, being rude to the older female customer in front of her. She stated the receipt had 2 names listed, Jasmine and Tina as host. She reiterated she ordered a 6 piece classic combo, but with veggie sticks instead of fries, she did not want fries. She stated the female cashier aggressively and loudlyasked her in a shocked tone if she did not want fries, twice. She stated she asked the female cashier for a refund and she told her they did not give refunds. She stated she would not give her name and was reluctant to provide a receipt. She stated she asked the cashier and another employee who was the manager and they both ignored her. She stated she asked for a phone number, and the cashier told her no. She stated she video recorded part of the experience and had the names of the other customers who were there. She stated all of the customers were angry by the repeated poor customer service. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

# Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.

2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)

3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).

4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.

5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

6. You may then provide testimony.

a. Include only information relating to the above license application.

b. Include only information you have personally witnessed or seen.

c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.

d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.

7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.

8. Business Competition is not a valid basis for denial or non-renewal of a license.
