This report is written by Police Officer Penny Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 01/17/23 at approximately 12:20p.m., Milwaukee Police were attending a meeting at 6050 W. Fond du Lac Av., where they were informed of After-Hours parties taking place at 6046 W. Fond du Lac. Officers received photos of vehicle parked in front of the location at 2:36a.m. Officers were later approached by a citizen who stated they were in the process of obtaining an extended hours license. A check with License Information Reporting and Administration revealed there were no licenses to operate at 6046 W. Fond du Lac. Further investigation revealed multiple advertisements on various social media platforms of both future and past events. The officer advised the agent they should not be open as they do not have any licenses.
- 2. On 02/02/23 at approximately 7:10p.m., officers were assigned to check for a party at 6046 W. Fond du Lac. This was in regards to information obtained via social media of an event taking place at 6046 W. Fond du Lac. Officers observed a White SUV parked in front of the location, and a Department of Transportation check revealed it listed to the agent. Officers were parked in the gas station next to the location to observe if a party was taking place, and observed two unidentified females get in to the agents White SUV and drive around the block, before parking in the gas station lot. After approximately 10 minutes the driver leaves and a truck pulls into the lot behind the squad. A male exited the truck and asked the officers "what y'all on man, I'm trying to have my birthday party cause I go to Houston tomorrow. Man, let me have my party". Officers advised the citizen they did not have a license to operate.

Upon arrival we met the owner Antwan D. HOGANS (B/M, 1218/1972) at Hookah by Tweezy LLC to verify licenses at the establishment. We received an anonymous tip that an after-set was going on at the location above. Photos were received of multiple Vehicles parked in front of the location above at approximately 2:36 am on the morning of Monday January 16, 2023. In the process of leaving Hookah by Tweezy LLC an unidentified black male came into the location and stated he is from next door at Lounge Sixty46. The unidentified male stated that they were in the process of getting a license for extended hours at the establishment. The unidentified male stated that someone at the Sherman Phoenix was working on a petition to get signatures from the neighbors in order to have extended hours.

Once I arrived back to District Seven, I completed licenses search on Lira and discovered that the establishment Lounge Sixty46 does not any licenses to operate. I continued my investigation on an open social media platform and came a across multiple advertisement flyers of past and future event at the Lounge Sixty46 location. I have provided a link of a recording that was taken from Lounge Sixty46 early in the morning on Sunday January 1,

We reached out to the owner Danielle JONES (B/F, 06/17/1985) and informed her that the establishment should not be open.

This report is written by Police Officer Dominique Thompson (029229) assigned to District Seven, Early Shift.

On Thursday February 2, 2023, at approximately 19:00 pm while assigned to Squad 7266 (P.O. WALKER and I) went to 6046 W. Fond Du Lac, located in the City and County of Milwaukee for special assignment.

Upon arrival we observed a white 2013 Mercedes Benz G1 Sport Utility truck bearing Wisconsin license plates AKF-5172 (Vin#4JGDF7CEXDA115765) registered to Danielle JONES (B/F, 06/17/1985.) JONES is the owner of Lounge Sixty46 at the address above. We have received multiple tips from an OPEN-SOURCE media that shows Lounge Sixty46 distributing digital flyer on an open media source. (I have attached a flyer to the report of the digital advertisement that Lounge Sixty46 has been advertising for private events.)

P.O. WALKER reached out to JONES on Monday January 23, 2023, at approximately 13:48pm and informed her that she is not supposed

to have any events at the location because they don't have license. JONES asked P.O. WALKER if they could have family events at the location and P.O. WALKER informed her that she could not have any events. The same day a digital flyer was uploaded to an open media platform which I have attached to the report.

On Thursday, February 2, 2023, we went out at approximately 19:10pm for a special assignment at the address above for possible birthday party due to an open media source. Upon arrival we parked in front of the Clark gas station located at 6028 W Fond Du Lac Ave., which is next door southeast of Lounge Sixty46. We observed two black unidentified females that came out of Lounge Sixty46 after about twenty MINUTES in front of the establishment. Once the two unidentified black females came out of Lounge Sixty46 they got into a white SUV Mercedes bearing Wisconsin license plates AKF-5172. The white SUV Mercedes went around the block then parked in the Clark gas station parking lot across from the marked squad. The white Mercedes SUV after about ten minutes left from the gas station parking lot.

At approximately 20:18 pm a white pickup truck pulled up behind the squad and an unidentified black male got out of the vehicle and begin to Walk to the driver side of door. When the unidentified black arrived at the driver side of the squad car the unidentified black male stated, "What y'all on man, I'm trying to have my birthday party cus I go to Houston tomorrow. Man, let me have my party." We informed him that the establishment doesn't have license and is not supposed to be open. The unidentified male went back to his vehicle and drove off northbound on Fond Du Lac Ave. We cleared from the special assignment at approximately 21:02pm.



When we completed a business check yesterday, one of the businesses owners stated that the old tire shop had excess to 6046 and use to have parties before they were evicted from the location. He stated that he never said anything because when he had issue, they would look out for him.

The guy that promotes the parties (Facebook Name) is Wanky Wonder. We ran across him yesterday when we were in Hookah by Tweezy completing a business check for a short period of time. He stated that he was getting a petition together so they can have extended hours. When we came outside to go to the 6046 address he was gone.

We later found out that they don't have license or permits to be open at all, and their occupancy permit is on standby. I have attached some flyers of past and upcoming events at the locations.



I'm just informing everyone my findings so we can start to gather our thoughts to put together an execution plan.




# City Concentration Map 6046 W Fond Du lac AV #300


