Investigation revealed the victim had pulled into the gas station to put air in his tires when he was approached by the suspects who displayed a firearm and shot the victim in the neck. 4. On 05/24/2021 at 6:18pm officers were dispatched to 5168 N. 76th St. to investigate an Armed Robbery. The officers interviewed the victim, who stated he was at the gas pumps putting gas in his car when a subject he knows by first name got into his car without consent. The suspect asked to see the victim's firearm. The victim showed his gun and the suspect produced his own gun and demanded the victim's gun. The victim turned over the gun but fought with the suspect. Another suspect produced a gun and the victim fled the scene. As the victim was fleeing the suspect fired 2 shots. The officers recovered spent casings and the business provided video of the incident.

- 5. On 11/06/2021 officers investigated a shooting that occurred at 5170 N. 76th St. The victim walked into District 4 to report the shooting. The officers located shell casings at the entrance to the station. The officers spoke with the clerk who heard 3-4 gun shots outside and saw a car leave the gas station. The clerk provide officers video of the incident.
- 6. On 12/13/2021at 11:49pm officers were dispatched to a shooting at 7615 W. Green Tree Rd. The victim stated they were in a stolen car at the gas station at 5170 N. 76th St. At the station they observed several subject at the station. When they left the station they were followed by those subject. The driver pulled over to see if the car would pass them. The auto pulled up on the passenger side and two subject began shooting at them. Two people in the auto were shot. The subjects then drove to 7615 W. Green Tree Rd, where they got rid of the car and called police. The officers were not able to get the video from the station that night but would follow up to obtain the footage.
- 7. On 05/05/22 at 2:27am, Milwaukee Police were dispatched to 5170 N. 76th Street for an armed robbery compliant. Investigation revealed that an employee, who just got off work, was filling his vehicle with fuel when he was struck from behind with an unknown object. The subject took the employees property and fled the scene. This was witnessed by a co-worker but surveillance cameras were unable to capture the incident.

This report is being written by P.O Issac LORETO assigned to District 7, Late Shift.

On Tuesday, May 5,2022 at 2:27AM while assigned to Squad 7332 (P.O DUFFY and I), Squad 7342 (DAWSON, MOORE), and Squad 7312 (Sgt LIDWIN) were dispatched to an Armed Robbery Complaint at 5170 N 76th St.

Upon our arrival we met up with the victim identified as Manpreet S. KINGRA (A/M, 06/30/1998) who stated he got robbed. KINGRA stated he was leaving work and stopped to put some gas. KINGA stated while he was putting gas someone came from behind and struck him with an unknown object in the back of the head. KINGA stated the subject obtained his iPhone 6, Airpods and wallet. KINGA stated he had approximately \$700 in his wallet.

At the scene I also spoke with Sriram SEETHARAMAN (A/M, 05/02/1967) who stated he witnessed the robbery. SEETHARAMAN is KINGRA'S coworker. SEETHARAMAN stated he was at the register when this occurred. SEETHARAMAN stated he saw a male approximately 5'06", with a beard, wearing a dark colored hoodie, and dark colored pants come behind and assault KINGRA. SEETHARAMAN stated he ran outside the gas station and the subject fled South-East on W Medford Ave from N 76th St.

At the scene we checked the cameras but the incident its not captured on camera.

Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.

2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)

3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).

4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.

5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.) 6. You may then provide testimony.

a. Include only information relating to the above license application.

b. Include only information you have personally witnessed or seen.

c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.

d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.

7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.

8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
