Thanks for your questions. Parking management claim this change will actually increase turnover of parked vehicles thereby increasing on-street parking availability. In addition, I am told the city is not required to run all meters until 9 pm. They are open to looking at specific locations where 6 pm can be retained.

Regarding installing parking meters, DPW does look at parking demand at given locations to determine whether the demand would justify the cost of installing meters. I am told areas without meters are areas where the revenue would not justify the cost.

I would suggest signing up for e-notify. The file has been pending since last fall and it has been heard twice by the Public Safety Committee. It is set for CC approval tomorrow.

Good Afternoon,

I'm a resident at 418 N 3rd St, Milwaukee who is writing against proposed changes to Milwaukee street parking. Myself and many of my neighbors rely on the availability of street parking overnight during the week and on weekends as we commute to and from work. Open surface parking lots nearby are an alternative, which cost \$100+ per month. The \$100/month is not nearly as concerning as the car break-ins that happen on those poorly lit and monitored properties.

Although there could be meaningful personal financial impact, my main concern is the impact this may have on downtown businesses and the continued development of the area. As a 7 year resident of downtown, I see people park near my building on week nights and weekends frequently to grab a bite to eat, coffee, or shop with friends. It just so happens the street fills up once parking is free... It's great to see Westown transform into an area that feels safer with more people around when walking my dog in the evening from what was generally an eye sore to the city when I first moved here. This has been in large part, due to the increased businesses opened, supported meaningfully by those who drive to downtown from surrounding areas.

In speaking with friends and family who often visit on week nights and weekends, the appeal of coming downtown on week nights and weekends greatly diminishes when adding paid parking to the equation. Areas of downtown Milwaukee with paid metered parking would be at a great disadvantage to other nearby areas without metered parking, such as Walkers Point, Bay View or Tosa when deciding where to meet with a group arriving from varying locations. I want to see downtown Milwaukee continue to develop and decrease crime west of the river; the deterrence of free parking in the area would not support either objective, providing another reason for those in surrounding areas not to make the short drive downtown when shopping, dining, or deciding who in the group is hosting the next dinner party.

In an environment where budgets are getting stretched for the average consumer, an added fee such as parking could be psychologically more impactful than the economic dollar amount. At least that's the input I've received from the many friends, family and coworkers who live outside of downtown that have heard the proposed changes.

Milwaukee should consider actions that encourage people to come downtown and spend money, bolstering local economics; not discourage it. More people = more money. Let's make downtown Milwaukee a more welcoming location for all!

As a side note, perhaps the public market has data on the impact of them offering temporary free parking has had on increased visits and sales. Why would they offer free parking if it didn't matter?

I saw that your office is reconsidering the parking meter change to 9pm. If your office was considering more opinions, I think it would be bad for business to change the parking meters. Having free parking helps downtown businesses that already have a very limited amount of parking available. It also will make it difficult for customers to come and dine at our establishments before an event because they would need to return to their cars or apps to redo their parking because it would expire with the current 2-hour limits when they were going from our establishments to the event causing unnecessary conflicts with timing and ticketing with parking. This will discourage people from frequenting downtown entertainment establishments.

I believe the cost reward or parking revenue to sales tax and downtown public opinion is not worth changing the parking meters to 9pm and weekends.

Eliminating parking late night on weekends can help with the loitering issues that Water Street has experienced in the summertime, but it will hurt our dinner crowds in non-bar establishments that rely on a dinner service.

Thank you for sharing your thoughts. You make some excellent points. Yours is the first communication I have received supporting these changes so I appreciate it. I personally support your assertion that free or below market parking simply promotes and reinforces an auto centric culture but I represent many diverse constituencies downtown and there are divergent opinions.

The basic issue here is transparency. The downtown BIDs, the Downtown Neighborhood Association and most residents and condo associations were not aware of this proposal. BID 21 told me they last discussed downtown meter hours in 2019. All these stakeholders deserve the opportunity to discuss these changes with their constituencies and weigh in on the policy change. Most of the opposition so far is from downtown residents and condo associations who are concerned about the impact of this change on guests to their homes—not suburban visitors or patrons of hospitality establishments. They have a point given that we have heavily promoted downtown residential development. For these constituencies, downtown is their neighborhood not simply an entertainment district.

At the end of the day the changes may stand or be modified but hopefully we will have a full and robust discussion which did not occur the first time around. Finally, now is the time to revisit this issue before any time and money is expended implementing these changes. Moreover nothing is lost since DPW would require months to implement these changes given the number of signage changes required and reprograming of meters.

People will not stop going downtown. Instead, with paid parking, they will have an easier time finding a spot, and yes, they will have to pay a very small amount of money. Keep in mind that I take the bus every day, I visit our Third Ward and Downtown businesses nearly every day, and I never get free bus fares. I do not understand this idea that some people should get free transportation, and others should not. Furthermore, I think it is absurd that we are supporting people drinking and driving: with some basic costs like parking associated, the math makes more sense to take the bus or an Uber/Lyft/walk.

Our parking is already extremely cheap. Paying for parking reduces people circling blocks -- reducing traffic. Paid parking helps to ensure a spot or two is open on blocks, meaning that fewer people are circling around, angry that they can't find a spot. I can tell you as a pedestrian than people circling looking for parking has *absolutely* led to people almost hitting me with their car as they frustratingly try to find a spot.
