3. Review and approval of the previous meeting minutes from February 6, 2023.

The meeting minutes from February 6, 2023 were approved. There were no objections.

4. Review, discussion, update, or motion(s) on the task force reporting deadline.

Chair Coggs said that she wanted to revisit and discuss with the task force on extending the task force deadline. Ald. Michael Murphy had suggested at a recent Finance and Personnel Committee meeting on extending the deadline beyond May 31, 2023 to August 1, 2023 to give the task force more time and to especially consider the impacts to the City regarding the State's allocations to the City, if any, that were anticipated to be determined in the summer.

Members and staff discussed the options to keep the extension to May 31, 2023 or changing it to August 1, 2023, July 11, 2023, or June 30, 2023. Important considerations included the timeliness to align ARPA allocations with the City's budget process for next year with August maybe being too late, knowing whether the City would have additional funding to free up ARPA allocations, cautioning against making ARPA allocations too early should the City receive State funding, and whether any State funding would be earmarked for the City for use next year.

Member Zamarripa moved to change the task force extension deadline to August 1, 2023. She withdrew her motion after discussions.

Member Karanja moved to have public testimony, due to public request, and later withdrew the motion. The meeting was not noticed for public testimony, the task force had discretion over whether to permit public testimony, and the overall sentiment was to not have public testimony due to possible diversion that it may cause to the meeting, if any.

Overall, members discussed, as a happy medium, to extend the task force deadline to or after June 30, 2023 but before August 1, 2023 after all considerations were made.

Ald. Zamarripa moved to extend the task force recommendations deadline to June 30, 2023 in lieu of May 31, 2023. There were no objections.

After the meeting it was found that reference to June 30, 2023 was in error due to there being no Common Council meeting on June 30, 2023. Therefore, Chair Coggs would submit legislation to extend the task force deadlines to June 20, 2023 for introduction of a file, July 7, 2023 for review by the Finance and Personnel Committee, and July 11, 2023 for review by the Common Council.

Ms. Norfolk would prepare the necessary legislative amendment and chair Coggs would present the amended task force deadline extension legislation at tomorrow's Common Council meeting.

Members and staff discussed that all meetings were well attended and successful, included much testimony by the same well-organized community groups, that all public input from the meetings were being compiled, for all paper surveys to be submitted to the City Clerk's Office for compilation, and for all public input information to be compiled and presented to the task force in the near future.

Member Chambers, Jr. said that all public input meetings were sufficient and no additional public input meetings were needed despite his interest in adding additional sessions at the last regular task force meeting.

6. Review, discussion, update, or motion(s) relating to work groups and work group activities.

A. Public Engagement and Information Dissemination Work Group

No new update. Member Zamarripa said that the work group had concluded its task of coordinating and holding the public input sessions.

B. Proposal Collection, Review Funding and Criteria Work Group

Member Knapp said that the work group has not met recently but did come to consensus in creating ARPA proposal request form, instructions, and evaluation criteria for the task force to consider, review, and approve. Members were sent these documents recently.

Members discussed to have all those documents as agenda items for the task force to formally consider at its next meeting. It would allow members to have adequate time to review the documents.

Members also discussed to have a robust discussion at the next meeting, aside from the request and evaluation criteria, on the ARPA application submission process and timeline. The manner of submissions was referenced in the task force enabling legislation. It would be prudent to make these determinations since the public were at the ready to formally make requests.
