This report was submitted by Police Officer Michael Antoniak of the Milwaukee Police Department, currently assigned to District Six, Day Shift.

On Saturday, October 29, 2022, at 1:03pm, I (Antoniak), along with Squad 6190 (Police Officer Bradley Johnson), were dispatched to 6181 South Howell Avenue, in the City and County of Milwaukee, for a complaint of a fight.

CAD (223020822) stated, CLR STS PEOPLE FIGHTING AND THROWING POTS OF COFFEE...STS AN EMPLOYEE AND A CUSTOMER ARE FIGHTING...THE EMPLOYEE WALKED OUT, UNK WHERE SHE WENT. A second call for police service, (CAD# 223020023) stated, WTG FOR INFO, COFFEE POTS AND UTENSILS BEING THROWN.

Actors involved were identified as Kimberly A. Gee (B/F, 11-11-83), Employee, and Nichole M. Dorsey (B/F, 07-05-90), Customer.

Upon arrival, I spoke with the Manager, Pamela J. Bloom (W/F, 01/27/62), who stated a fight broke out between a customer and an employee. Bloom indicated the incident was captured on surveillance. Bloom and I reviewed the surveillance. I observed Dorsey, and her family arrived at approximately 12:59pm and walked over to a booth along the south wall. Dorsey placed a child in a high chair. Within a minute, Dorsey removed the child from the high chair and began walking toward the exit. Dorsey stopped in the aisle and waited for her mother and child. I observed Gee and Dorsey standing in the aisle, in close vicinity of one another. I observed Gee passed Dorsey. I then observed Dorsey hand over the child to her mother and proceeded to follow Gee toward the exit door. I observed Dorsey kick Gee from behind and a fight ensued. I observed Gee grab, what appeared to be a coffee pot, and swing toward Dorsey. I observed Gee and Dorsey continued fighting, but were separated. I observed Dorsey proceeded to stand on a table or bench. I then observed a white male (later identified as David M. Jutrzonka, W/M, 10-15-55) grab Dorsey, while standing on the table/bench, and take her to the ground. Bloom indicated video surveillance will be available on Monday, October 31, 2022.

Bloom indicated that Gee had previous altercation(s) with patrons in the past.

Dorsey subsequently left the scene.

Dorsey returned to the scene,

I spoke with Jutrzonka, who stated he was at George Webbs with his son and grandkids, Jutrzonka stated he observed Dorsey kick Gee. Jutrzonka stated Gee proceeded to grab a pot of coffee. Jutrzonka stated during the fight that his grandchild sustained redness to the right cheek. Jutrzonka stated, to protect others, he grabbed Dorsey and took her to the ground in an attempt to detain her until police arrival.

I then spoke with Dorsey, who stated she arrived to George Webbs with her children and mother and walked over to a booth. Dorsey stated she placed her child in a high chair. Dorsey stated Gee walked past, while making physical contact with her, and told her [Dorsey] that she couldn't use that high chair and needed to use the one in the corner. Dorsey stated Gee then walked over to another patron and engaged him in a very rude manner. Dorsey stated that she told her mother that they would be leaving due to the customer service. Dorsey stated she picked up child.

Dorsey stated she waited for her other child and mother to catch up. Dorsey stated, at this point, Gee was standing next to her. Dorsey stated that Gee pushed herself past her [Dorsey]. Dorsey stated that she told Gee, "You can say excuse me!" Dorsey indicated that Gee responded, which upset her. Dorsey admitted that she proceeded to kick Gee. Dorsey stated that Gee then referenced throwing something "hot" onto her. Dorsey stated that Gee then grabbed a pot of coffee and swung at her. Dorsey admitted that she was acting "belligerent" and probably excessive. Dorsey admitted to standing on a bench and stated that Jutrzonka grabbed her and restrained her on the ground. Dorsey believed that to be excessive.

I observed Dorsey had, appeared to be superficial burns to her left shoulder, resulting in skin peeling. Dorsey denied medical treatment on scene. Dorsey indicated that she may go to an Urgent Care at a later time. Dorsey indicated that she wanted to get her children to Trick or Treat in the Bay View area.

License Premise Report -RE

This report is being written by PO Chris DZIADOWICZ, assigned to Milwaukee Police Department (District 6), day shift, squad area 6130. On Saturday, November 5th, 2022, I was dispatched to 6181 S Howell Ave, in the city and county of Milwaukee, equipped with a Body Worn Axon Camera, in a marked squad.

At approximately 11:08 am, I was dispatched to George Webbs restaurant, at the above listed address, for a complaint about fraud. Upon arrival I spoke to the victim identified verbally as UIHLEIN, Angela M F/W 03/07/1972. UIHLEIN stated that at approximately 10:55 am on that day, an unknown actor entered the restaurant and ordered an orange juice which was priced at \$4.03. The actor then provided UIHLEIN with a \$5.00 bill as payment. The unknown actor told UIHLEIN to keep the change as a tip. UIHLEIN stated that the unknown actor then provided her with a \$5.00 bill and four \$1.00 bills and asked for two \$5.00 bills back as change. The unknown actor then provided her a total of \$19.00 and asked for a single \$20.00 bill back in return. The unknown actor then asked for all of the money back from UIHLEIN. The unknown actor left the business, then returned to retrieve his wallet, the unknown actor gave UIHLEIN \$10.00 and told her that she gave him too much.

UIHLEIN did not initially provide the unknown actor their wallet because she wanted the police present. The unknown actor then crossed the threshold to go behind the counter, into the employee area, by the register. The unknown actor then made verbal threats to UIHLEIN to give his wallet back to him. UIHLEIN stated that the unknown actor's actions and threats made her feel like her safety was being threatened.

UIHLEIN described the unknown actor to be male, Black or possibly Hispanic, about six feet tall, thin build, wearing a black jacket with a neon-colored construction type safety vest underneath, and wore light blue jeans.

At no time did UIHLEIN give the unknown actor permission to go behind the employee counter, or to threaten her, thus causing her to fear for her safety.

At this time, this investigation is ongoing.

Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
