There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. It is the intention of the Common Council to suspend or non-renew the licenses if objectors provide testimony related to the factors enumerated in MCO 85-4-4 that the Common Council finds to be true by a preponderance of the evidence and/or police reports are found to be true by a preponderance of the evidence. The police reports and other attached documents relating to objections to the license are a part of this notice and expressly incorporated in this notice. The licensee should be prepared to address these matters at the hearing.

Notice for applicants with warrants or unpaid fines:

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing. You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing. You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below. Limited parking for persons attending meetings in City Hall is available at reduced rates (5 hour limit) at the Milwaukee Center on the southwest corner of East Kilbourn and North Water Street. Parking tickets must be validated in the first floor information booth in City Hall.

Thank you for letting me know. I have been in contact with MPD and the City Attorney. A record of complaints is being compiled to see if a nulsance designation for this establishment is applicable.

I cannot call a hearing, outside of their annual renewal hearing, unless there is a documented record that supports a license revocation. At the time of their renewal earlier this year, neighbors within 200 feet should have received a renewal notification letter. Given the Licensing Division had no record of complaints, their renewal was not scheduled for a hearing and granted via the "agenda only" process.

This is the standard practice for licensed establishments with no documented record of complaints.

Please continue to report any illegal or nuisance issues you witness to police. Feel free to contact me if I can be of assistance.

# What is sleep deprivation?

Sleep deprivation means you're not getting enough sleep. For most adults, the amount of sleep needed for best health is 7 to 8 hours each night.

When you get less sleep than that, as many people do, it can eventually lead to many health problems. These can include forgetfulness, being less able to fight off infections, and even mood swings and depression.

# What causes sleep deprivation?

Sleep deprivation is not a specific disease. It's usually the result of other illnesses or from life circumstances.

Sleep deprivation is becoming more common. Many people try to adjust their schedule to get as much done as possible, and sleep is sacrificed.

Sleep deprivation also becomes a greater problem as people grow older. Older adults probably need as much sleep as younger adults, but they typically sleep more lightly. They also sleep for shorter time spans than younger people. Half of all people older than 65 have frequent sleeping problems.

Sleep deprivation can occur for a number of reasons:

Sleep disorder. These include insomnia, sleep apnea, narcolepsy, and restless legs syndrome.

**Aging.** People older than 65 have trouble sleeping because of aging, medicine they're taking, or health problems they're having.

**Illness.** Sleep deprivation is common with depression, schizophrenia, chronic pain syndrome, cancer, stroke, and Alzheimer disease.

**Other factors.** Many people have occasional sleep deprivation for other reasons. These include stress, a change in schedule, or a new baby disrupting their sleep schedule.

## What are the symptoms of sleep deprivation?

At first, sleep deprivation may cause minor symptoms. But over time, these symptoms can become more serious.

Early sleep deprivation symptoms may include:

Drowsiness

Inability to concentrate

Memory problems

Less physical strength

Less ability to fight off infections

Sleep deprivation problems over time may include:

Increased risk for depression and mental illness

Increased risk for stroke and asthma attack

Increased risk for potentially life-threatening problems. These include car accidents, and untreated sleep disorders such as insomnia, sleep apnea, and narcolepsy.

# How is sleep deprivation diagnosed?

Sleep specialists say that one of the telltale signs of sleep deprivation is feeling drowsy during the day. In fact, even if a task is boring, you should be able to stay alert during it if you are not sleep-deprived. If you often fall asleep within 5 minutes of lying down, then you likely have severe sleep deprivation. People with sleep deprivation also have "microsleeps." These are brief periods of sleep during waking time. In many cases, sleep-deprived people may not even be aware that they are having these microsleeps.

If you have any of these warning signs listed above, see your doctor or ask for a referral to a sleep specialist. Your doctor will ask you detailed questions to get a better sense of the nature of your sleeping problems.

In some cases, if your doctor thinks you have a more serious and possibly life-threatening sleep disorder such sleep apnea, then the sleep specialist may do a test called a sleep study (polysomnography). This test actually monitors your breathing, heart rate, and other vital signs during an entire night of sleep. It gives the sleep specialist useful information to help diagnose and treat your underlying disorder.

# How is sleep deprivation treated?

Treatments for sleep deprivation vary based on how severe it is. In some cases, your doctor may want you to try self-care methods before turning to medicine. Your doctor may prescribe sleeping pills. But keep in mind that they tend to work less well after a few weeks. They can actually disrupt your sleep. Sometime insomnia is caused by an adjustment in your body clock. This is called a circadian rhythm disorder. For this, your doctor may have you try light therapy. It can help your body's internal clock readjust and allow you to sleep more restfully.

If you are diagnosed with sleep apnea, your doctor may prescribe a special breathing machine to use while you sleep. It's called CPAP (continuous positive airway pressure). This machine gives you a continuous flow of air through a mask. This help keep your airway open.

# Can sleep deprivation be prevented?

If your sleep deprivation is mild, these simple strategies may help you to get a better night's sleep:

Exercise at least 20 to 30 minutes each day, at least 5 to 6 hours before going to bed. This will make you more likely to fall asleep later in the day.

Don't use substances that contain caffeine, nicotine, or alcohol. Any of these can disrupt your regular sleep patterns. Quitting smoking is always a good idea.

# How to manage sleep deprivation

Creating a relaxing bedtime routine often helps conquer sleep deprivation and give you a good night's sleep. This can include taking a warm bath, reading, or meditating. Let your mind drift peacefully to sleep. But don't eat a large meal just before bed. It can make it hard to sleep.

Another step that may help you to get a good night's sleep is sticking to a consistent schedule. This, means that you go to bed and wake up at the same time every day. If possible, waking up with the sun is a good way to reset your body's clock more naturally.

Also keep your bedroom at a reasonable temperature. A bedroom that is too hot or too cold can disrupt sleep.

If you're having trouble sleeping, try doing something else like reading a book for a few minutes. The anxiety of not being able to fall asleep can actually make sleep deprivation worse for some people.

Finally, see a doctor if your problems with sleep deprivation continue. Don't let sleep problems linger.

Ask if your condition can be treated in other ways.

Know why a test or procedure is recommended and what the results could mean.

Know what to expect if you do not take the medicine or have the test or procedure.

If you have a follow-up appointment, write down the date, time, and purpose for that visit.

Know how you can contact your provider if you have questions.



The Milwaukee Police Department's investigation regarding this application revealed the following:

- On 09/26/21 at 2:20am, Milwaukee Police were dispatched to 1900 W. Lincoln Avenue for a fight compliant. Investigation revealed that a group of subjects tried to fight a single subject outside the tavern. The one subject handed security a firearm and all subjects began to fight (including security). The security guard who was handed the firearm, began striking subjects with that firearm. The applicant was on scene and was involved in the fight.
- 2. On 10/06/21 at 2:00pm, a subject walked into the Second District to report a battery which occurred on 10/01/21 at 1900 W. Lincoln Avenue. Investigation revealed that the subject was drinking at the tavern and got into an argument with two subjects. The argument turned physical and all subjects were removed by security. While outside the subject was assaulted by several people which required him to seek medical attention.
- 3. On 05/15/22, officers and detectives responded to a shooting at 1913 W. Lincoln Avenue. Investigation revealed that the victim had patronized the tavern located at 1900 W. Lincoln Avenue and left the establishment at closing time. While sitting in his vehicle, a subject fired over forty rounds into his car killing him.

- 4. On 06/10/22 at 9:45pm, Milwaukee Police, along with the Wisconsin Department of Revenue, conducted a license premise check at 1900 W. Lincoln Avenue. When entering the tavern police observed two security guards who were armed (one had a firearm in his pants pocket and the other in a satchel). The applicant was upset with the Department of Revenue Agent and said he was going to call his cousin and complaint to her about the "tavern check". The applicant did not have any receipts for the liquor brought for the tavern but said he had them at his residence. The agent gave the applicant a chance to produce the receipts on a later date and confiscated all the liquor that was left by the previous owner.
- 5. On 06/11/22 at 1:03am, Milwaukee Police were dispatched to 1900 W. Lincoln Avenue for a noise complaint. Upon arrival, Officers observed that the tavern was closing and patrons were gathered outside playing loud music from their vehicles and loitering in front of the tavern. Police did not observe any security guards trying to get patrons to leave or stop playing their loud music. Officers interviewed the caller who stated that this is an ongoing problem.
- 6. On 06/12/22 at 1:38am, Milwaukee Police were dispatched to 1900 W. Lincoln Avenue for a ShotSpotter compliant. Investigation revealed that a subject was denied access to the tavern because he had a firearm. The subject became upset and a small altercation happened out front with security and the subject. A short time later the applicant heard multiple shots fired. Officers recovered 16 spent casings, with 3 rounds striking the address of 1834 W. Lincoln Avenue.
- 7. On 07/13/22 at 4:00pm, Milwaukee Police, along with other representatives of the city, conducted a meeting with the applicant from 1900 W. Lincoln Avenue. The reason for the meeting was to explain to the applicant that his premise was going to be designed a chronic nuisance property and the options or actions he can take. 19 calls for service were entered into the report.
- 8. On 08/21/22 at 2:03am, Milwaukee Police were dispatched to 1900 W Lincoln Avenue for a noise compliant. Upon arrival, the tavern was closed and there was only one person outside. Officers interviewed the manager who stated that she has been trying to control the people who go outside and plans to hire another security guard to help with the noise. She also said that she has an issue with the caller because he walks by the tavern when she's opening with a firearm on his hip and calls her a derogatory name. Officers tried to explain the report process to the caller but he hung up on police.

MLR stated that they left the bar at bar close at approximately 2:00am, and both walked to her car parked at 1913 W Lincoln St.

MLR stated that she walked to a parking lot across the street to speak with other patrons to see where the after-set party would be. After that, she and ESTELA-ORTIZ started to walk back to her vehicle. ESTELA-ORTIZ got to the car first, sat in the driver's seat, when the suspect walked up to the vehicle, and fired over 40+ shots into MLR's vehicle, striking ESTELA-ORTIZ over 20 times, killing him. One of the subjects who was later identified as Edwin MORALES-DIAZ (W/M 12/07/84) was carrying a firearm in his front right pocket. The second subject who was later identified as was wearing a satchel across his chest and was carrying a firearm inside the satchel. Both subjects stated they where security for the tavern. I felt this was not normal to carry firearms in your pants pocket and in satchel.

I made contact with the listed agent of the tavern who was identified as Tomas HERNANDEZ (06/17/81). HERNANDEZ stated he has one security guard. I explained to HERNANDEZ that the reason we were there was due to the a homicide that occurred across the street from his tavern with a patron of his tavern and a substantial battery that occurred to his patrons and his security guards. Agent WALDHERR spoke with HERNANDEZ and HERNANDEZ became upset. He stated he was told that we where going to conduct a tavern check and that he was going to call his cousin Maribel MURILLO and complain to her about us conducting a tavern check.

HERNANDEZ didn't have receipts for the liquor bought for the tavern but stated it was at his residence. Agent WALDHERR told HERNANDEZ he would give him a chance to get his receipts and forward them to him on the following day. Located in the basement were several boxes containing beer. HERNANDEZ stated that most of those boxes were from the previous owner. Agent WALDHERR confiscated 4 boxes of Coors Light, 5 Estrella, 4 Modelo, 3 XX, 7 Pacifico, 3 Red Apple, 8 White Claws, 4 Corona and 5 Miller Lite boxes of beer.

Michael RADAVICH, Safe and Sound Neighborhood Safety Coordinator Araceli ARAVELLO and I met with Tomas HERNANDEZ, the licensee of Diamante Negro which is located at 1900 W Lincoln Av, at District Two and regarding recent incidents involving firearm offenses, fights, and noise nuisance complaints.

Captain PAJOT expressed his support for responsible local businesses and I read a summary of nuisance related incidents that involved Diamante Negro. I explained MCO 80 -10 (Chronic Nuisance Premises ordinance), why the premises was designated a nuisance property, and options that HERNANDEZ faced including not taking any action, appealing the designation, and submitting an abatement plan as well as the process described in MCO 80-10 regarding abatement plans. HERNANDEZ stated he understood the ordinance and was aware of the incidents. HERNANDEZ stated that he had already fired the DJ/promotor that attracted a problematic customer base and was considering changes to how he operated the business.

Regarding the noise complaints, HERNANDEZ stated that there is one neighbor in the area who he is aware often complains. HERNANDEZ provided several printed text message exchanges between the neighbor and he and HERNANDEZ stated that he would provide the documents to the City of Milwaukee so that they could be included in his licensing file. The exchanges essentially have the neighbor complaining to HERNANDEZ about loud and profane customers keeping him awake around bar close and then the neighbor and HERNANDEZ insulting each other. HERNANDEZ stated that he felt the complaints were not valid and that if the subjects had been patrons at his bar he was not responsible for them once they had left.

Several suggestions were made to HERNANDEZ for consideration including; personally being outside to monitor patrons at close, requesting a meeting with neighbors to hear their concerns/complaints about the business, closing earlier, changing the format of the business, changing the name of the business, reaching out to other business owner that successfully manage customers exiting taverns at close, reminding and monitoring employees not to over-serve customers, etc.

I informed HERNADEZ that I would also include a summary of noise nuisance calls in this summary. A search of Department Records revealed the following calls for service at 1900 W Lincoln Av and the intersection of S 19th St / W Lincoln Av:

On Sunday, August 21st, 2022 at 2:03 AM we were dispatched to a noise nuisance complaint at the address of 1900 W Lincoln Ave (which is located in the City and County of Milwaukee). The caller who identified himself as Patrick J DOYLE (M/W 09-03-1960) who resides at 1918 W Lincoln Ave and stated that the listed bar was being "extremely loud".

Upon our arrival to the establishment there was only one person outside waiting for a ride home. The bar was closed but we were able to observe employees inside cleaning up. We made contact with the employees and let us inside the bar. I was able to make contact with the manager who identified herself as Melisa M GONZALEZ (F/W 12-20-1978). GONZALEZ was made aware that there was a complaint made about the establishment. GONZALEZ stated that they have been trying to control the people who go out and smoke in front of the establishment because they get too loud. GONZALEZ stated she was in the process of hiring a second security guard to address the issue.

GONZALEZ stated that she has had issues with DOYLE when she opens the bar, and believes DOYLE is trying to intimidate her by walking in front of the bar with a firearm on his hip. GONZALEZ stated that DOYLE has been calling her a "faggot". A check of the CAD System did not reveal any complaints made by GONZALEZ. GONZALEZ was highly cooperative throughout the interview and provided us with all the information needed by police.

I made contact with DOYLE via phone call. DOYLE was highly upset and stated that he has been sleep deprived due to the bar's excessive noise levels. DOYLE became upset during the phone contact while we attempted to explain the report process and he hung up the call.

This concludes my report.
