We, Attorney Michael Maistelman, Maistelman and Associates and Attorney Vincent J. Bobot, Bobot Law Office LLC, represent Chamber East Food Market LLC in connection with the above-referenced matter, an application for renewal of the Class A Fermented Malt and Food Dealer licenses. The Licenses Committee recommended non-renewal of Chamber East Food Market LLC's licenses following the hearing conducted on March 29, 2023.

OBJECTION TO THE FINDINGS OF FACT AND CONCLUSIONS OF LAW

- 1. Neighbors appeared at the Licenses Committee hearing in support for renewal of Chambers East Food Market LLC's licenses.
- 2. No neighbors testified against renewal of Chamber East Food Market LLC's licenses.
- 3. Davinderjit Kaur, the "Agent", was in the country of India when a video in November, 2022 depicted violations at Chamber East Food Market. The Agent's brother, who owns the building, was in charge during the Agent's absence.

- 4. The Agent, under no circumstances, condoned the behavior of her brother.
- 5. There were no incidents before the November, 2022 video warranting action by the Licenses Committee against Chamber East Food Market LLC.
- 6. There were no incidents after the November, 2022 video warranting action by the Licenses Committee against Chamber East Food Market LLC.
- 7. The Licenses Committee speculated that there would be further illegal conduct at Chamber East Food Market LLC without an evidentiary basis.
- 8. Progressive discipline was not properly vetted by the Licenses Committee.

OBJECTIONS

We formally object to the Report of the Licenses Committee and recommendation of non-renewal of the licenses under the following grounds:

- A. The Committee considered hearsay without any evidentiary basis;
- B. The Report contains incorrect factual and conclusion statements and key facts without any evidentiary basis;
- C. Neighbors testified at the hearing in support to renewal of the licenses, and no neighbors testified against renewal of the licenses;
- D. The notice dated March 16, 2023 provided insufficient notice to Chamber East Food Market LLC citing reasons for imposition of the non-renewal of its licenses in violation of 85-3, MCO;
- E. The Committee speculated on possible future wrongdoing by the management of Chamber East Food Market employees without an evidentiary basis.
- F. The Committee failed to follow its customary and required principles of progressive discipline when considering imposing sanctions such that it should have recommended a warning letter or a lesser suspension time. (Wisconsin courts have noted that such principles are appropriate in order to satisfy equal protection requirements of the U.S. Constitution, 14th Amendment. See *Village of Menomonee Falls v Michelson*, 104 Wis 2d 137, 145-146, 311 N.W. 2d 658 (Ct. App. 1981)
