There is a possibility that your application may be denied for one or more of committee regarding the application shall be based on evidence presented at the hearing. Per McO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. This report is written by Police Officer Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 05/22/22 at 4:58p.m., Milwaukee Police conducted follow up at 432 E. Chambers., regarding multiple Health Department violations and an order to cease all food sales. The officer interviewed the cashier who stated the Health Department had cleared the business to resume food sales on 05/21/22. The officer was able to confirm the food license had been issued.
- 2. On 10/27/22 at 12:28p.m., Milwaukee Police along with an Inspector from the Health Department conducted a License Premise check at 432 E. Chambers. Officers observed expired food in a cooler with other food and mice droppings in the rear of the business. The employee stated the food in the cooler was not for sale and was only being stored there. The employee was advised by the Inspector, expired food cannot be stored with other food products and an order was issued to clean up the mice droppings.
- 3. On 11/28/22 at 11:15a.m., officers were flagged down by a citizen regarding an argument at 432 E. Chambers. On arrival officers were advised by the employee an armed robbery had just occurred. The employee stated suspect #1 produced a firearm and ordered the employee to the ground. Suspect #1 then took the employees cell phone and ordered the employee to open the register. Suspect #1 removed US Currency from the register and Suspect #2 took the whole register, fleeing from the store. The employee was cooperative with the investigation.

On Sunday, May 22, 2022, at approximately 4:58PM, I, PO GARLAND (Squad 5266) was dispatched to 432 E. Chambers St (Chambers Food Mart) to conduct a Business Check.

Prior to the Business Check, I, PO GARLAND received an email from Avila NORMA (Program Assistant for the Health Department) on the date of 05/20/2022, who provided me an inspection order for the business. The inspection order stated that Chambers Food Mart was to cease all food operations as of 05/18/2022 for the following violations:

#### 6-501.111 (B) - CONTROLLING PESTS - INSPECTING PREMISE

This is a core item.

Observation: Evidence of mouse droppings throughout the establishment:

- 1. Among chip bags including gnawed through bags and droppings within pretzel bag.
- 2. Among ramen noodle packages.

Upon arrival to Chambers Food Mart on today's date, I spoke to cashier, who identified himself as Rabeeh M. MUSAITIF (I/M, 05/07/1962). MUSAITIF stated, an inspector responded to the business on 05/21/2022, and cleared the business to resume all food operations. MUSAITIF stated, he was working during that time, but the owner of the business was not present. MUSAITIF identified the owner/agent of the business as Ayah R. MUSAITIF (I/M, 04/26/1996) whose DOT address listed out of state at 4912 Stratford Pine La, Dublin, OH 43016. MUSAITIF stated, the current licenses for the business were not displayed because the licenses were being mailed to the business.

This report was submitted by PO Keith Garland, assigned to District 5, Early Power Shift, CPU (Community Partnership Unit).

On Thursday, October 27, 2022, at approximately 12:28PM, PO Christopher SCHLEI (Squad 5264) and I, PO GARLAND (Squad 5266) were dispatched to 432 E. Chambers St (Chambers Food Mart) for an investigation regarding possible health code violations. Inspector Matt RZEPKOWSKI (Department of Neighborhood Services) also responded with us to inspect the business for building code violations.

Prior to this investigation, Officers Evan Mikulsky and Mark STASZESKI (Squad 5258) responded to the business on the date of 10/14/2022 to investigate a Battery complaint. During the investigation, PO MIKULSKY and PO STASZESKI observed that the business appeared to be unsanitary, and they observed a cooler inside of the business that contained food that appeared to be expired.

Upon arrival, on today's date, PO SCHLEI and I, PO GARLAND, observed a large cooler located near the front entrance of the business that contained an assortment of food products (Meat, pizzas, ice cream, milk, and much more). It appeared that the meat was brown colored and expired. PO SCHLEI and I observed that mice droppings were located in the rear area of the business.

I spoke to the on scene manager of the business, who was identified Rabeeh M. MUSAITIF (I/M, 05/07/1962). MUSAITIF stated, the food products that were located inside of the front cooler were not for sale, and he was just storing the food there. Inspector RZEPKOWSKI informed Rabeeh MUSAITIF it was a health code violation to store expired food inside of the business cooler with other food products. Inspector RZEPKOWSKI also informed Rabeeh MUSAITIF that he had to clean up the mice droppings that was located inside of the business. Inspector RZEPKOWSKI informed Rabeeh MUSAITIF that he was going to issues the business violation orders for the mice droppings, and he was going to report the expired food products to the health department.

This report was written by PO John SCHAEFER, assigned to District 5, day Shift.

On Monday, November 28th, 2022, Squad 5122, Po Damon WILCOX and I were flagged down by a City of Milwaukee Worker at N Booth St and W Hadley Street. This worker stated there was an argument at 432 E Chambers St and asked if we could check it out. We went to this location and MUSAITIF came out of the location and stated he was just robbed at gun point. MUSTAIF stated this was separate from the trouble with subject we were flagged down for.

MUSTAIFTIF stated an undescribed male came into the store and asked him how much the surcharge was for credit use. MUSTAITIF stated he told them it was 75 cents and that the suspect had a Silver gun in his right hand and told him to get on the ground before he shoots him. MUSAITIF then stated this subject went through his pockets and took an I-Phone 6 from his right front pocket. MUSAITIF then stated this suspect got him off the ground and told him to open the register at which time he went to the back with the suspect and opened the register. MUSAITIF stated the suspect 1 then grabbed \$300 to \$400 in cash from the register and suspect #2 took the whole register. They the fled the location west on E Chambers St then north in the alley. SANCHEZ stated he was back by the freezer when he heard someone ask about the surcharge and then someone say everyone get on the ground. SANCHEZ described the suspect as a light skinned male, wearing a Black knit cap, and Cream jacket, that then came by him and went through his pockets taking a Black Android cell phone from front right pocket, and Black Coach wallet from his rear pocket.

Michael A JAMES was inside the store but not a victim of the incident. He provided suspect descriptions.

The manager of the business, MUSAITIF, was cooperative and did show us the business licenses for Food # 0013148 valid from 5-24-22 until 5-23-23 and for Tobacco and Cigarettes #1031145 valid from 5-24-22 until 5-23-23.



The hearing before the Licenses Committee will take place on 4/25/2023 at 10:00 AM in Room 301-B, Third Floor, City Hall. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony via phone or internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

# Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
