This report is written by Police Officer Penny Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 06/11/22, the applicant was cited in the City of Milwaukee for Sale of Cigarettes to Minor.

Charge:Sale of Cigarettes to MinorFinding:GuiltySentence:FineDate:12/05/22Case:22050181

- 2. On 09/17/22 at 10:39pm, Milwaukee Police were dispatched to 2012 W. Capitol Drive for an entry complaint. Investigation revealed that a subject broke into the store using the two rear doors and breaking through a particleboard wall. The subject took merchandise and exited through an alarmed door.
- 3. On 10/08/22 at 9:35am, Milwaukee Police responded to a business burglary at 2012 W. Capitol Drive. Investigation revealed that a subject entered the store while it was closed (unknown how entry was gained), pried open drawers behind the main counter and took merchandise. The subject tried to open the safe with an employee card but was unable to access the safe. Employees of the business were cooperative with the investigation.

4. On 02/24/23 at 6:50p.m., officers were dispatched to 2012 W. Capitol Dr., for a Subject with Gun. Investigation revealed a suspect entered the store and attempted to leave with items without paying. The suspect was stopped by employees and threats were made. A second suspect entered the store and a verbal and physical altercation took place. Both suspects eventually left, however, smashed out the employee's rear windshield prior to fleeing. The employee was cooperative and allowed officers to view video surveillance.

This report is written by PO Daniel TIERNEY, assigned to District 5 Early Shift, Squad 5220.

On Friday, September 17, 2022, at 10:39 PM, PO Brian PFEIL and I were dispatched to an entry at the Family Dollar at 2012 W Capitol Dr.

Upon arrival we observed two rear doors that were open. One door towards the eastern end of the building, was pried open. On the other side of the door was a particleboard wall, which was the back of the shelving units inside of the store. The suspect broke through the particleboard and made entry into the store through the hole. The other door was the alarmed door that appeared to be where the suspect exited.

We did clear the business and found that nobody was left inside. We did observe that the glass cabinet that contains tobacco products was broken into. There was also a cash box that was broken into. Nothing else in the store appeared to be disturbed.

I did speak with the Closing Manager, Asianae JORDAN, who stated that an estimated \$40 dollars' worth of Black and Mild cigars were taken from behind the register. She stated the cash box was empty.

Sgt Joseph BEOHLKE responded and took photographs of the scene.

PO PFEIL did view the surveillance video. Please see his supplement regarding.

This report was written by P.O. Damon WILCOX, assigned to District 5 Day Shift.

On Saturday October 8, 2022, at 9:35AM, Squad 5122 (P.O. WALISZEWSKI and I) responded to a Business Burglary at the Family Dollar (2012 W Capitol Dr).

Upon arrival I did not observe any signs of forced entry to the location. I spoke with the store manager, identified as James L WARD (B/M, 7-10-1970), who stated that the only items missing (at the time of this notification) were approximately 15 cartons of cigarettes (valued at approximately \$1200).

I did observe damage to four drawers behind the font counter of the business. The doors appeared to have been pried open (one of these drawers did contain the missing cigarettes).

P.O. WALISZEWSKI was able to view some of the recovered video. This video did show a black male suspect behind the front counter of the business between the time of 3:49AM and 4:04AM. The subject is observed to pry open the four drawers and remove the cigarettes from one of these drawers. The suspect is also observed attempting to access the safe by using an employee card. The suspect was unable to open the safe and is believed to possibly be a former employee. The subject is observed to be wearing gloves during the incident.

At the time of this notification, we were unable to view more than the one camera and had not determined how entrance was gained. Store personal (familiar with the camera system) was contacted and will be responding to the location for video retrieval.

A check revealed that the store had been a victim of a burglary recently MPD case # 222600164. All employees of the business were cooperative in this investigation.

INITIAL INVESTIGATION

Price, Dominque 035701

This report is written by P.O. Dominique PRICE assigned to MPD District 5, Late Power, Squad 5426 with my partner PO WELCH, equipped with AXON body worn cameras, in full duty uniform and in a Milwaukee Police Department marked squad car.

On Friday February 24th, 2022, my partner PO WELCH and I were dispatched to a Subject with Gun call for service at the location of 2012 W Capitol Dr, which is in the City and County of Milwaukee.

Upon arrival officers spoke with the victim/caller Asianae D. JORDAN (B/F 07/06/1997) who stated that a customer came into the store and tried walking out with merchandise. When confronted at the exit, the customer started a verbal altercation, which involved another employee, later identified as Annesia L. JORDAN (b/f, 07-06-94) and another suspect which then turned physical and involved some property being damaged by the suspects. (I will be using first names for the remainder of this report due to the two victims having the same last name).

Interview of Asianae D JORDAN:

ASIANAE stated Suspect 1 walked into the listed business and grabbed 3 boxes of pampers from the shelves and attempted to walk out of the business. ASIANAE stated that S1 was then stopped at the front door where she confronted her about the pampers and a verbal confrontation ensued. ASIANAE stated she retrieved the pampers from S1 possession and walked them back into the business. ASIANAE stated that ANNESIA then entered the business and tried to help with the situation. ASIANAE stated after arguing with S1 for approximately 2 mins, S2 then entered the business and joined the verbal altercation stating that he would come back and "shoot up the place" if ASIANAE would not let S1 leave with the pampers. ASAINAE stated that S1 then re-entered the business and tried to walk down the aisle to steal more pampers where she was confronted by herself as well as ANNESIA. ASIANAE stated S2 then followed behind them and a physical altercation then occurred, and she was struck in the face multiple times. ASIANAE stated after the scuffle S1 and S2 then left the store, and S1 proceeded to break the rear windshield of ANNESIA vehicle. S1 and S2 then entered a silver unknown make and model vehicle and fled the scene in an unknown direction.

ANNESIA stated she was sitting in her vehicle outside of the business, on break at the time, and saw all of the commotion and decided she would try and help the situation.

Additional Info:

Upon arrival I (PO PRICE) observed the store to have items scrambled and ransacked all over the entrance.

Video surveillance showed S1 enter the business and go into an aisle. Approximately 3 minutes later S1 resurfaces and can be observed with 3 boxes of pampers where she was stopped at the entrance by ASIANAE, who retrieved the boxes from S1 and walked them back in the building. ASIANAE and S1 can be observed exchanging words before ANNESIA appear in the picture. After more words were exchanged, S2 can be observed approaching from the parking lot. After approximately 2-3 minutes of more words being exchanged, S1 walks back down the initial aisle where she was followed by ASIANAE, ANNESIA and S2. Approximately 2 minutes after that, all parties could be seen coming from the aisle in a huge scuffle knocking items all over the entrance. The scuffle lasted about 2 minutes until S1 grabbed S2 and exited the business. Both suspects can be spotted entering a silver (unknown make and model) vehicle, where S1 obtains an unknown item and gets out and smashes the back windshield of ANNESIAs vehicle. S1 then re-enters the vehicle and they flee the scene in an unknown direction.

S1 and S2 then entered a silver unknown make and model vehicle and fled the scene in an unknown direction.

SUSPECT 1 (Female, Black, approximately 5'08, Thin build, Medium Complexion, Long Hair, wearing Light Gray sweater with white t-shirt underneath, gray sweatpants and white and black shoes.)

Suspect 2 (Male, Black, 5'10, Medium complexion, thin build, Short hair, wearing a Black Sweater with white t-shirt underneath, black sweatpants and black shoes.)

PO WELCH took photos of the scene and the victim's vehicle with the shattered rear windshield.

Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.

2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)

3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).

4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.

5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

6. You may then provide testimony.

a. Include only information relating to the above license application.

b. Include only information you have personally witnessed or seen.

c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.

d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.

7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.

8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
