10. On 05/15/19 at 1:20am, Milwaukee Police were dispatched to 4295 N. Teutonia Avenue for a shot spotter complaint. Investigation revealed that a shooting took place in the parking lot of the establishment. Two vehicles pulled into the lot and a female suspect entered the victims vehicle which was parked at the gas pumps. Another suspect approached in his vehicle and shot the victim inside his vehicle and drove away. The female suspect, after a struggle with the victim inside his car, exited and began walking away. The victim then backed his vehicle up, striking the female suspect and dragging her into the street. The victim then left and the female suspect, got up and entered the male suspects' vehicle (who had returned to the scene) and the left the scene.

11. On 03/07/21 at 3:24pm, Milwaukee Police were dispatched to 4295 N. Teutonia for an Armed Robbery. Investigation revealed the victim was exiting the business when they were approached by a subject demanding money. When the victim refused, the suspect then brandished a firearm. The victim ran back into the business and the employee locked the door. The employee was cooperative and provided police with video surveillance of the incident.

- 12. On 03/24/21 at 10:53pm, Milwaukee Police conducted a License Premise Check at 4295 N. Teutonia Av. No violations were observed and employees were cooperative.
- 13. On 08/26/21 at 8:19pm, Milwaukee Police were dispatched to 4295 N. Teutonia Av., for a Battery. Investigation revealed the agent, along with a few other employees, began to a assault another employee in the cashier area of the store. The agent and the other employees eventually dragged the employee to the rear of the store and continued the assault, so it would not be on video surveillance. The agent stated this was due to suspicions the employee was stealing from him. Video surveillance officers observed depicted the assault until the camera in the cashier area was turned off and the victim was dragged to the rear of the store. The agent was uncooperative with officers when they tried to retrieve the other employees' names to issue citations. The agent was issued a citation for Assault and Battery.

Charge: Assault and Battery Finding: Dismissed without Prejudice Sentence: Date: Case: 21052788 14. On 09/28/21 Milwaukee Police were dispatched to 4295 N. Teutonia Av., for a Shots Fired, which was later upgraded to a shooting. Video surveillance revealed 4 subjects inside of the business struggling over a firearm, when the victim was shot. The victim was uncooperative with police.

Item #13 updated with disposition

- 15. On 10/01/22 at 5:06p.m., officers were dispatched to a Battery at 4295 N. Teutonia Av. The caller stated they purchased items and prepaid for gas inside the store, however, when they tried to pump gas, the pump would not work. The caller stated they again entered the store, and were asked to leave by the clerk due to disorderly actions. The customer stated they refused and the clerk attempted to escort the customer out and that is when the 911 call was placed. The employee stated they did not see that the transaction went through on their end, however, agreed to the customers' demands
- 16. On 10/09/22 at 11;13p.m., officers were dispatched to 4295 N. Teutonia Av., for a Shoplifter. Investigation revealed a subject walked in and took several items and exited without paying. The employee stated this subject does this often and is still trying to identify the subject.
- 17. On 10/10/22 at 9:07p.m., officers were dispatched to a Shoplifter at 4295 N. Teutonia Av. Investigation revealed a suspect attempted to shoplift items, however, when the employee intervened the suspect attempted to damage items. The suspect was conveyed to a homeless shelter and later issued a citation for Disorderly Conduct.
- 18. On 10/26/22 at 5:21p.m., officers were dispatched to 4295 N. Teutonia Av., for a Battery. Investigation revealed a verbal argument between an employee and the suspect began inside the store, then turned physical outside, at which time the employee began suffering from a seizure. The employees were cooperative and allowed officers to view video surveillance of the incident.
- 19. On 11/11/22 at 10:42a.m., officers were dispatched to 4295 N. Teutonia Av., for Shots Fired. Investigation revealed a suspect, armed with a sub-compact Black Rifle, was seen pointing it toward the sky and firing the weapon appearing to test fire in the parking lot. Video surveillance depicted the employees on scene allowing the armed suspect to enter, loiter and exit, multiple times without locking the doors. The employees do not lock the bullet proof glass and continued to wait on other customers while the armed suspect was in the store. While officers were interviewing the employee regarding the incident, the officer observed the subject walking toward the entrance and the employee positively identified the suspect. The suspect was no longer armed, however, was taken into custody.
- 20. On 01/07/23 at 8:09p.m., officers were dispatched to an Armed Robbery at 4295 N. Teutonia. Investigation revealed the victim was pumping gas when they were approached by a subject from behind. The suspect pressed an object into the victim's back and demanded money. The victim complied and as the suspect was running away, the victim saw the suspect with a handgun in their hand. The employees were cooperative and allowed officers to view video surveillance of the incident.

21. On 03/23/23 at 5:07p.m., officers were flagged down by a citizen for a Battery in progress at 4295 N. Teutonia. Investigation revealed a customer was upset over the pump being cancelled. The clerk advised the suspect they have no control over this and it could have been due to an incorrect pin number. The suspect became irate and began to knock over shelves and throw things around inside the store. When the employee tried to follow the suspects to take pictures of the license plates, the suspect got out of the vehicle and punched the employee in the face multiple times in the head and face.

This report is being written by PO Constantine SPENCE, assigned to District five, Early shift.

On Saturday, October 1, 2022, I along with my partner PO Daniel PIASECKI, were assigned to Squad 5230 and dressed in Milwaukee Police Department uniform. PO PIASECKI and I were equipped with axon body

cameras during this investigation.

At 5:06 pm, we were dispatched to a battery complaint at 4295 N Teutonia Ave, in the City and County of Milwaukee, Wisconsin. Upon arrival we spoke to the caller/victim of this incident **CARTER**, Ajae A (B/F 10 -08-2003).

Initial Observation

The Clark Gas Station located at 4295 N. Teutonia Ave. is a brick single story building with a flat blue roof. The entrance is located on the east side of the building. Inside the store there are multiple rows and racks that contain typical gas station store items. The rows are perpendicular to the front entrance. The register and clerk are located on the northern side of the building and are enclosed behind bullet resistant glass.

CAD 22-274-1113: CARTER'S original call to the telecommunication division stated the gas station owner is pushing her to get out of his store. CARTER states she will take matters into her own hands if police don't come.

Interview with CARTER

CARTER stated to officers that she purchased snacks and gas from her debit card but wasn't able to pump gas into her vehicle when she went outside. CARTER stated her money is viewed as being withdrawn from her bank account. CARTER stated the clerk told her to leave the store because she was getting too loud and preventing customers from placing their orders.

CARTER stated the clerk attempted to escort her outside the store. CARTER stated she refused and called 911. CARTER stated the actions conducted by the clerk did not cause her pain and injury and it also did not make her fear for her safety. CARTER stated she just wants the gas she paid for, and she will leave and never shop at this gas station again. CARTER became uncooperative and stated she does not want to prosecute.

The cashier stated he does not see the purchase on his side of the scene. The cashier agreed to CARTER's demands even though the sale did not fully go through.

This report is being written by P.O. Kaonnie WHITLEY, assigned to District Five, Early Shift, Squad 5291. On Sunday October 9th, 2022, at approximately 11:13 P.M. my partner P.O. Brian HOLMES and I, were dispatched to 4295 N Teutonia Ave, which is located in the city and county of Milwaukee, for a shoplifter complaint.

Upon arrival I was met by reporting person identified as **Krishan SINGH (W/M 01/14/1972)**. SINGH stated that an unknown suspect described as a (B/F 509/150LBS), last seen wearing a black jacket with black pants. SINGH noted that the suspect is missing her right eye.

INTERVIEW OF REPORTING PERSON: SINGH

SINGH stated that the establishment has constant issues with the above listed suspect, but that they have yet to identify her real name.

SINGH stated that there have been multiple occasions where the suspect has walked in and stolen several items and then ran out. SINGH stated on today's date at approximately 9:08 P.M. that the suspect entered into the establishment and began to take items.

SINGH stated that he did not have an exact account of everything missing at the time of my investigation but that it was approximately \$50.00 in USD of items that were taken by the suspect.

SINGH stated that he wanted the incident documented for future incidents due to the suspect committing multiple thefts at his establishment.

FOLLOW UP:

I provided SINGH with a PV-17 and community contact card regarding this incident containing his case information and my contact information should he have any questions in the future regarding this incident.

An attempt was made to locate the described suspect listed above. It is known that the suspect left the residence on foot and frequents that area of North 27th Street and West Atkinson Street. I was unable to locate the suspect at the time of my investigation.

I instructed SINGH that when he was able to conduct and inventory of all the items that were taken to contact via the district phone number or by email so that it could be added to the report.

This case is pended following further suspect identification.

License were currently up to date and employees were helpful while on scene. Camera systems were active and operable at the time of my investigation.

This report was written by PO Nora BURLO, assigned to District Five, Late Power shift. On October 10th, 2022, I was assigned to Squad 5468 along with my partner PO James TERRELL.

On the listed date, PO TERRELL and I were dispatched to a Shoplifter complaint at the address 4295 N Teutonia Av, which is a licensed premise in the City of Milwaukee. The listed location is a gas station-Teutonia Gas & Food.

Upon arrival at the listed address, PO TERRELL and I observed a female subject, later identified as *Sandra N LEE (04/16/1975)* inside of the gas station. I observed her to be disheveled and talking at a fast pace. I was not able to understand what she was saying as she was not speaking clearly. I observed her to be agitated and worked up. PO TERRELL and I calmed LEE down and escorted her outside of the location and placed her in the rear of our squad vehicle. She was not handcuffed.

PO TERRELL then met with the clerk, identified as *Krishan SINGH (w/m, 1/14/1972)*. SINGH stated LEE had been causing a disturbance at the location. He stated LEE attempted to steal multiple items from inside the store. SINGH stated she did not steal anything due to him taking the items away from LEE. SINGH then stated LEE attempted to damage items in the store. SINGH stated he wanted LEE away from the store and wanted restraining order information in order to prevent her from coming back.

I provided SINGH with restraining order information at that time.

LEE asked officers if we were able to convey her to 1400 W Vilet St, due to her being homeless, she was requesting to go to a homeless shelter in the area. I informed her that I would be issuing her a citation for disorderly conduct.

I then attempted to issue her a citation, but our computer was malfunctioning at the time. I attempted three times to issue the citation. I then informed LEE that I would send her a citation in the mail.

PO TERRELL and I then conveyed LEE to 1400 W Vilet.

I later attempted to issue LEE a citation, however I was unable to locate an address for her due to her homeless status.

SECURITY VIDEO REVIEW:

On 11/11/2022 at approximately 10:42AM, I Officer BUKOVSKY arrived and began assisting fellow MPD officers while investigating a shots fired call at 4295 N. Teutonia Av, which occurred in the City and County of Milwaukee. After obtaining a description from gas station employee witness's, the suspect was stated to be a black male, wearing a green top, and green pants. Officer MERRILL, Officer GRAMS, Officer ZIARNIK, and I located three spent brass shell casings on the outside of the gas station (Inventory #22041501). Shortly after locating the casings, Officer MERRILL, Officer GRAMS and I began reviewing security camera video from the back office of the business behind the cash register counter.

On the gas station security cameras, during the time frames between 10:16AM and 10:30AM (11/11/2022), a black male with short black curly hair, black square/rectangular framed glasses, wearing a green shirt, light green sweatpants, walked onto the 4295 N. Teutonia Ave gas station from the south off of N. Teutonia Ave, at approximately 10:16AM. The suspect was holding a sub-compact, black rifle with a double-drum magazines. As the suspect walked towards the gas station door, he appeared to be test firing the weapon, towards the sky. The weapon appeared to have multiple malfunctions and the suspect attempted to fix the malfunctions. He then entered the gas station with the weapon in-hand. The inside gas station cameras showed a clearer visual of the suspects face and clothing; long-sleeve OD green fleece, light green sweatpants with a US Army logo on the thigh of the pants. The suspect continued trying to fix his weapon inside and outside the gas station and appeared to fire the weapon twice. He was observed leaving the property at approximately 10:30AM.

ARREST:

At approximately 11:20AM while assisting with the investigation, MPD Sergeant LEWAN and I were behind the cashier counter speaking with the clerk, Samarth SINGH (12/12/1990) who witnessed the suspects actions. At this time, I visually identified the same subject from the security video who fired the weapon on the property. The subject was observed outside the glass store window, walking towards the front door from the north of the building. At this time, I pointed out the subject to the clerk (SINGH), who verbally confirmed and identified that was the suspect, who fired the weapon approximately one hour prior at this gas station. The suspect who was identified as Terrance L. BANKHEAD (05/13/2003), entered the gas station front door and stood near the entrance, with no visible weapon. The subject was observed holding cash currency in his hands, attempting to make a purchase. Sergeant LEWAN and I approached the suspect and took him into custody.

BANKHEAD was searched incident to arrest; total of \$275.00 (US cash currency), and one plastic baggie containing a green leafy plant like material in his left pants pocket. BANKHEAD was placed in SQD 5123 vehicle (Officers GRAMS and ZIARNIK). BANKHEAD voluntarily gave me his information and was later transported to District 5 by SQD 5123.

Employees present can be seen on camera allowing the armed subject to loiter inside the store. Suspect exits multiple times and the employees do not lock down the business and secure behind the bullet proof windows. Instead, they leave the door unlocked and continue to check-out customers while the suspect is outside armed.

There were 3 callers for this incident, one anonymous caller (no name or phone number) and two additional callers, neither matching the name of the gas station clerk.

This report was submitted by P.O. Tyler SEELOW assigned to District 5 late power shift. The following details were gathered from a report written by P.O. Brandon BUKOVSKY:

On 01/07/2023 at approximately 20:09hrs, my partner PO Tyler SEELOW and I (Squad 5426) were dispatched to an Armed Robbery that occurred at 4295 N. Teutonia Ave (Clark Gas Station). This address is located in the City and County of Milwaukee. We arrived to the listed address at approximately 20:15hrs in uniform and in a marked squad car (#514).

CAD INFORMATION #230071428:

At 20:09hrs caller reported armed robbery. Updated CAD information, caller stated subject robbed him from behind and took his money. Caller stated that he saw a gun when subject was running away, no injury, no description of subject. Stated subject was last seen running northbound on N. Teutonia Ave.

INVESTIGATION:

We arrived at approximately 20:15hrs to the listed address. We immediately made contact with the victim, later identified as Sanjaykumar M. PATEL (W/M 06/01/1980) by his Illinois Drivers License. PATEL gave me a summary of the incident and a description of the subject. Additional arriving Officers were given the description and last known direction of travel which was eastbound on W. Roosevelt Dr. according to the victim. P.O. ARNOLD / SANDOVAL (Squad 5428), P.O. SILKEY / XIONG (Squad 5434), and P.O. CARSON / MACRAE (Squad 5448) saturated the area for the subject with the given description and updated direction of travel.

SUBJECT DISCRIPTION:

Black male, approximately 5'5", medium build, black hooded sweatshirt with the hood up, black face mask, and black mask.

VICTIM INTERVIEW:

PATEL stated he had arrived to the 4295 N. Teutonia Ave Clark Gas Station and pulled up to pump #1 (most northern gas pump on the property), according to security cameras #5 he arrived at 2005hrs (accurate time). PATEL was driving a 2017 maroon Chrysler Pacifica mini-van. PATEL stated while he was pumping gas and was rushed by an unknown male subject who repeatedly stated "give that money". PATEL stated he felt what he believed to be a handgun pressing into his back on his left side during the

PATEL stated the subject without consent, went into PATEL's pockets by force and took approximately \$300.00 to \$400.00 in US currency along with unknown miscellaneous store receipts that have the victim's name on them. PATEL stated the subject took the items, turned around and began running eastbound. When the subject began to run away, PATEL stated he visibly saw a handgun in the subject's right hand being put into the subjects front right-side outer garments pocket. Subject continued running eastbound on W. Roosevelt Drive and did not see him enter a vehicle. PATEL and the passenger proceeded into the Gas Station where he called 911 from.

WITNESS INTERVIEW:

During the incident the passenger in the vehicle had witnessed some of the incident; Amit Rameshbhai PATEL (W/M 10/26/1988) stated he was sitting in the front passenger seat when he saw his brother struggling with an unknown male subject outside of the vehicle. Amit PATEL stated the subject was a black male and did not have any additional descriptions and did not see a firearm.

DISTRICT 5 CASE TO HANDLE:

At 21:17hrs, I was advised by acting Lieutenant, Sgt. Wilder that the Criminal Investigation Bureau would not be responding and the case was ours to investigate.

SECURITY CAMERA FOOTAGE:

P.O. SEELOW and I viewed security camera footage from inside the Clark gas station, Camera #5 located on the southeast corner of the building. The camera shows PATEL pumping gas at approximately 20:05hrs, at 20:07hrs he turned around to speak with the passenger in his vehicle. At 20:07hrs the unknown male subject can be seen approaching from the northeast corner of W. Roosevelt Drive walking to the northeast corner of the Clark gas station and came behind the subjects maroon Chrysler van. He appeared to rush the victim and immediately went into the victims' pockets, a slight struggle ensued but the victim put his hands up in the air. The altercation lasted only a few seconds and the subject ran on foot eastbound on W. Roosevelt Drive. No firearm could be seen in the camera footage.

FORENSIC INVESTIGATOR (F.I.):

P.O. / F.I. CERVERA (Squad 1828) arrived at approximately 21:46hrs and downloaded the above mentioned security camera #5 footage. See P.O. CERVERA's F.I. report for details.

It should be noted that the establishment listed above was clean and the camera systems were in working order. It should also be noted that the employee was cooperative with the investigation and gave us access to the camera system and answered what questions we had about the incident above.

On Thursday, March 23, 2023 at approximately 5:07 PM, PO Brian HOLMES and I were flagged down by a concerned citizen while we were finishing up a Traffic Stop. The citizen stated that there was a Battery in progress at 4295 N. Teutonia Ave. (Clark Gas Station), which is located in the City and County of Milwaukee.

SCENE DESCRIPTION:

The Clark Gas Station located at 4295 N. Teutonia Ave. is a brick single story building with a flat blue roof. The entrance is located on the east side of the building. Inside the store there are multiple rows and racks that contain typical gas station store items. The rows are perpendicular to the front entrance. The register and clerk are located on the northern side of the building and are enclosed behind bullet resistant glass.

INTERVIEW WITH THE VICTIM:

Upon arrival, PO HOLMES and I secured the scene, asking if the suspect was still at the location. We were informed that the subject fled northbound on N. Teutonia Ave., moments before we arrived on scene. I spoke with the victim, later identified as Samardh SINGH (M/A 12/19/1980). I observed an unidentified female providing first aid to SINGH. The female stated that she was not present for Battery but she was friends with SINGH. SINGH stated that 2 unidentified females walked into the convenient store inquiring why their money was canceled at the gas pump. The females walked out of the store and appeared to be with an Unknown subject. SINGH stated the Unknown subject aggressively entered the store and started yelling at him demanding him to accept his payment. SINGH stated he tried to explain that he has no control over the system and that the Unknown subject must have entered his PIN incorrectly. SINGH stated the Unknown subject then started throwing the store display racks, that are stock with various food items, all over the store. SINGH stated the Unknown subject, exited the store. SINGH stated that he followed the Unknown subject at a distance and took a photograph of him in a vehicle. The picture of the vehicle appears to be a black Chevrolet Malibu or Impala with no registration on display in the front. SINGH stated that Unknown subject ran from the vehicle and started punching him with a closed fist all over his head and face. SINGH stated that these actions caused him pain. I observed a small laceration to the back of SINGH's head under his hair. I observed swelling and bruising to SINGH's left eye and a small amount of blood coming from his upper lip. SINGH stated that he believes Unknown subject has
