ITEMS DAMAGED: 2 City street trees were cut down: City Site ID# 101426 – 17" Green Ash City Site ID# 101429 – 12" Green Ash In the process of removing private trees at 10211 W Sharon Lane the 2 City street trees between the sidewalk and curb were topped out and the trunks remain standing. Google Maps shows no private Ash on the property. Ash limbs are shown in photos from a post on Facebook Marketplace for free hardwood posted by the tree service that did the work.	
REMARKS: On the morning of 1/20/23 Forestry received 2 complaints (Service Work Order # 4911884 and #4911878) that the City street trees between the sidewalk and curb were being removed. Forestry Manager Eric Wolf arrived at the site and took photos of the trees that were being removed and cut up. The damaged city property will be removed and the trees replaced by the DPW Forestry Division. The cost of removing the trunks, stumps, value of the trees, and the replacement cost of the trees will be billed to the property owner. Value of the 2 trees is \$2900.00. Value is based on \$100.00 per diameter inch of the trunk at 4.5 feet above ground.
