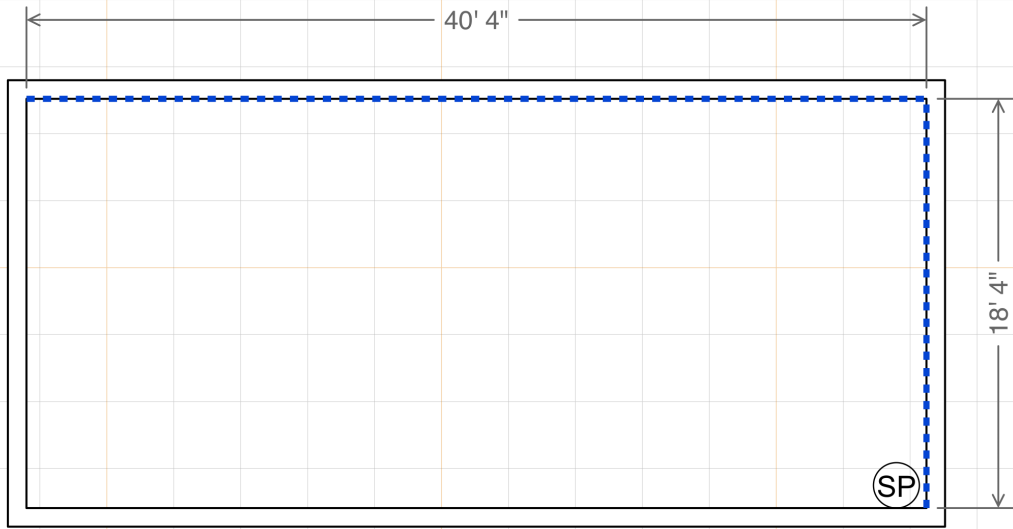

<b>Drain Tile System Installation</b> Remove Floor along wall area (12"-18" wide) where indicated; Remove existing drain tile and create down pitch towards sump pump; Drill 1" weep holes in the bottom of the first course; Drill holes in fourth block every 4 feet; flush all weep holes until completely clean, clean and flush bleeders. When flushing observe water flow into sump pump, Clean trench if necessary; Install 4" perforated drain tile; fill new drain tile with 3/4 chip stone; Install drainage board against first course; Re-cement floor.		<b>\$3,519.60</b>

Contractor guarantees labor for a period of 20 years .

Warranty for waterproofing only covers water leakage in the floor and walls. Does not cover any dampness.

Warranty does not cover water entering from windows, chimney, sewer or any water from above the foundation walls.

Renew Basement is not responsible for any damage to siding, gutters/guards, fascia, soffit, downspouts nor landscaping.

Warranty for sump pumps are only through the manufacturer.

Warranty only applies if gutters and downspouts are maintained in good working condition by the owner after the work has been completed.

For client protection, during contract performance, the client shall not be permitted in the working area without the company of the contractor, emergencies exempted.

Services are strictly in the work area and do not cover any leakage or flow in non-working areas.

Client is responsible for removing personal property from the working area prior to commencing work. The Contractor is not responsible for damages of personal property not removed or properly protected.

Renew Basement Foundation LLC is not responsible for any damages to landscaping (lawn, flowers, shrubs, or trees) unless restricted by the contract.

Any changes to the original scope of project will require a written change order prior to commencing the work.

This contract may be cancelled via written notification with a 15 days' notice. Client shall be responsible for all expenses incurred prior to cancellation.

Neither the Contractor nor the Client shall be considered in breach of this Contract to the extent that performance of their respective obligations (excluding payment obligations) is prevented by an Event of Force Majeure that arises after the Effective Date.

Any disagreements arising from the performance of this contract shall be resolved by a third neutral mutually agreed by all parties to the contract.

This contract shall be governed by Wisconsin Statutes.

A waiver of construction lien will be provided after the final payment.
