On Wednesday May 4th, 2022 at 12:54pm PO Monreal and I conducted a license premise check at 4780 N. 76th St. During the premise check I was equipped with an axon body worn camera, for the interaction in its entirety review camera footage.

Upon entering the business, I located 3 video gambling machines operating in the location. I looked for the licenses of the business and could not locate them . I spoke with the employee, Manpreet Singh (m/u 12-15-00) and inquired about the location of the posted license for the business. Mr. Singh directed me to the inside of the cashier area and handed me a white binder containing the licenses of the business. I Looked through the binder and did not locate a Public Entertainment Premises License, regarding the video gambling machines. I told the employee, Mr. Singh that the current valid licenses of the business should be visible and displayed and not in a binder. The licenses I observed were: *Food Dealer Retail*, *Cigarette and Tobacco*, *Filling Station*, *Weights & Measures valid expire 05/17/23*. I asked Mr. Singh if he was the agent and he stated that he is not and put be in contact with the agent.

I spoke with Surjit Singh, over the telephone, regarding two violations I observed. First, I explained to Mr. S. Singh of the recent Wisconsin State Court Appeals ruling and that the video gaming machines have been determined to be gambling machines, therefore not allowed to be used on the business premise. Prior to the ruling the business was required to have an entertainment license be granted from the city to have them operating. Second, the licenses are to be visibly displayed for inspections.

I informed Mr. S. Singh that officers conducted a prior inspection (05-05-21 MPD Case # 21250078) and the the same violations were discovered. Mr. S. Singh was informed he would be cited regarding, license required, and licenses to be displayed.

Mr. S. Singh was cooperative and stated that he will have his employee unplug the machines and have them returned to the business that he leases them from. Mr. S. Singh also stated that he would have the licenses posted in the future.

Upon returning to the office I verified through MPD computers that the business never was granted or applied for an Public Entertainment Premises License.

6. You may then provide testimony.
