There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. It is the intention of the Common Council to suspend or non-renew the licenses if objectors provide testimony related to the factors enumerated in MCO 85-4-4 that the Common Council finds to be true by a preponderance of the evidence and/or police reports are found to be true by a preponderance of the evidence. The police reports and other attached documents relating to objections to the license are a part of this notice and expressly incorporated in this notice. The licensee should be prepared to address these matters at the hearing.

Notice for applicants with warrants or unpaid fines:

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing. You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing. You may examine the application file at this office during regular business hours prior to the hearing date. Alderwoman Dimitrijevic,

I hope you are well. My name is ... of ... I am contacting you with concerns regarding the Back Draught bar located at 3631 S. Clement Avenue.

My husband, , and I purchased our home in . Since then, we have experienced several issues with Back Draught and have made multiple reports to the police regarding the activities happening in and around the establishment.

Almost daily, drug deals occur in front of our home by the bar's regulars. On one occasion, an extremely intoxicated bar patron stubbled out of the bar, pulled his pants down and urinated in the middle of the street in front of our home in broad daylight. He proceeded to get in his car and drive away, completely intoxicated. A police call was made regarding this incident. Please note, the bar is located directly across from Clement Ave School. Children are everywhere in the area and are usually playing in the playground while these incidents and drug deals occur. On another occasion, bar patrons filed out of the bar and proceeded to fight each other in the middle of the street, holding up traffic and waking up the entire neighborhood in the early hours of the morning. There was also a call made to the police regarding this. These are just a couple of the many incidents that have happened since we moved to the area.

My husband and I love our neighborhood and take a lot of pride in our home. We also love a good neighborhood bar, however, we choose to avoid Back Draught at all costs due to the reasons listed above. We choose to frequent other establishments in the area such as, Creed's Foggy Dew and Bad Moon Saloon.

We have spoken with the bar owner but the incidents still continue to occur regularly. Just yesterday, my husband witnessed a drug deal outside of our home. We understand that Backdraught's Class B Tavern License Renewal is pending and I would like our concerns to be taken into consideration in the city's decision to renew their license.

If something is not done, it will only get worse. Contacting the police whenever an incident occurs is a major drain on our city's already limited resources. Furthermore, my husband and I are expecting our first child and are deeply concerned with the activities happening in and around this bar and our home. Will there be a public hearing for their license renewal? Or, will there be a chance for citizen comments regarding their license renewal? Any assistance with this would be greatly appreciated.

This report is written by Police Officer Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 06/02/07 at 1:37 am, Milwaukee police were dispatched to 3631 S Clement for a Battery complaint. Officers spoke to the victim who stated a fight broke out between him and his cousin with his cousin punching him in the eye and hitting him with a glass bottle. The victim sustained two lacerations under both eyes requiring stitches. Officers spoke to the bartender identified as Jody Young, who stated a fight took place inside the bar and patrons then began throwing bottles and glasses with all patrons being ordered out of the tavern. Officers also made phone contact with the licensee, Terry Lucas.
- 2. On 08/27/07 at 3:53 am, Milwaukee police were dispatched to 3631 S Clement for a Battery complaint. Milwaukee police were met by a St Francis police officer who was with a victim who was bleeding heavily from the face area. Investigation revealed there were patrons in the tavern after hours when a known patron struck the another with a pint glass and with closed fists that caused several lacerations to the victim's face requiring 18 stitches. Officers spoke to the bartender, Jessica Vandevort, who stated she was restocking the back bar when when she returned to the front bar observed the victim bleeding. There was broken glass and blood all over the bar and floor. Officers contacted the licensee, Terry Lucas, who first stated that one of the patrons was an employee but further investigation revealed the patron was not but that he helped out from time to time. Officers also observed that no Class B license was posted. The same suspect involved in this battery was also involved in incident # 1. The licensee, Lucas, was cited for Display of License and Class B Tavern Patrons After Hours. The city attorney amended the charge of Patrons After Hours to Special Hours For Liquor Sale in Original Package.

The patrons exited the tavern and a fight took place outside the bar between the two. Police spoke to the bartender Alexis Priest regarding this incident and all parties were issued warnings.

6. On 03/11/12 at 11:23 pm, Milwaukee police responded to a Trouble With Subject complaint at 3631 S Clement Avenue. An anonymous male caller stated that there were two underage subjects drinking in the bar named Alexandria and Stephanie. Police entered the bar and observed two younger females sitting next to one another at the bar. Investigation revealed that the patrons were indeed under the age of 21 and were cited. Police spoke with the bartender Ehricka Larson who stated she did not check the ID's of the patrons because they both have been served numerous times in the tavern before and she thought they were of age.

Larson also provided officers with a different date of birth as well as the spelling of her first name and she was cited for obstructing police and sale to underage. Officers contacted the licensee Terry Lucas and informed him that he would be cited for having minors in the bar. Lucas stated he was unaware that there were minors in the bar.

7. On 07/19/12 at 1:33 am, Milwaukee police were dispatched to a Fight complaint at 3631 S Clement Avenue. Investigation revealed an altercation took place inside the bar when a patron was asked to leave due to his behavior. Two patrons tried to get the subject to leave and when they got him to the door, someone pushed him and he fell down the front three steps as well as one of the patrons. The subject got up and began to physically fight with the patrons before fleeing. The licensee, Terry Lucas, was on scene provided officers' with surveillance tape of the incident.

8. On 02/24/2014 Milwaukee police conducted a licensed premise check at 3631 South Clement Avenue (Back Draught). The bartender on duty, who initially gave officers the name of Christina M. Elliot, did not have a Class D Operator's license with her. As an officer exited the business to determine if "Elliott" possessed a valid Class D license, he was pursued by "Elliott" who admitted that she had lied about her name. She then gave the officer the name of Ehrika S. Larson and told the officer she had lied because she does not possess a valid Class D license. The applicant told officers he was not aware that Larson did not have a valid bartenders license, and volunteered to close the business. Both Larson and the applicant were cited.

9. On 05/01/2014 at 10:00pm officers conducted a tavern check at 3631 S Clement Av, Backdraught. The bartender was Christina ELLIOT. She did not have a Class D license on her person but produced a receipt for it. A check with LIU revealed ELLIOT had not picked up her license until 05/02/2014. The applicant and ELLIOT were issued citations for Class D license required.

10. On 01/23/2015 at 8:37pm officers were dispatched to 3631 S Clement Av, Back Draught, for a fight. The bartender, Ehrika LARSON had called because of a fight between two patrons. One of the patrons was still on scene and denied fighting. The patron was cited for Disorderly Conduct because LARSON stated she had feared for her safety. There are cameras inside but LARSON did not know how to operate them. The applicant was called regarding this incident and a message was left inquiring about the camera system. As of 01/30/2015 the applicant had not responded back.

11.On 04/15/2015 a 20 year old Milwaukee police aide, working in conjunction with Milwaukee police, was able to enter Back Draught (3631 South Clement Avenue) and purchase two Miller High Life brand beers from the bartender.

12. On 01/03/2016 Milwaukee police conducted a licensed premise check at 3631 South Clement Avenue (Backdraught). All the establishments' licenses were current and properly posted. The bartender, Angel Jones, stated she had a current class D operator's license which she did not have on her person. Officers confirmed that Jones has a current class D operator's license and a verbal warning was given regarding the need for her to have it when she serves alcohol.

13. On 01/21/2016 Milwaukee police responded to an armed robbery complaint at 3631 South Clement Avenue (Back Draught Bar). Investigation revealed a subject entered the business and displayed a black semi-automatic handgun, demanding money. Both the business and its patrons were robbed. Milwaukee police incident report # 160210161 filed.

14. On 10/02/2018 at 9:28pm an officer conducted a licensed premise check at Backdraught, 3631 S Clement Av. The bartender was identified as Melanie BAUMAN. BAUMAN was the only employee working and she did not have a Class D Operator's license. The previous bartender was now a customer at the bar but stated she was not working. The applicant stated he thought it was okay for a licensed bartender to be in the tavern even if they were not working. The applicant was advised there must be a licensed bartender working, not just on the premise. The applicant was cited for Responsible Person on Premise Required.

15. On 03/17/2019 officers were dispatched to a Battery call at Backdraught, 3631 S Clement Av. The officers observed a subject in the parking lot that matched the description of the actor given over the radio. They stopped the subject who stated she was in the bar when things went badly and she got into a fight with the bartender. The officer spoke with the bartender, who stated the patron was intoxicated and got upset when she was cut off because she was causing a disturbance. The customer then began hitting the bartender. The bar has cameras but the bartender could not access them. The patron was arrested for battery and conveyed to the district station.

16. On 11/08/20 at 6:00pm, Milwaukee Police were dispatched to 3631 S. Clement Avenue for a fight complaint. The actors in the fight were gone before police arrival and all the establishments licenses' were in compliance.

- 17. On 02/11/21 at 11:10pm, Milwaukee Police were dispatched to 3631 S. Clement Avenue for a threat complaint. Investigation revealed that one of the patrons threated the DJ and the DJ wanted police on scene while he packed his equipment. All licenses' were up to date.
- 18. On 03/03/21 at 9:56pm, Milwaukee Police conducted a license premise check at 3631 S. Clement Avenue. No violations were found.
- 19. On 04/08/21 at 11:44pm, Milwaukee Police were dispatched to 3631 S. Clement Avenue for a battery complaint. Investigation revealed that no battery or child abuse took place at the location and the establishment held the proper licenses'.

20. On 07/31/21 at 1:28a.m., Milwaukee Police were dispatched to a Fight at 3631 S. Clement Av. Investigation revealed an altercation that occurred earlier and the employee kicked everyone out and closed the business. The business was closed on officers arrival and no patrons were observed inside or outside the bar.

21. On 10/11/21 at 11:21pm, Milwaukee Police were dispatched to a Subject with Gun at 3631 S. Clement Av. An arrest was made of a patron for a traffic violation, who in turn stated he obtained cocaine from the bartender prior to police being called. The employee/caller was cooperative with the investigation and stated he did not wish to press charges for what occurred in the bar.

- 22. On 01/13/22 Milwaukee Police conducted a License Premise Check at 3631 S. Clement Av. It was determined the bartender on duty had an expired Operator License, which he stated he was not aware of. The employee willingly closed the bar immediately and stated he would renew his license prior to continuing to tend bar. No other violations were observed and the employee was cooperative.
- 23. On 08/10/22 at 11:03a.m., officers were dispatched to a Burglary at 3641 S. Clement Av. Investigation revealed an unknown suspect had gained entry to the locked establishment via the front entrance door and damaged a gaming machine which contained US Currency. The agent was cooperative and attempted to allow officers to view video surveillance, however, was unsuccessful.

MARSHALL and (I) was dispatched to 3641 S. Clement Ave (Back Draught Tavern), located in City and County of Milwaukee, State of Wisconsin, regarding a burglary complaint.

At this time P.O. MARSHALL and I were dressed in our full police uniform(s) with our last name (s) affixed to our outer most garment(s), which also included our department issued Axon digital body camera(s) which captured the investigation. P.O. MARSHALL was driving marked police patrol car #574, which is also equipped with the Axon digital recording system.

Interview - Terry D. LUCAS

On scene, I spoke to the caller identified by his Wisconsin Driver's license as Terry D. LUCAS (w/m 08-31-62), 3641 S. Clement Ave., Milwaukee, WI 53207 (414) 727-1599. LUCAS identified himself as the proprietor to Back Drought Tavern. LUCAS stated the business was secured today August 10, 2022 at approximately 2:30 am. LUCAS stated he received a notification to his cell phone at approximately 6:30 am (same day) that motion occurred inside the empty establishment.

LUCAS stated when he arrived at the location, he observed damage to the front entrance door. Upon entering the establishment he observed damage to one of the gambling / game system(s) inside located adjacent to the entrance door. The machine was identified and titled "Bonus Hole". This machine has quarter(s) (US Currency) inside the machine, where the operator attempts to retrieve additional quarter(s) by operating the machine with new quarter(s). Located on top of the quarters inside the machine, LUCAS had placed approximately three hundred dollars (\$300.00) (US Currency) in order to entice people to play the machine to gain additional quarter(s) and the US Currency bills. The machine was secured by glass so the user(s) can see the quarter(s) in motion and their location in proximity to the machine.

LUCAS stated he has three different security system(s), within the establishment, On scene, LUCAS attempted to access the surveillance footage but was unsuccessful. LUCAS sated there have been two other prior incident(s) at the location that were reported to the police.

LUCAS was given my contact information and advised to submit any surveillance footage obtained regarding the incident.

This concluded my interview with LUCAS.

As a department trained CST, approximately seven (7) photos were taken of the reported incident. These photo(s) depict the damaged door, door frame and gaming machine. No latent print(s) were obtained from the crime scene.

You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
