This report is written by Police Officer Corstan D. COURT, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 09/26/2021 at 11:01am officers were dispatched to a Shooting at 2117 W. Center St. The officer spoke with employees who stated they heard shots fired outside the store. One employee saw a subject driving away holding a gun and another subject limping toward a car which then fled the scene. The officers located casing and a pistol magazine on the ground. The officers were able to view the video but the area of the parking lot where this incident took place was not covered by cameras. No victim was ever located.
- 2. On 08/31/22 at 11:37am, Milwaukee Police were dispatched to 2117 W. Center Street for a theft complaint. Investigation revealed that an employee was checking out customers but was not ringing up all their items.
- 3. On 09/21/22 at 6:22am, Milwaukee Police were dispatched to 2117 W. Center Street for a burglary complaint. Investigation revealed that a subject lifted the security gate at the front entrance and entered through an already broken door. He took merchandise and exited through an emergency exit door.

- 4. On 09/28/22 at 4:03am, Milwaukee Police, while on patrol, observed the two lower glass windows broken on the business at 2117 W. Center Street. Officers also found the metal security gate closed but a few of the metal rungs were bent inward and a metal security door in the southwest corner pried open in the lower right corner. It did not appear that anyone gained entry to the establishment and this was the third incident since 09/19/22. Attempts to contact the key holder were unsuccessful so the points of entry where boarded up.
- 5. On 12/29/22 at 10:59am, Milwaukee Police were dispatched to 2117 W. Center Street for a theft complaint. Investigation revealed that the security guard observed a subject enter the store, grab merchandise, and leave through the rear exit. The manager was confused as to why police were there because she did not call or need police service.
- 6. On 04/15/23 at 4:45pm, Milwaukee Police were dispatched to 2117 W. Center Street for a theft complaint. Investigation revealed that a subject entered the establishment, took merchandise, and left the store in a vehicle. The manager was able to give officers the registration plate of the vehicle the suspect left in.

Upon arrival I spoke to the Market Investigator, Amy T. BRNNETTE (W/F, 08-26-72) who stated Twanyeh D. NICHOLS (B/M, 01-14-04) is one of their employees and they caught him stealing. BRUNETTE stated this theft took place over several months and several transactions. BRUNETTE stated NICHOLS was working as a cashier at this Family Dollar location. BRUNETTE stated NICHOLS took park in this theft by checking out customers but wasn't ringing up all of their items. BRUNETTE stated NICHOLS admitted to them that the customers paid him to do this. PO MAGEE interviewed NICHOLS but he didn't admit to helping the customers steal. BRUNETTE stated she didn't know what items were stolen but she would provide video regarding the incidents. This case is pending the video results.

On Wednesday September 21, 2022 at approximately 6:22am, my partner (P.O. Richard SMITH) and I were dispatched to 2117 W Center St, located within the City and County of Milwaukee (Family Dollar) regarding a Burglary.

Upon arrival we observed the front door had broken glass, which was from a prior event, with the security gate partially open. The inside sliding door was shattered, which was from this incident.

We cleared the building and didn't observe any individuals remaining in the store.

Tiffany ENGEL (F/B 7-20-82), store manager, arrived on scene and was able to access video footage. ENGEL was cooperative with assisting officers with the investigation.

### Camera Footage

At approximately 6:13am the subject lifted the security gate at the front entrance and entered through the already broken door.

# The subject is described as black male, black hoodie with the hood up, white facemask, black pants, white log sleeve undershirt, white shoes, dark colored backpack.

The subject is observed going behind the front register and grabs multiple bottles of shampoo. The subject then walks to the south end of the isle grabbing more items. The subject then steps out of frame. The subject then exits through the emergency exit door on the south side of store. The subject walks westbound through the alley behind the store with a white basket full of items. The subject walks across N 22nd St and continues to walk westbound through the alley.

This report is written by PO Lauren MAROWSKY (on behalf of PO Adam GONZALEZ), Squad 3369, District 3, Late Shift.

On Wednesday, September 28, 2022, PO GONZALEZ and I were on routine patrol, when we drove into the parking lot of 2117 W. Center Street, located within the City and County of Milwaukee (Family Dollar) at approximately 4:03 AM.

As soon as we entered the parking lot, PO GONZALEZ and I observed the lower two glass window panes on the north side broken. There was numerous shards of glass both inside and outside the Family Dollar. The window panes were double pane and both the interior and exterior glass was broken.

Just inside the Family Dollar is a metal security gate, which was closed; however, I did observe a few of the rungs bent inward (towards the inside of the store) as if someone was attempting to pry them to gain entry into the store. As both PO GONZALEZ and I checked the exterior of the Family Dollar for further damage, we both observed the metal framing on the door in the southwest corner of the building pried on the lower right corner.

It does not appear anything was taken due to the security gate not being open at the time of our investigation however this is the 3rd incident where windows were damaged at the front of the Family Dollar since September 19, 2022 (IR # 222630076 and 222640033).

Based on the the sign on the Family Dollar, the incident occurred between Tuesday, September 27, 2022 at 8:00 PM, which is when the Family Dollar closes and Wednesday, September 28, 2022 at 4:03 AM, which is when we arrived on scene.

I attempted to contact the key holder from the previous two Burglaries reported but was unsuccessful and a voicemail was left. A buck slip (Milwaukee Police Department form PM-11) was filled out for video surveillance to be obtained of the incident.

2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)

3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).

4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.

5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

6. You may then provide testimony.

a. Include only information relating to the above license application.

b. Include only information you have personally witnessed or seen.

c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.

d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.

7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.

8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
