The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 08/08/2007, at 9:34am, a Milwaukee Police Department squad was sent to an armed robbery at the Wendy's parking lot 4601 W North Avenue. Upon arrival spoke to the manager who stated as he was walking to his car he was robbed of the night deposit, which is approximately \$2000.00. He stated it was two black males with a gun in a maroon Ford Expedition that fled eastbound through the rear alley.
- 2. On 05/31/18 at 8:24am a squad was dispatched to 4601 W. North Avenue (Wendy's) for a burglary complaint. Squad arrives and concludes a burglary did happen and an incident report was filed (171510029).
- 3. On 08/20/17 at 4:00pm a Milwaukee Police squad, while on patrol, observed two vehicles and a pedestrian dealing drugs in the parking lot at 4601 W. North Avenue (Wendy's). The officer's stopped the individuals in the parking lot, found drugs and drug packaging material, and they were arrested. An incident number was filed (172320130)

- 4. On 03/19/2019 officers were dispatched to a property damage at Wendy's, 4601 W. North Av. The officers spoke with that manager who stated an employee was having a problem with an ex-boyfriend. The employee stated she had an argument with her ex-boyfriend prior to coming to work. When she got to work he pulled up in his car and she closed the business door and locked it. He then kicked the door and left the scene.
- 5. On 10/04/20 Milwaukee Police were dispatched to 4061 W. North Av (Wendy's) for a hold up alarm. Upon arrival officers spoke with an employee who stated that the alarm was activated by mistake, and did not require the police. Officers checked the restaurant and observed that no one was in distress. The employee was not pleased that the police were at the location.

- 6. On 09/02/22 at 2:04pm, Milwaukee Police were dispatched to 4601 W. North Avenue for a property damage compliant. Investigation revealed that two terminated employees damaged property at the establishment. The manager had surveillance footage of the incident and she was cooperative with the investigation.
- 7. On 11/06/22 at 6:22pm, Milwaukee Police were dispatched to 4601 W. North Avenue for a shots fired compliant. Surveillance footage showed a vehicle parking in the middle of N. 46<sup>th</sup> Street, just south of W. North Avenue. The driver exits the vehicle and walks toward the establishment and at the same time an employee of Wendy's exits the building and walks toward the drive through. The two subjects exchange gunfire, and both leave the scene before police arrival.

On Friday, September 2, 2022, at approximately 2:04 pm, P.O. Antonio OBREGON and I were assigned to Squad 3233 (wearing full duty uniform, Axon body camera and operating a marked MPD Squad) and were dispatched to 4601 W. North Ave, the Wendy's for a reported Property Damage.

On scene we spoke with Manager Markquesha L. ALEXANDER (b/f 10-20-73) who stated that last night on 09-01-22 at approximately 11:00 pm, two ex-employees came and damaged property. ALEXANDER went on to state that "Fantasha GORDAN" and "Bethany DUCAN" were the ex-employees that had showed up the previous night. GORDON and DUCAN then tipped over and threw two garbage bins, damaging them and broke a Handicap Sign in the lot.

ALEXANDER did show us video of the incident and stated that she wanted to press charges. ALEXANDER could not provide further details regarding birthdates or contact info for GORDON and DUCAN and we informed her we would issue citations should we ID them.

ALEXANDER was cooperative with the investigation and issued a contact card.

This report is written by P.O. Craig ZIARNIK, assigned to District 3, Early Shift.

On Sunday, November 11, 2022, at approximately 6:20 PM, P.O. Ethan SCHLAX and I (squad 3220) were dispatched to 4601 W North Av, Wendy's, located in the City and County of Milwaukee, for a shots fired investigation.

Upon arrival, I spoke to the caller, Creshel N JONES (B/F, 03/29/81) who stated she is an assistant General Manager at Wendy's but does not usually work at this store and that she was filling in today to help out. JONES stated that there was a black female customer who was unhappy with how long it was taking to get her food, so the customer exited her vehicle and approached the drive thru window on foot while the vehicle ahead of her was still waiting at the window for their food. JONES stated the female started yelling at her and telling her she wanted her food and that if she was not going to get her food that she wanted her money back. JONES told the female to get back inside her vehicle and that her order would be coming up, but the female customer continued to be rude and yell at her until she left the window so the customers ahead of her could get their food. JONES stated the next vehicle pulled up which she described as a Gray Nissan SUV, possibly a Nissan Murano. JONES stated the vehicle is the same vehicle that the female customer was inside of before she exited to confront employees at the drive thru window. JONES stated the female customer continued to be rude and shout at her while waiting for her food and telling her to give her money back or give her the food. JONES stated she explained to the female customer that she would need the card that the food was paid for in order to return the charge, but the female was not listening, and the male driver of the vehicle told JONES that they would take the food and did not want the money back.

JONES stated she called the store manager and was explaining to them what was going on because the female continued to yell at her and at one point stated that no one was going to make it out this store. JONES stated an employee told her to press the button, which was the holdup alarm and shortly after she heard approximately five to seven gunshots. JONES stated she and another employee walked to the back room of the location to be safe from the gunfire and was unable to see who was firing the shots.

JONES took me to a back room of the restaurant where we were able to view video on their security system and Stephen A ROWAN (B/M, 03/23/81), who is the General Manager at the location arrived on scene to assist with viewing the video. The video shows the gray Nissan SUV at the drive through window with the black female customer outside the vehicle and waiting for their food. At approximately 6:10 PM, a white four door sedan, possibly a Nissan, is seen parking in the middle of N 46th St, just south of W North Av. The black male driver exits the front driver's seat of the vehicle and approached the east side of the Wendy's building and walks towards the drive thru. At the same time, a Wendy's employee who is later identified as Ray K WILSON (B/M, 12/06/84) exits the Wendy's through an exit located on the west side of the building and walks north and then east in the drive thru towards the subjects. The unknown black male driver of the white four door sedan is seen raising what appears to be a black handgun and points it in the direction of WILSON and discharges his firearm which appears to be a black handgun at least two times. The black male driver of the white Nissan four door sedan returns to his vehicle and is last seen driving eastbound on W North Av from N 46th St. WILSON returns to inside the Wendy's restaurant

While watching the video, ROWAN identified the Wendy's employee who exited the restaurant on video and is seen discharging a firearm was "Ray" and provided me with the information for Ray K WILSON. I attempted to call WILSON at the phone number provided to me of (414) 759-5279 but the call went straight to voicemail. I provided my name and a callback number for WILSON to contact me regarding this incident.

There were no longer any Wendy's Employees on scene that were there at the time of the incident besides JONES when I was done speaking with her.

P.O. SCHLAX located four casings on the south side of the Wendy's building, in the drive through area and on the sidewalk. The casings were later placed on MPD INV#22040926. We were unable to locate any casings on N 46th St where the unknown suspect is seen on video discharging a firearm.

P.O. SCHLAX took 19 photos at 6:49 PM of the scene.

The in-store video was emailed to P.O. SCHLAX but it is unable to be downloaded at this time possibly due to being on an internal program. Follow up will be conducted to attempt to retrieve the video as the restaurant is closed for the night.

P.O. SCHLAX and I changed locations to 3046 N 22nd St to check for WILSON at his listed address. We received no answer and were unable to locate WILSON.

WILSON is a convicted felon in the State of Wisconsin under Milwaukee County Court Case Number 2007CF005826.

Suspect Alert and Temporary Felony Want entered for WILSON.

This case is pending review by the Milwaukee County District Attorney's Office.

Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

# Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.

2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)

3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).

4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.

5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.) 6. You may then provide testimony.

a. Include only information relating to the above license application.

b. Include only information you have personally witnessed or seen.

c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.

d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.

7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.

8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
