Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffit, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. The Milwaukee Police Department's investigation regarding this application revealed the following:

- On 02/20/2015 Milwaukee police conducted a tavern check at Jack's American Pub (1323
 East Brady Street). Officers provided the shift manager, Daniel Gillespie, with a packet of the
 tavern related ordinances and discussed the tavern's procedures to prevent these ordinances
 from being violated.
- 2. On 02/26/2015 an 18 year old Milwaukee police aide, working in conjunction with Milwaukee police, attempted to gain entry to Jack's American Pub (1323 East Brady Street) but was turned away when she could not produce proof she had attained the legal drinking age of 21.

3. On 08/06/2015 at 2:12am Milwaukee police observed patrons exiting Jack's American Pub (1323 East Brady Street) and conducted a licensed premise check. Officers discovered 4 patrons still inside the business. The applicant was cited for Patron After Hours.

The applicant was cited. Sale of Alcohol to Underage Person Charge: Finding: Guilty Sentence: Fined \$181.00 Date: 04/22/2016 16018465 Case: 5. On 02/04/2016 officers conducted a training course for bars regarding the use and detection of fake ID's. Jack's American Pub, 1323 E. Brady St, participated in the training course. 6. On 03/30/2017 officers conducted underage tavern enforcement in District 1. An underage Police Aid attempted to gain entry to Jack's American Pub, 1323 E. Brady St. The Police Aid was allowed inside and ordered and was served a Miller Lite at the bar. 7. On 11/29/2018 officers conducted underage tavern enforcement in District 1. An underage Police Aid attempted to gain entry to Jacks American Pub, 1323 E. Brady St. The Police Aide was allowed entry and ordered a Miller Lite for \$4.00. The bartender was cited for the violation. The manager, Ryan GOEBEL was advised they failed the check. 8. On 03/03/2019 officers were dispatched to an incapacitated person at 1323 E. Brady St. The officers located the subject on the landing to the second floor. The investigation revealed the subject was in the bar and attempted to flee without paying for his bar tap. He was seen walking back inside after falling outside. He then began to act intoxicated and again fell to the floor. Medical was called because of a possible head injury. The subject was conveyed to the hospital for observation. No citation was issued for failure to bay his bar tap. 9. Investigation revealed that a patron was upset about his debit card transaction and flashed a holstered gun to the manager saying, "Your lucky I don't shoot you right now." The subject was arrested. All employees the police interacted with were cooperative during the investigation.
- 12. On 11/24/21 at 6:37pm, Milwaukee Police were dispatched to 1323 E. Brady Street for a fight compliant. Investigation revealed that a patron was in a verbal argument with the manager of the tavern. The argument became physical and employees helped the manager subdue the subject until police arrived. The subject was cited. All individuals on scene were cooperative.

The general manager stated that the security cameras were not functional.

When informed that he would not be able to enter their bar, the subject approached the security guard and removed what appeared to be a knife from his pocket. The security stated that he pushed the subject away from him out of self-defense, which resulted in the subject falling to the ground.

Security as well as the bar owner both stated that they did not want any legal action taken with the subject, instead they asked that the subject just be removed from the premise.

The male subject was offered a ride, to which he refused but later walked away under his own power.

No citations were issued, as well as no wrongdoing done by the bar employees.

On 5-21-22 at 1:48AM while assigned to Squad 1322, PO Elliott SANDERS-BARTA and I responded to an Overdose Complaint at Jack's American Pub, located at 1323 E Brady St. On this day, both officers were in full uniform and wearing Axon body worn cameras.

Upon arrival, I was directed to the upstairs level of the bar and into the women's bathroom. MFD Med #2 (Green Shift, led by LT Quincy WALKER) was already on-scene and tending to the victim, later identified as Cleara C BLACK (B/F, 05-30-89). BLACK was now seated on the bathroom floor and awake and talking. MFD informed me that they had administered 1mg of Narcan intra-nasally and another .5mg intra-venously. BLACK refused any further medical treatment and MFD cleared from the scene.

I spoke with BLACK who was semi-uncooperative as she spoke as to what happened and would not go into much detail. BLACK stated she arrived to the location with her friend, "Nay" by Uber. BLACK stated she ingested what she believed was an ecstasy pill around 1AM. BLACK would not say where she ingested the pill or who she received it from. BLACK stated she remembered being at the bar, but then does not recall anything else until she awoke on the bathroom floor. BLACK again declined any medical attention or any police services. BLACK denied intentionally overdosing and stated she did not try to harm herself.

I later spoke with Robertson T JONES (W/M, 06-15-90) who is the General Manager at Jack's. JONES stated that BLACK and another B/F wearing an all-gray outfit were said to have entered the women's bathroom together around 1AM. After a few minutes, only the other B/F exited as was not seen again. JONES stated this information was provided to him from another bar patron who was no longer on scene. I then asked JONES about the tavern's video surveillance system and JONES informed me that the cameras were not functional.

Those wishing to provide oral testimony via phone or internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
