5. On 01/20/20 at 10:19pm, Milwaukee Police conducted a license premise check at the address of 2237 N. Holton Avenue. The only violation found was an opened ½ gallon of milk. The employee was told to move it away from the other products for sale.

- 6. On 11/04/20 at 10:06pm, Milwaukee Police were dispatched to St Mary's Hospital 2301 N. Lake Dr. for a sick and injured complaint. Officers identified the victim of a substantial battery and located a scene at 2237 N. Holton St. Officers spoke with the clerk at the gas station who allowed officers to review video of the incident. Officers discovered that the victim was panhandling outside the location and got into a physical altercation with the suspect who was also panhandling. The suspect during the altercation struck the victim with a glass bottle causing injury. The gas station clerk stated to officers that the subjects usually panhandle near the business. When the subjects are told to leave they become verbally and physically combative.
- 7. On 03/30/21 at approximately 9:00pm, Milwaukee Police conducted a license premise check at 2237 N. Holton St. during the course of the premise check other officers were responding to a robbery investigation. The business was cooperative with the officers and provided video, of the incident. The video revealed that the incident took place outside on the lot of the gas station. From the video officers were able to determine the time frame of the incidet, the suspect and vehicle description.

8. On 07/11/2021 at 7:24pm officers observed a pop-up tent selling Milwaukee Bucks merchandise on the parking lot of 2237 N. Holton St. The officers spoke with the subject selling the shirts. He stated he was from Ohio and did not know he needed a license. He was able to get a co=worker to the sight that had a sellers permit. The subject stated they paid the manager of the gas station \$500 to use the property. The officers spoke with the applicant, who stated he did not give them permission and wanted them removed.

- 9. On 08/07/2021 at 2:50am officers were dispatched to a Shots Fired at 2237 N. Holton St. The investigation revealed a patron was filling up his car with gas, when a car pulls up in front of his parked auto. The two drivers exchanged words. The driver of the second car attempted to get in the store but the clerk locked the door. The driver returned and again had words with the first subject. The car drove off and the first patron produced a gun firing at the auto. The second subject produced a firearm and shot back at the first subject. The officer spoke with the clerk and he provided the officer with video of the incident. The officers contacted the applicant and he stated he was aware of the incident and that there was no damage to the station.
- 10. On 04/28/2022 at 9:39pm officers conducted a license premise check at Citgo on Holton, 2237 N. Holton St. During the check the officers observed several food items to be displayed for sale after their expiration dates. The items were removed from the counter and the clerk stated he would advise his manager. The officer did speak with the agent by phone.

- 11. On 07/15/22 at 8:29a.m., Milwaukee Police were dispatched to a License Violation at 2237 N. Holton St. Officers were advised a caller had checked with License Division and found the licenses to the business were expired, however, they were operating. The caller stated their goal was to get the business shut down. On arrival officers did find the business was operating with expired licenses. The officer contacted the agent, who stated they had a community meeting the same day and a meeting with License Committee the next day and was informed their license would be pushed through, therefore they thought it would be ok to operate. The agent voluntarily shut down the business.
- 12. On 08/08/22 at 10:15a.m., Milwaukee Police conducted follow up at 2237 N. Holton regarding a violation of the business plan for the Extended Hours License. The agent expressed understanding of the security measures and stated the date of the violation the security guard called in sick.

On 07-18-22 at 9:37 a.m., we were dispatched to the location of 2237 N. Holton St., for a report of a license violation. The caller called to inform the police that the this location, Citgo on Holton, is a licensed premise in the city of Milwaukee. The caller stated the licenses to the business were not longer valid.

The caller stated he found out the licenses to the businesses expired on 07-15-22, via contacting the license committee and that his goal is to get the business ticketed and shut down.

I went to the business and attempted to speak to the worker, but due to a language difficulty, I was not able to really speak to the employee. I was able to have the employee call the owner/agent of the business, Prewal PRITPAL. While he was calling PRITPAL, I was able to view the licenses for the business and found they were expired.

I was able to speak to the owner/agent and informed him that is business licenses were expired and that he could not operate until his licenses were renewed. He stated he had a community meeting tonight and a meeting with the license committee tomorrow on 07-19-22. GREWAL stated he was informed that his license would be pushed through and believed he would be ok to operate his business. Again I informed him he could not operate until the new licenses were issued. GREWAL voluntarily shut down his business until he was issued new licenses.

(m/w 04/26/81) regarding the amended extend hours of the business. Currently the business is closing before 12:00am, and not allowed to have extended hours of operation. When the business is back to extended hours operations the business is to be closed at 2am and have security from 9pm-2am. After clarification with the City of Milwaukee License Division, the business is to have security at his business after 9pm, no matter the time of the business closing. Mr. Grewal stated that he is having an unarmed security guard work his business from 9pm to 12am. When the business is allowed to go back to its augmented extended hours the security guard will work from 9pm to 2am.

Mr. Grewal did relay to me that on Sunday 08/07/22 the security guard did not work because he had to care for his sick son, and he did not have security coverage that day.

Those wishing to provide oral testimony via phone or internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.

2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)

3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).

4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.

5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.) 6. You may then provide testimony.

a. Include only information relating to the above license application.

b. Include only information you have personally witnessed or seen.

c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.

d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.

7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.

8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
