The Milwaukee Police Department's investigation regarding this application revealed the following:

CRIVELLO was upset with her friend for calling medical and police services and advised numerous times that she was ok.

The guest was Identified as Amauri Quintarious ROYAL, M/B, 09-16-91 of Alabama. This incident had been reported by another occupant of the room, Marchelle L II, F/W, 03-12-69. SALEEM works with Royal. She stated she had gone to the room and observed ROYAL to be unresponsive while laying in bed.

Upon arrival in room 216, Officers observed ROYAL to be laying on a bed in the S/E corner of the room. ROYAL was laying down with his feet slightly off the food of the bed. ROYAL was on his back and was not breathing. He had no pulse and was cold to the touch. Medical attention was summoned at this time. P.O. KRESA brought Marchelle into the hallway to interview her regarding her knowledge of the situation.

PO Bradley JOHNSON and I lifted ROYAL from the bed to the floor to begin life saving measures. It was shortly after that Milwaukee Fire Department (MFD), Engine 14, headed by Lt. James KELLEY, and Sq 6210, Sgt. Brian LAROQUE, arrived on scene. MFD advised due to ROYAL being cold to touch and having rigor mortis, no life saving measures would be provided to ROYAL. MFD pronounced ROYAL at 8:46 pm. MFD contacted Medical Examiner

During this investigation, Officer JOHNSON advised me of a small zipper pocket in the right front of ROYAL's shorts. Upon checking this pocket, I recovered a small plastic corner cut sandwich baggie with a brown powdery substance, suspected to be Heroin; a clear corner cut sandwich baggie, with a white powdery substance suspected to be cocaine, and a plastic "shooter" straw for inhaling narcotics. I seized the narcotics, and later took possession of them for further testing. Officer JOHNSON spoke with Marchelle, who advised him that she knows ROYAL smokes "weed" and that he smoked weed earlier after they finished their shift and prior to coming home around 7:00 am. She did not know if he smokes or uses other drugs.

Medical Examiner Debbie STODOLA arrived on the scene and pronounced Royal at 10:10pm. The narcotics were then conveyed to District 6 for testing. P.O. Eric LAUX, Sq 6231,

MFD Engine #14 was on scene in room #206 with an unconscious and not breathing patient identified as Jennifer NELSON (F/W 03-28-81). Two doses of Narcan were then delivered to NELSON and she slowly became conscious and breathing on her own. She was still very disoriented so she was conveyed by Oak Creek Med #183 to St Luke's South Shore for treatment and evaluation.

I spoke to the manager and original caller, Muhammad USMAN on scene. Usman stated NELSON checked in on her own on 04-15-23 and was to stay for (7) nights.

USMAN stated she was to check out at noon but did not and the door as locked. H waited until about 1pm and entered the room with a key and found NELSON on her stomach unresponsive. USMAN immediately called 911.

PO JUMES recovered a glass tube charred at both ends from the table in the hotel room along with a plastic push rod. These are both commonly used during narcotics use. These will be placed on MPD inventory and NELSON issued a citation for drug paraphernalia.

At the hospital, NELSON admitted to smoking crack cocaine and snorting powder cocaine. She stated she binged all night and was unaware she had been unresponsive.
