

Dear Sir or Madam:

Gallun Tannery Row alleges that the Condominium Owners Association's fire suppression system located at 1818 N. Water Street and 818 - 824 E. Hamilton Street, was compromised after repair work was completed during the time period of July 21, 2022 - July 24, 2022. Gallun Tannery Row submitted an estimate for damages in the amount of \$6,000, regarding rock and debris that entered the fire suppression system.

This notice of claim was filed on December 12, 2022. Wisconsin Statute 893.80(1d)(a) requires that a notice of the circumstances of the claim be filed within 120days after the happening of the event giving rise to the claim.

Our investigation reveals that on February 21 and May 25, 2022, Milwaukee Water Works(MWW) reported that FP Solutions conducted fire sprinkler system inspections at the subject locations and while performing inspection tests, the main drain valve filled with rock/debris as observed in the pipes when refiling the system.

Prior inspection reports from 2021 did not indicate rocks or debris present in the sprinkler pipes. Maintenance records in the proceeding twelve months of that February inspection did not indicate any evidence of work performed by MWW.
