

RE: Ladarius Marshall v. City of Milwaukee, et al.

Dear Council Members:

Enclosed please find a proposed resolution. We ask that it be introduced and referred to the Committee on Judiciary & Legislation, with the following recommendation.

Please find a proposed resolution to approve additional funds to pay outside counsel settlement to conclusion in the amount of \$60,000 in the lawsuit *Ladarius Marshall v. City of Milwaukee*, Eastern District Federal Court Case Number 22-cv-00525, as well as a fiscal impact statement.

On May 2, 2022, Mr. Marshall filed a complaint with the United States District Court for the Eastern District of Wisconsin, case number 22-CV-0525, alleging, among other things, a violation by obtaining a confession contrary to the Fifth Amendment, his due process rights under the Fourteenth Amendment to the U.S. Constitution, Failure to Intervene, and various state law claims. In addition to suing the City of Milwaukee directly, Mr. White sued Milwaukee police department officers Matthew Goldberg, Timothy Heier, Gus Petropoulous, and Michael Braunreiter.

Mr. Marshall alleges that officers in 2008 during a homicide investigation coerced his confession wherein he admitted to shooting his friend, another juvenile. Mr. Marshall ultimately pled guilty in state court, and served 10 of his 20-year sentence of initial confinement before he was released by a federal court judge on a successful motion for Habeas Corpus.

The request for these additional funds in the amount of \$60,000 will pay all outstanding bills, and any final fees, to conclude this litigation.

Based on the status of these claims, it is the City Attorney's recommendation that authorizing these specific additional funds is in the City's best interest.
