Description of Grant Project/Program (Include Target Locations and Populations):

The Milwaukee Police Department (MPD) will host the Wisconsin State Patrol Bureau as they conduct Drug Recognition Expert (DRE) Field Certification training to be held at the Training Academy. DRE field certification requires participants to perform a 12-step standardized and systematic evaluation on individuals who are under the influence of drugs other than alcohol. Training participants must correctly identify impairment from different drug classifications. The grant will fund voluntary overtime for police officers to accompany training participants in the field to locate individuals that agree to voluntary drug evaluations held at the Academy. The drug evaluations are voluntary and completely confidential, no personal identifying information is requested or obtained. Individuals that agree to drug evaluations receive snacks and information on addiction, mental health, homelessness, meal programs, and employment resources and opportunities. The focus of the evaluations is on training, not enforcement. No enforcement actions are taken. The purpose of DRE certification is train law enforcement officers on drug physiology, anatomy, and the effects of different drug categories on the body to enable identification of a subject's drug impairment using the 12-step evaluation process. The MPD will provide the Academy to facilitate the voluntary drug evaluations and accompany DRE training candidates to locate voluntary individuals for drug evaluations through consensual encounters.

 - The MPD will partner with the Wisconsin State Patrol Bureau to provide the facility and voluntary overtime opportunities for police officers as part of the DRE Field Certification in support of proactive training for law enforcement officers to identify drug impairment in suspects and provide expert testimony in drug impaired driving cases.
