Dear City Clerk Owczarski:

Enclosed are documents that have been provided to Alderman Russell Stamper from the City of Milwaukee Water Works regarding work that was done at 4013-17 West Center Street. I have been working with the Department of Public Works and City Treasurers office since this charge was incurred to rectify the situation. I have been advised to process a claim.

Milwaukee Water Works requested access to the building to change the water meter, at no charge, in August of 2021. An appointment was scheduled for the water meter switch for October 5, 2021. The city worker/contractor that came to install the meter caused a leak that the business owner contacted Milwaukee Water Works about on October 7, 2021. In the Work Order History provided by the Milwaukee Water Works, it is noted on October 11, 2021, the leak occurred after the exchange and that Milwaukee Water Works needed to use the curbside shut off in order to stop the leak.

These "repairs" started on October 15, 2021 and continued until October 23, 2021. During this time, according to the Milwaukee Water Works Work Order History, October 18, 2021, lead lateral replacement started. This location was then charged \$4,000 on a special tax bill for changing the lead laterals. This was not any part of the initial discussion or reason why Milwaukee Water Works was provided access to the building. There would not have been a need for repair, if the city worker/contractor had not banged on the valve "attempting" to remove the water meter.

Hello,

There is a clarification for note 5a. "Election to use City Contractor to replace lead service line and install meter settings" is referring to the title of the form that Akua Oladunjoye, owner of Sabir's Karate & Fitness, was pressured to sign on 10/23/2021, after the work was completed. The referenced note is attached, as well as, the original documents sent earlier today.

Below is a summary of the chain of events. It was very confusing at the time due to the physical mess that was made and the number of people that were involved in resolving the issue.

- Milwaukee Water Works came to the business on 10/5/2021 to change the water meter at "no cost" to the business/home owner. (note 1)
- Due to the worker banging on and breaking the valve, which resulted in a leak, Milwaukee Water Works returned to the business on 10/11/21 to repair the leak. (note 4)
- The worker was unable to shut off the valve inside or at the curbside 10/11/21. The worker contacted a supervisor for assistance. (note 4)
- Shut off at curbside was fixed 10/14/21 (note 4)
- Milwaukee Water Works Work Order History on 10/15/21 states "Inlet valve leaking". (note 3)
- Milwaukee Water Works also notes on 10/15/21 that supervisor Ron C. was called and that the "customer is in the lead program". Sabir's Karate & Fitness was not informed of or asked to be a part of a lead program. (note 3)

Looking at the Work Order History, there is no mention of lead pipe until 10/15/21, which is after the leak was fixed. I am curious whether other residences or businesses on that block had their meters changed during that same time frame. Seems very convenient that the meter is being replaced at no charge, the valve is broken and now there is a lead pipe after all is done.

Again, thank you for your assistance with this matter.
