Dear Ms. Ogboni:

We are in receipt of your claim in the amount of \$4,000, as a result of a meter exchanged that occurred on October 5, 2021, at your property located at 4013-17 W. Center Street.

This notice of claim was filed on March 22, 2023. Wisconsin Statute 893.80(1d)(a) requires that a notice of the circumstances of the claim be filed within 120 days after the happening of the event given rise to the claim.

Milwaukee Water Works (MWW) reported that on October 8, 2021, at 3:41pm, you reported a leak near the meter. The next business day, October 11, 2011, MWW responded and observed a small leak at the GKS valve on the private side of the inlet line. The valve could not be repaired without shutting the water off. The meter shop tech was unable to turn off the water at the curb stop which generated a work repair order.

On October 14, 2021, MWW completed maintenance cleaning on the curb stop box, and it was fully operable. On October 15, 2021, MWW attempted to repair the leak and noted the inlet pipe was made of lead. A referral was made to the Lead Service Line Replacement Program, per the City of Milwaukee Code of Ordinance 225-25.5-3a, a lead service line must be replaced when "a leak or failure has been discovered on either the privately owned or utility owned portion of the service line. There is no clause in the ordinance that allows for costs associated with the private side of the Lead Service Line Replacement Program to be waived.


