1. Description of Grant Project/Program (Include Target Locations and Populations):

The overall purpose of the State Newborn Screening Program is to screen every infant born in Wisconsin for rare disorders including hypothyroidism, PKU, and hemoglobinopathies (which includes sickle cell disease) along with many other disorders recommended by the National Committee for Newborn Screening. While infants are often covered by insurance, accessing and obtaining proper medical care is often difficult for families. The MHD congenital disorders public health nurse coordinator works with any infant in the State of Wisconsin who requires repeat screening, and ensures they receive appropriate care. The major activity of this grant is to assist families in accessing medical care for follow-up tests, assuring appropriate medical follow-up for affected infants, and establishing a medical home for ongoing care. In addition, this program provides education to clients and professionals about newborn screening and repeat testing. This project also assures that each client family has a medical home for their infant and has access to resources and support around medical insurance. MHD may complete blood tests in home if family has been unable to get baby tested elsewhere and agrees to service.

2. Relationship to City-wide Strategic Goals and Departmental Objectives:

This program helps to improve the health of children, reduce infant mortality, and ensure that all children entering school are physically and mentally capable of living their best lives. All of these are departmental objectives and assist in attaining the City-wide objective of making Milwaukee a city of healthy citizens with educational opportunities.

3. Need for Grant Funds and Impact on Other Departmental Operations (Applies only to Programs):

This grant fully funds one position of Public Health Nurse Coordinator.

4. Results Measurement/Progress Report (Applies only to Programs):

In 2022, MHD followed up with 105 infants, screened 50 infants, and case managed 11 infants with a sickling disorder. All referrals were triaged within 2 business days. One hundred percent of babies with sickle cell were seen in clinic by four months of age. Ninety percent of infants had a primary care provider identified. A total of 5 Congenital Disorders Educational Classes and Outreach events were conducted/ in order to educate medical professionals, nursing students, and City of Milwaukee residents of the importance of Newborn Blood Screenings and its positive impact on infant health through early screening and intervention. MHD also supports families to ensure infants have health insurance, a primary healthcare provider, safe sleep, immunizations, and the ability to meet their basic needs. Without this funding the program will not continue.

The grant period is July 1st 2023 through June 30th 2024.
