Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. It is the intention of the Common Council to suspend or non-renew the licenses if objectors provide testimony related to the factors enumerated in MCO 85-4-4 that the Common Council finds to be true by a preponderance of the evidence and/or police reports are found to be true by a preponderance of the evidence. You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

This report is written by Police Officer Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 01/29/11 at 4:12 pm, Milwaukee police were dispatched to 27th and Atkinson for a Shots Fired complaint. Police spoke with a victim who stated he was shot by an employee of Hot Spot Super Market. The victim stated it occurred in front of the store and he was then transported by MFD to an area hospital for treatment. Police responded to the store and attempted to speak with the employees and witnesses however they were uncooperative. Police requested to view video. The owner, Nael Jabbar, stated that they had no video in the store for at least the last two months. Employees were telling officers they did not know why police were there. The business was closed until the investigation was completed. While on scene, police recovered two guns that were located in the store, which were confiscated by police. Police took photos of all employees, which were shown to the victim who identified Nader Ahmed Salem as the man who shot him. Salem was then placed into custody. Numerous other violations were observed in the store such as the sale of single cigarettes and batteries. Police also found two cans of pepper spray, a knife with a 5 inch blade, an empty gun holster and a scale.
2. On 05/24/11 at 12:45 pm, Milwaukee police as well as members from the the Department of Neighborhood Services conducted a License Premise check at 2643 W Atkinson. A check was done to verify that the store had their camera system properly running. The camera system was found to be not working because of construction work being done on the rear of the building and officers also observed excessive signage on the exterior of the building. The DNS inspector advised Nael Jabbar that he would get back to him regarding obtaining the proper permits for the signage on the exterior and the remodeling that was taking place. No other violations were observed at this time.

3. On 06/03/11, a store clerk identified as Ibrahim A Issa, did sell to a citizen two single Newport cigarettes for a dollar. Behind the counter was a box with numerous single Newport cigarettes. It was a citizen that complained to police about the sale of single cigarettes. Issa was cited for the violation.

4. On 02/20/2016 a 17 year old, working in conjunction with Milwaukee police, was able to purchase a 2 pack of White Owl Cigars from the cashier at 2643 West Atkinson (Hot Spot Supermarket).
 5. On 09/06/2016 Milwaukee police responded to a fight at 2643 West Atkinson Avenue (Hot Spot Foods): Investigation revealed there had been a fight inside the store that escalated once the involved parties exited the business. One of the involved parties threatened to return and shoot the armed security guard. The subject who made the threat was cited for disorderly conduct.

6. On 03/03/2018 an officer conducted a licensed premises check on The Hot Spot, 2643 W. Atkinson Av. The officer observed a subject sitting on empty milk crates behind the deli counter drinking alcohol. This subject was not an employee and with help of an actual employee located marijuana by where the subject was sitting. The officer viewed the stores video surveillance which showed the subject outside the store conducting suspected drug transactions. The subject was arrested for POCS with intent to deliver.

7. On 07/18/2018 officers were dispatched to a Violation of Restraining order at The Hot Spot, 2643 W. Atkinson Av. The applicant was the caller and stated her has a restraining order against a subject and that person was in the store today charging his phone. The applicant

stated after several minutes the subject did leave but returned later. The officers filed a report regarding the violation of restraining order.

8. On 08/05/2018 officers were dispatched to a Violation of Restraining Order at The Hot Spot, 2643 W. Atkinson Av. The applicant was on scene and observed a subject outside the store that he has a restraining order against. The subject was told to leave and left prior to the arrival of the Police. Report filed.
9. On 11/16/2018 officers were dispatched to a Shooting at The Hot Spot, 2643 W. Atkinson Av. The caller was in the store when a subject walked in and stated someone robbed him and shot him, so she called the Police. The clerk stated the victim is a frequent customer but he only knows him by a nickname. The clerk did not have the password for the surveillance cameras but did call the owner.
10. On 02/03/2019 at 9:04pm officers observed patrons inside The Hot Spot, 2643 W. Atkinson Av. They continued to observe and saw 2 people enter after the 9:00pm closing time. They then conducted a licensed premise check and found 8 patron inside, one of which was standing in line with alcohol to purchase. The clerk stated the patrons had entered prior to 9:00pm. The store was closed and the customers asked to leave. None of the employees had a Class D Operators license. The officers observed litter outside the store along the north wall and did not observe any security guards. The applicant was cited for Responsible Person on Premise Required.

11. On 02/16/2019 at 3:07pm officers were dispatched to a fight at The Hot Spot, 2643 W. Atkinson Av. The applicant was on scene and stated that Keontray DURRAH came into the store wanting to fight an employee. He stated that DURRAH threw a garbage can spilling it on the floor. He did show the officers a portion of the security video that showed DURRAH throwing the garbage can but refused to show the officers all of the video. The officers spoke with the subject who stated the store manager broke his glasses and he wanted them fixed. The store manager took the glasses to have them fixed.
12. On 2/26/2019 at 8:50pm officers conducted a business check at The Hot Spot, 2643 W. Atkinson Av. The officers located a subject in the store smoking a cigarette. He was escorted out of the store. The subject left some property in the store and the officers smelled marijuana coming from his property. They did not locate any marijuana but did locate several more cigarette butts where the subject was sitting, suggesting he had been at that spot for some time. The officers spoke with the applicant about his lack of security, which would have kept the subject from loitering in the store for long periods of time. The applicant stated he had security companies but they quit because they were being harassed by the customers. The applicant stated he would not allow this subject back in his store again.
13. On 03/07/2019 officers conducted follow up at The Hot Spot, 2643 W. Atkinson Av, regarding the fight on 02/16/2019. The officers had interviewed the victim of that incident, Keontay DURRAH, who stated he had been beaten by the store owner and his employees and that one of them had pointed an AR-15 rifle at him. The officers spoke with the owner who stated DURRAH was just attempting to get money from him. The officers requested to see the video.

The applicant took them back to the system but appeared to be pulling up the wrong date. The officer advised the applicant he was familiar with his camera system and he could operate it but he then called his attorney who told the officers they would need a warrant to see the video.

Item #10 updated with disposition on 05/06/2020

14. On 07/15/2019 at 4:18pm officers were dispatched to a Shooting at The Hot Spot Supermarket, 2643 W. Atkinson Av. The victim was shot three times as he was leaving the store. The applicant was cooperative with the investigation.
15. On 09/23/2019 at 12:00pm an officer investigated a battery at The Hot Spot Supermarket, 2643 W. Atkinson Av. The victim stated he was at the store visiting the applicant, who is his uncle. The victim stated there was a subject in the store acting strange, asking for his phone back. The applicant gave him his phone, which was charging behind the counter. Later the victim went outside and asked the subject why he was acting strange. The suspect stated they own the block and would beat up the victim. The victim felt something strike him in his left eye. The victim blacked out but observed the suspect run away. The victim was taken to the hospital where he was diagnosed with a fractured orbital. The suspect was located and arrested.
16. On 10/18/2019 at 8:34pm officers conducted a licensed premise check at The Hot Spot Supermarket, 2643 W. Atkinson Av. The store closed at 9:00pm and the staff promptly had the customers exit. The officer observed the posted licenses were expired. The clerk located the current licenses and was advised to post them right away. The officer observed electronic gambling machines in the middle of the store. The officer observed cigarette butts on the floor and in cup around the machines. The staff was advised to monitor the machines, to prevent patrons from smoking in the business.
17. On 11/14/2019 at 3:33pm officers, along with agents from the Wisconsin Department of Revenue, conducted a licensed premise check at The Hot Spot, 2643 W. Atkinson Av. The Department of Revenue agent could not locate invoices for some tobacco products and confiscated 13 boxes of un-invoiced products. The applicant was on scene and cooperative. The Department of Revenue agent wrote violations relating to the 6 gambling machines.
18. On 12/25/2019 at 10:51am officers were dispatched to a Subject with a Gun at 2643 W. Atkinson Av. The officers interviewed an employee, who stated a known subject was in the store acting out. The subject knocked over displays and knocked the cash register and lottery machines off the counter. The applicant stated the subject had been in the store last night and was ordered in to the DA's office for Disorderly Conduct. Today he caused damage to the registers and lottery machine.
19. On 12/29/2019 at 1:23pm officers were dispatched to a Drug Dealing complaint at 2643 W. Atkinson Av. The officer spoke with the caller, who was identified as the security guard at the Hot Spot. He observed a subject on the northeast corner of N. 27th St and W. Atkinson Av perform a suspected drug transaction. The subject then came on the property of the Hot Spot and the guard asked him what he was doing. The subject admitted selling marijuana and the guard detained him for the police. The subject was found to be in possession of marijuana and was arrested.

20. On 12/29/2019 at 5:43pm officers were dispatched to a Drug Dealing complaint at The Hot Spot, 2643 W. Atkinson Av. The officers met the security guard, who had detained a subject for selling drugs on the property. The officers located marijuana on the subject and issued him a citation.

21. On 02/28/2020 at 8:48pm an officer was in the area for illegally parked autos, when he observed a fight inside The Hot Spot Supermarket, 2643 W. Atkinson Av. The officer went inside and saw two females fighting with a group watching. There were two security guards that were attempting to break up the fight. The officer detained one of the females and the security guards held the other until more squads arrived. The officer spoke with the applicant, who stated he knows the two females and they have an on going feud, which has resulted in fights in the past. He stated he wanted the officers to advise the females they were not allowed back in the store and had them sign a form advising them they would be trespassing if they returned.

22. On 10/10/21 at 3:31pm, Milwaukee Police were dispatched to 2643 W. Atkinson Avenue for a hold up alarm. Investigation revealed that an employee pushed a customer down inside the establishment which caused a large fight to break out. The manager is seen on surveillance footage with a silver handgun in his right hand trying to break up the fight and another customer threw a rock at the front door of the store. Video then showed multiple subjects outside the store and one of them kicking at the glass front door. The manager fired one shot at the wall near the front door fearing that the subjects might break down the door to gain entry. The applicant arrived on scene approximately 30 minutes later and was cooperative throughout the investigation.

23. On 02/05/22 at 6:07pm, Milwaukee Police were dispatched to 2218 N. 42nd Street for a robbery complaint which occurred at 2643 W. Atkinson Avenue. Investigation revealed that the caller was inside the establishment and engaged in a verbal argument with an employee and applicant. The caller, who reached to the back of his waistband multiple times, walked aggressively towards the applicant. The applicant struck the caller one time in the face and a physical altercation happened between the caller, an employee, and other customers of that location. The applicant told officers that the fight started because his employee refused to sell the caller alcohol because he was highly intoxicated.

24. On 05/25/22 at 7:51pm, Milwaukee Police conducted a license premise check at 2643 W. Atkinson Avenue. The applicant was very cooperative with the investigation, but he was unable to provide paper copies of his licenses and they were not posted inside the location. The armed security guard at the location was working with an expired license.

26. On 12/20/22 at 7:11p.m., Milwaukee Police were dispatched to a Reckless Use of a Weapon at 2643 W. Atkinson Av. Investigation revealed a known subject was in the store loitering and refusing to leave. When asked to leave the subject pulled out a firearm and stated "we gonna

fight", to the security officer, before passing the firearm to another subject. The subject is known to the agent and security and they previously had a restraining order on the subject, however, it had expired. The employees were cooperative and showed officers video surveillance of the incident, which led to a probation hold on one of the subjects.

27. On 01/14/23 at 10:19a.m., Milwaukee Police were dispatched to a Drug Dealing at 2643 W. Atkinson Av. The owner of the store called the police to state they witnessed a hand to hand drug transaction take place inside the store. On arrival officers were provided a description of the subject as well as where the subject had hidden a firearm they had on their person. Officers located the firearm hidden by jars of salsa. A search incident to arrest of the subject revealed the subject to be in possession of marijuana and individually packaged bags of crack cocaine. The agent and employees were cooperative with the investigation.
28. On 03/06/23 at 3:36p.m., Milwaukee Police were dispatched to a Hold Up Alarm at 2643 W. Atkinson Av. Investigation revealed a customer in store was acting belligerent, when asked to leave by the security officer. The suspect then displayed a firearm in his waistband as the security officer closed the door. The customer continued to yell and cause a disturbance outside, when he re-entered the store with this firearm out, eventually firing 2 rounds at a customer, however, he missed. The customer then retrieved his firearm and fired 2 rounds, shooting the suspect. The suspect continued to fire off rounds, at which time the security guard, the clerk and a customer fired their weapons at the suspect until the suspect stopped shooting. The security guard held the suspect at gunpoint until police arrived on scene. The employees were cooperative with police and the investigation providing video surveillance of the incident. No charges issued against any employees.
29. On 04/18/23 at 7:40p.m, Milwaukee Police were dispatched to a Drug Dealing complaint at 2643 W. Atkinson. Prior to arrival officers were provided with a description of the subject that was wearing a yellow backpack. On arrival officers observed an individual matching the description inside of the store. The subject was taken into custody and was found to be in possession of Methamphetamine, THC and Fentanyl. The owner was very cooperative with the investigation and assisted officers in retrieving video surveillance of the transactions. The owner stated the area is known for narcotic sales, however, he does not want them conducted in or around the business.
30. On 04/24/23 at 7:14p.m., Milwaukee Police were dispatched to a Drug Dealing complaint at 2643 W. Atkinson Av. Dispatch provided officers with a description of the suspect, however, he was gone on police arrival. The agent was on scene and cooperative providing video surveillance of the individual, which was determined to be the same suspect in Item #27. The agent stated he does not allow drug transactions inside his premise and requested police assistance.
31. On 05/19/23 at 8:47p.m., Milwaukee Police were dispatched to an Overdose at 2643 W. Atkinson Av. Prior to arrival officers were advised a subject was going "in and out", vomiting and was on drugs. On police arrival the subject or caller could not be located, however, it was later determined police responded to a Battery call and met the victim at the hospital. It is believed this was the same subject.

This report is written by PO Christopher J SCHLEI, PS 022571, assigned to District 5 - early power shift.

On Saturday, June 10th, 2023, I was instructed by Sgt SMITH to file this license premise report. I was not on scene and am only able to use the information available to me in the filed reports. The reports are as follows:

PO ROSEN's initial report

~~This report is being typed by PO Matthew ROSEN, assigned to District #5, Early Shift, Squad 5273 (Garden Homes).~~

On Tuesday, December 20, 2022, at approximately 7:11 PM, PO Matthew ROSEN and PO Benjamin HOLSEN (Squad 5273) were dispatched to a Reckless Use of Weapon Complaint at 2643 W. Atkinson Ave. (Hot Spot Supermarket), which is located in the City and County of Milwaukee.

Upon arrival, I spoke with the caller/victim, later identified as Deroyce M. CARTER (M/B 02/16/1987). CARTER stated that at approximately 4:11 PM on the aforementioned date, the subject, identified as Melvin R. GOODWIN (M/B 11/19/1990), was loud, boisterous and stated "We gonna fight" when he was asked to leave the store. CARTER stated that GOODWIN then pulled a black semiautomatic handgun from his waistband area of his pants and handed to another subject, identified as Donzel L. MORSE (M/B 10/26/1997). CARTER stated that MORSE then took the firearm and concealed it in the waistband area of his pants. CARTER stated that he has known both the subjects for many years through interactions at the Hot Spot as Security Manager of the store. CARTER stated that there was a Restraining Order on GOODWIN at the Hot Spot in previous years. A Wisconsin CCAP search of GOODWIN reveal that he is a convicted felon (19CF1593), which has not been overturned. A Wisconsin CCAP search of MORSE revealed that he is a convicted felon (19CF0796), which has not been overturned. While PO HOLSEN and PO ROSEN were investigating, they were able to observe the above stated incident on a recorded surveillance video at the location.

INTERVIEW WITH THE VICTIM: Deroyce M. CARTER

CARTER stated that he is the security manager at the Hot Spot and has had numerous contacts with GOODWIN and MORSE during his employment. CARTER stated that many of these contacts have involved the police being called. CARTER stated because of these incidents, he knows GOODWIN and MORSE by their full names. CARTER stated that there was a Restraining Order (2017CV011635) in place on GOODWIN and the Hot Spot Supermarket. The Restraining Order no longer appears to be in place on a database system records check. CARTER stated that at approximately 4:11 PM on today's date GOODWIN was loitering inside of the Hot Spot. CARTER stated that a City Council representative was meeting the owner at the Hot Spot during this period of time. CARTER stated because of this meeting, he wanted to make sure that there was not any loitering or other unwanted activity in the store. CARTER stated that he asked GOODWIN to leave if he was not buying anything. CARTER stated that GOODWIN

said "We gonna fight!" and was swearing at him. CARTER stated that GOODWIN said " You gonna have to put me out!". CARTER stated that GOODWIN pulled a black semiautomatic pistol from his midsection, waistband area of his pants. CARTER stated that GOODWIN handed the firearm off to MORSE. CARTER stated that MORSE placed the firearm in the waistband area of his pants. CARTER stated that another Hot Spot employee ushered GOODWIN out the door of the store.

The incident was captured on the Hot Spot's surveillance system and a synopsis of the observation is detailed in a supplemental report by PO HOLSEN.

I sent a citizen request to CARTER through Evidence.Com, so that he could directly download the surveillance footage into evidence.

I issued a PV-17 and Community Contact card to CARTER and informed him to call 911 if GOODWIN or MORSE were to come into the Hot Spot.

PO HOLSEN and I searched the area of N. 27th St./W. Atkinson Ave. (Garden Homes) for GOODWIN and MORSE but we're unable to locate them at this time.

GOODWIN pulls the rear of his pants up and then withdraws a black semiauto pistol from his waistband with his righthand and then hands the firearm to a subject located to the right. The subject was identified as Donzel L MORSE (B/M 10/26/1997), who was wearing a black winter hat with a white emblem on the front, a shiny puffy winter jacket, sweatpants with a red stripe on the side with glasses. took the handgun with his left hand and then concealed the firearm on his left hip away from the camera.

GOODWIN then continues to threaten the victim, who was off screen of the video. When an older woman entered the store GOODWIN then puts his jacket back on. This is where the video ends.

I am unable to determine what licenses the location had displayed. ~~On Saturday, January 14, 2023, at approximately 10:19AM, We were dispatched to 2643 W Atkinson Ave (Hot Spot Supermarket) for a drug dealing complaint.~~

Upon *our arrival* I observed Squad 5123 (PO Jeffrey KENNEDY and PO Nicholas KROPP) had a B/M later identified as GREEN, Edmond J (B/M 11-28-1979) in custody. Upon PO KROPP and PO KENNEDY'S arrival they observed several subjects exit the store. None of these subjects closely matched the provided description.

The caller, JABBAR, Nael (414-914-3772) who is the owner of the Hot Spot supermarket. JABBAR stated to the TC that he witnessed a hand to hand drug exchange and the subject was still in the store. JABBAR described the subject as B/M 40s wearing a black jacket, gray hooded sweatshirt, white pants and his right arm was missing. The business was cooperative with this investigation.

Upon entering the store, PO KROPP immediately observed a subject with one arm, wearing white pants, and a dark vest over a hooded sweatshirt with a gray hood protruding from the top of the vest. PO KROPP instructed this subject to stop and he complied. PO KROPP then conducted a frisk for weapons, after asking the subject if he had a firearm on him. He indicated he did not. During the frisk for weapons PO KROPP felt a small spongy item in the subject's left front pants pocket. Based upon PO KROPP'S training and prior experience, PO KROPP believed this to be a bag of marijuana. When the frisk had been completed, PO KROPP did not locate any item he believed was a weapon, PO KROPP asked the subject about the item in his pocket. He stated, "I don't have anything on me." PO KROPP asked what was in his pocket, and he replied, "Nothing but some money, some cigarettes, and a little bag of weed, sir". The subject then removed, a bag of suspected marijuana from his pocket and handed it to PO KROPP.

During the investigation, PO KROPP received additional information from store personnel that the subject who was armed with the gun when the call was made, had the gun hidden near the kitchen door by the meat counter in the back of the store. PO KROPP checked this area for a firearm and located a black semi-automatic firearm, with the grip pointing up, between jars of salsa in a storage area near the door to the kitchen. PO KROPP walked back to the front of the store and placed GREEN into handcuffs by securing his left arm to a beltloop on the right side of his body such that his arm was handcuffed behind his back. PO Kennedy remained with GREEN and conducted a search incident to arrest.

During the search of GREEN, PO Kennedy located a small silver pill container, which contained ten (10)

small corner-cut bags containing suspected crack cocaine. GREEN also had in his possession, two touchscreen cellular phones. Based upon amount of suspected cocaine, the nature of the packaging, and the possession of multiple cellular phones, in addition to the call describing the subject as having conducted hand-to-hand drug transactions in the store, it is reasonable to conclude the cocaine was possessed by GREEN with the intent to re-sell. The presence of a firearm, is further indicative of a suspected drug dealer protecting himself from violence or attempts by other subjects to rob him of his drugs or sales proceeds.

PO KROPP reviewed video surveillance footage. The video was recovered and *inventoried/uploaded to AXON*

While on scene, PO KROPP observed the licenses posted and they were up to date. During my investigation for drug dealing I did not observe any violations in the licensed premise.

On Monday, March 6th, 2023, at approximately 3:36PM, squads were dispatched to a Hold Up Alarm turned Shooting complaint, located at The Hot Spot corner store located at 2643 W Atkinson Ave, located within the City and County of Milwaukee.

This location is a Licensed Premise which currently holds active licenses for Cigarette/Tabacco, Class A Mart & Class A Liquor License, Food Retailer, and Weights and Measures. All four licenses expire on 7/20/2023. The licensing agent for this premises is Nael N JABBAR (W/M, 7/27/1978). JABBAR was not on scene when this incident occurred.

Upon our arrival, officers located the suspect, Terrill G JACKSON (B/M, 3/17/1984), lying in front of the pay counter of the store, suffering from multiple gunshot wounds (1 GSW to each thigh, 1 GSW to lower flank, 1 GSW to upper left chest) and being held at rifle point by the store security guard, Deroyce M CARTER (B/M, 2/16/1987). Officers tended to JACKSON, where MFD ENG# 36 and MED# 5 arrived on scene moments later after the scene was safe, taking over critical care.

While investigating, it was discovered that JACKSON was acting agitated and being boisterous inside of the store arguing with CARTER, when JACKSON was asked to leave the location and walked to the entry/exit door by CARTER and asked to "stay out." Upon reaching the front doorway of the store, JACKSON showed CARTER a black in color handgun with an extended magazine, when CARTER then stated, "Now you're really not coming in man, no guns allowed. Have a good day." W1 then shut the entry door of the store and walked up the small staircase into the security office. JACKSON became even more belligerent, causing a very brief scene screaming outside of the store on the front sidewalk for approximately 10 seconds. After screaming outside of the store for approximately 10 seconds, JACKSON re-entered the store with his pistol drawn, quickly walking into the store while visually searching the store as if he was looking for someone. JACKSON proceeded to the rear section of the store by the beer coolers, where JACKSON confronted a customer in an agitated manner. This customer then asked JACKSON, "What's good? Who are you looking for?" JACKSON then indicated to the customer that he was looking for him. JACKSON then fired 2 shots at the customer from approximately 6-8' away, missing the customer. The customer then drew his pistol and fired 2 shots towards

JACKSON. The customer then fled the store on foot.

Upon hearing the gunfire and witnessing the customers running around the store attempting to find cover, CARTER and the store clerk, Xavier R IRIZARRY (W/M, 2/9/1999) drew their pistols and began engaging JACKSON as he continued to fire rounds off at numerous customers inside of the store, making an elderly woman faint and temporarily lose consciousness during the incident. IRIZARRY and a customer hit JACKSON numerous times, bringing the shooting to an end, where JACKSON quickly surrendered to the customers and staff after being struck by gunfire multiple times. CARTER confiscated JACKSON's pistol and safeguarded it and held JACKSON at rifle point until police arrived on scene. JACKSON was subsequently taken into custody.

JACKSON is suspected to survive and make a full recovery. Two pistols and an AR-15 style rifle were recovered and taken as evidence.

The store manager, Raed F IRIZARRY (W/M, 9/3/1971), was also on scene. The licensed premise employees on scene were cooperative with police and the investigation. Surveillance footage of this incident was recovered and inventoried as evidence.
