## Interview of JEFFREY J. PETERSEN

Upon arrival I observed the victim, JEFFREY J. PETERSEN, W/M, 06-28-1991, who is an off-duty Libertyville IL Police Officer, in the parking lot behind 332 West State Street. PETERSEN took me over to his 2015 Subaru Outback, IL plate AB18772, which was parked at the northeast corner of the surface parking lot. I observed the auto was facing east and the passenger side front door window was broken out.

PETERSEN stated that he last observed his auto undamaged was on Saturday, October 15th, 2022, at 10:00 AM. PETERSEN stated that he discovered the entry to his auto on Sunday, October 16th, 2022, at 8:30 AM. PETERSEN stated that he discovered missing from the front passenger seat a green 511 shoulder bag containing a first aid kit and his Illinois Lake County Major Crash Assistance Team Investigator badge.

PETERSEN stated that he did not give anyone permission to damage and enter his auto. PETERSEN stated that he did not give anyone permission to remove property from his auto. PETERSEN stated that he is willing to prosecute.

The licensed premise is a parking lot managed by Interstate Parking with no onscene employees.

## Follow-up

I observed that the parking lot attendant building on the west side of the lot has exterior cameras. On Thursday, October 20th, 2022, at 8:55 AM, I emailed Interstate Parking on info@interstateparking.com regarding the entry to PETERSEN'S auto and requested a check of the video.

I observed that West State Street and North Vel R. Phillips has pole cameras at the intersection. I checked with the Milwaukee Police Department Fusion Division and P.O. RONALD HANDELAND checked the cameras and found that the northeast corner of the lot was not viewable due to the distance.

I observed that the parking lot attendant building on the west side of the lot has exterior cameras. On Thursday, October 20th, 2022, at 8:55 AM, I emailed Interstate Parking on info@interstateparking.com regarding the entry to PETERSEN'S auto and requested a check of the video.

I called for a Community Service Officer and Unit 1194, CSO ANGLEO KING responded to the scene and CSO KING checked for latent prints and took photos.

Teletype MWP1-0026 was sent on Sunday, October 26th, 2022, at 11:29 AM regarding PETERSEN'S property.

Investigation remains pending.

While on scene, I did not observe posted license for the parking lot. I did not observe any violations on the parking lot.

This report was typed by P.O. Jordan Emmons, assigned to District One, Day Shift.

On Thursday, February 9th, 2023, at 11:31AM, while assigned to squad 1164, I conducted a routine license premise check of a surface parking lot located at 332 W. State St. A Parking Lot or Place License (#PL 10076-73) issued 10/13/2022 and expires 09/12/2023. The Registered Agent is Erica E. VAILLANCOURT (W/F 11/25/1980) with Interstate Parking.

The location is a surface parking lot located across N. Vel R. Phillips Av. from the Fiserv Forum and the UW-Milwaukee Panther Arena. The location is also located in the area of multiple taverns and restaurants located on N. Doctor M.L.K. Dr. (formerly Old World Third St.).

The parking lot's perimeter is open and currently has concrete parking blocks separating the edge of the parking lot from surrounding sidewalks and streets. Vehicle entrances/exits are located at the southeast corner and northwest corner of the parking lot. The vehicle entrances/exits are unsecure and allows vehicles to enter and exit 24/7, and self-pay for their parking at one of two kiosks. The kiosks are located by an empty guard shack at the northwest corner of the lot. Three surveillance cameras are affixed to the guard shack. A Milwaukee Police Department Pole camera is located at the intersection of W. State St. and N. Vel R. Phillips Av. Lighting of the parking lot includes multiple harp style lights on a building the runs along the north perimeter of the lot, and a light pole located on the southwest and northwest corner of the lot.

Within the past year, Interstate Parking has been open to any suggestions from MPD on improving security at their parking lots. Interstate Parking has been taking the initiative in making their lots safer, adding new cameras and lighting to certain parking lots in the City of Milwaukee.

I emailed VAILLANCOURT to make her aware of my license premise check of this location. I advised VAILLANCOURT of some tips that could improve security at this parking lot, and that is to advise District One Police how we can retrieve surveillance footage from the parking lot. Interstate has roaming patrol from parking lot to parking lot, although advised staffing the parking lot with a human being that is stationary, possibly re-utilizing the guard shack on site could also help secure the parking lot. I asked if they could re-evaluate their barriers between the parking lot edges and sidewalks that surround the lot and consider something additional to concrete parking blocks.

VAILLANCOURT responded stating they provide staffing to this lot during events. They also provide

directed patrol security services 7 days a week and can evaluate the schedule and frequency of these services. VAILLANCOURT stated they can add a barrier on the western edge of the lot between the guard shack and the parking spaces. VAILLANCOURT stated they have tried this before and it kept getting knocked down but can work on something more permanent.

## Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
  - a. Include only information relating to the above license application.
  - b. Include only information you have personally witnessed or seen.
  - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
  - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.
