If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. For Mr. B's, concerns are with public safety late at night with unruly patrons, parking issues (packing up entire parking lot not leaving room impacting other adjacent business parking on the strip), traffic flow upon closing, and impacting other businesses wanting to come into the mall strip to open up similar venues (banquet halls, assembly halls) where the belief is that these public safety issues will be exacerbated with multiple venues with crowds operating at the same time.

Bellagio – same issues with night clubs – unruly patrons, dangerous incidents, deviation from business plan of a restaurant into a club or entertainment venue, adult entertainment/stripping events, to name a few.

No specific events mentioned – just general concerns expressed by the GAC.

This report is written by Police Officer Penny Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 10/26/22 at 11:29a.m., a citizen walked into the District to file a report regarding Strangulation Domestic Violence incident that took place at 8617 W. Brown Deer Rd. Investigation revealed two patrons who share children, were at the bar the previous night and one subject became jealous and began to choke the other until security intervened. The walk-in victim refused photos and a call to the Domestic Violence Hotline.
- 2. On 10/31/22 at 8:44p.m., Milwaukee Police were dispatched to an investigation at 8617 W. Brown Deer Rd. Investigation revealed an employee or part owner of the club had been receiving threats from a known subject via text and phone call. This would occur throughout the day and did not have any thing to do with the club.
- 3. On 11/13/22 at 2:43a.m., Milwaukee Police were dispatched to a fight at 8617 W. Brown Deer Rd. On arrival officers observed chair legs and broken glass, as well as tables moved away from where they normally were. Security stated they were able to move the crowd and break up the fight. Security was cooperative with the investigation and allowed officers to view video surveillance.

- 4. On 04/12/23 at 1:18a.m., Milwaukee Police were dispatched to a Trouble with Subject at 8617 W. Brown Deer Rd. Investigation revealed two parties were involved in a verbal altercation inside the premise. In an attempt to diffuse the situation, security escorted one of the parties outside, at which time a subject retrieved a firearm from their vehicle, however, did not point it at any one or the business. The subject's friend disarmed the subject and they all left the scene with no further incident. Security and the manager were cooperative with the investigation and did call for police to prevent the incident from escalating.
- 5. On 04/22/23 at 1:45a.m., Milwaukee Police were dispatched to a Sick and Injured at 8617 W. Brown Deer Rd. Investigation revealed an intoxicated patron vomited inside the premise and was asked to leave. On police arrival the subject was located and refused and medical or police assistance. The security was cooperative and allowed officers to view video surveillance of the incident.

On Saturday, October 29, 2022, at 11:29 AM, Barbara J SMITH (B/F 06/17/88) walked in to report a Strangulation Domestic Violence incident.

SMITH stated she was at B's Lounge at 8617 W Brown Deer Rd and at 1:30 AM on 10/29/22 her exboyfriend and father of her children, Lowers BATES (B/M 04/15/88), choked her by placing both hands around her neck and squeezing, impeding her breathing.

SMITH stated she did not know BATES was at the bar and did not see him while she was there. SMITH stated later in the night at 1:30 AM BATES approached her and began to yell at her. SMITH stated BATES was yelling about her talking to other men and saying he was going to kill her. SMITH stated a friend that was with her tried to talk to BATES. SMITH stated BATES then grabbed her by the neck and started to

SMITH stated she did not want me to take photographs and did not consent for me to give her information to the Domestic Violence hotline.

NATURE OF CALL/ JUSTIFICATION

On Monday, October 31, 2022, at approximately 8:44 pm, I was dispatched to 8617 W Brown Deer Rd for an Investigation assignment. The complainant of this assignment requested to speak to an officer regarding threats that he received via text messages and also over the telephone.

INVESTIGATION

Upon arrival at the mentioned address, I entered the establishment which is the Mr B's Nightclub. Once inside of the business, I met with the victim Jeffery S. BOWLIN (W/M 03/16/1960) in the restaurant section of the building. BOWLIN and I were the only two individuals inside of the restaurant portion of the building during this investigation.

BOWLIN stated that he wanted to report that he has received threats on his life from an individual that is an acquaintance. BOWLIN stated that he received the threats from the suspect who he identified as Kwan J. WILSON (B/M 12/11/1985). BOWLIN stated that he first received the threats on the morning of Sunday, October 30, 2022, when he woke up. BOWLIN stated that when he woke up from his sleep, he picked up his cellphone and observed that he received 43 missed telephone calls from an unknown number being 414-412-9369. BOWLIN went on to stated that he had notifications displayed on his phone for unread text messages.

BOWLIN stated that when he opened the text messages they were sent from the same number of the missed calls. BOWLIN stated that he read the text messages and realized that the messages and calls were sent by WILSON. BOWLIN stated that before he could read any of the messages, he received a telephone call from the mentioned number in which he answered. BOWLIN stated that when he answered the call WILSON began yelling out profanities towards him and stated,

"So your bitch ass finally answered huh, I am going to kill you!".

BOWLING stated that he attempted to speak with WILSON as to why was he so upset and angry with him while on the phone. BOWLIN stated that WILSON refused to hold a civil conversation with him and only continued to make threats to kill him and yell out profanities. BOLWIN stated that WILSON ended the call abruptly after telling BOWLIN one last time that he was going to die.

BOWLIN stated that he has known WILSON for years and the two of them never had any issues in the past. BOWLIN stated that recently WILSON was made aware that BOWLIN was friends with an aunt of WILSON. BOWLIN stated that for some unknown reason, the fact that BOWLIN was friends with WILSON's aunt sent him into a rage. BOWLIN stated that he regularly sees WILSON at nightclubs around the city and they never had an altercation.

BOWLIN allowed me to view the text messages that was sent to his cellphone and was dated October 30, 2022. IN the text messages WILSON stated the BOLWIN "You a bitch ass nigga who go get dealt with" and "I'm not a snake so I'm not go blind side you I'm go put it up close in yo face". WILSON went on to stated that "You go die about that shit, I dont give a fuck who knows".

BOWLIN stated that WILSON reached out to mutual associates of his and informed them to stay away from BOWLIN because he was going to kill him. BOWLIN stated that WILSON also threatened to kill one of his sons who is an employee at the mentioned business.

BOWLIN stated that he is a part owner of Mr. B's Nightclub and is there each night that the business is open. BOWLIN stated that he was aware of WILSON's violent past, and that WILSON has access to firearms. BOWLIN stated that WILSON is a known gang member that hangs around the BURLEIGH ZOO gang. BOWLIN would not reveal the name of WILSON's aunt and asked that she not be put further in this investigation. BOWLIN stated that because of WILSON's violent history he wanted to have a report of this incident on file with the police.

BOWLIN stated that WILSON has been banned from entering the establishment due to his threatening behavior.

NATURE OF CALL/JUSTIFICATION

On Sunday, November 13, 2022, at approximately 2:43am, my partner and I were dispatched to a large number of people fighting at this location.

INVESTIGATION

Upon arrival at the mentioned location, I observed security and the employees cleaning up the interior of the location. I observed tables and chairs moved away from where they normally sat on the main dance floor area. I observed chair legs broken and glass from bottles and or drinking glasses on the floor. This scene appeared to be consistent with people fighting.

Security stated they were able to move through the crowd at the location and break up the fight. Security and the employees were able to push the unknown individuals outside of the location. None of the subjects that fought were on scene upon police arrival.

-Mr. B's is cooperative with police investigations and encourages police presence. Mr. B's has multiple camera angles and surveillance that work and will be available for review.

On Wednesday, April 12, 2023, PO ENK and PO CAPPELLE responded to a Trouble with Subject complaint located at 8617 W Brown Deer Rd which is the Mr B's Lounge. This address is located in both the City and County of Milwaukee, WI.

INVESTIGATION

On the mentioned day, Mr B's Lounge was open for business and held their weekly Taco Tuesday's event. While the event carried on, two groups of male began verbally arguing inside of the establishment which prompted a security response. As the security guards attempted to defuse the situation, the two groups of males began pushing and shoving each other and were asked to leave the premises. The security guards followed their procedures when two groups are involved in an altercation by having one group leave prior to having the second party leave the building to prevent further altercations on the exterior of the building. Despite the security precautions, both groups exited the building at the same time where the argument continued in the parking lot area.

While in the parking lot, a male from one of the groups went to a vehicle and produced a firearm. Upon seeing the firearm, the security guards locked the main entrance doors and notified the manager Craig L BERRY of the situation. Individuals who were with the male that produced the firearm quickly disarmed him and put him inside the vehicle that quickly departed from the scene without further incident. The male that produced the firearm never pointed the weapon at anyone nor the business during this incident. BERRY call for a police response to ensure that the individuals that were involved in the incident were no longer on scene to provide safety for the remaining patrons inside the building.

PO ENK and PO CAPELLE arrived on scene and did not observe any remaining altercations. Upon speaking with the security staff, it was relayed that the two parties went their separate way with further incident. PO ENK made contact with BERRY inside of the business and informed him that the issue was resolved


