There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 11/28/2019 the applicant was cited in the City of Milwaukee at 5007 W. Center St for Licensed Establishment-Exceeding Occupy Limit.

2. On 01/23/2020 the applicant was cited in the City of Milwaukee at 5007 W. Center St for Licensed Establishment-Exceeding Occupy Limit.

3. On 08/29/20 at 1:11am, Milwaukee Police were dispatched to 7225 N. 76<sup>th</sup> Street for an entry to auto complaint. Investigation revealed that four vehicles were broken into and two firearms were taken. The incident occurred in the western part of the parking lot and there were no surveillance cameras, which would have captured the incident.
4. On 12/20/20 at 8:00pm, Milwaukee Police were dispatched to 7225 N. 76<sup>th</sup> Street for a trouble with subject complaint. Upon arrival, officers interviewed the applicant who stated that his staff had an altercation with a group of females who were attempting to engage in fights. The females left the scene before police arrival and a walk through of the tavern was conducted with no violation observed.
5. On 12/27/20 at 8:49pm, Milwaukee Police conducted a license premise check at 7225 N. 76<sup>th</sup> Street. Officers interviewed the applicant who said that he had no issues tonight, expressed gratitude for police presence, and encourages it.
6. On 05/02/21 at 6:43pm, Milwaukee Police were dispatched to 7225 N. 76<sup>th</sup> Street for a subject with gun complaint. Investigation revealed that security at the location were armed and that there was a large event taking place causing security to walk around the outside of the establishment. Security was cooperative with police and were considered to be doing a reasonable job.

7. On 06/21/21 a subject walked into the Seventh District to report a fight which occurred on 06/20/21 at 7225 N. 76<sup>th</sup> Street. The subject reported that a large fight erupted inside the tavern at 8:00pm and the police were never called. She had a video of the fight which was posted on Facebook. The following day, a District Four officer took a substantial battery complaint from that incident. Also, during the incident, several purses were found to be missing.
  8. On 07/04/21 at 9:21pm, Milwaukee Police conducted follow-up at 7225 N. 76<sup>th</sup> Street regarding the incident described in Item #7. Officers interviewed the applicant who stated that he was aware of the fight and said security broke up the two groups and someone called 911 for the injured female. The applicant told officers that medical staff arrived to treat the female and that he was unaware of the missing property. In the video of the incident, there was a subject seen with a firearm. The applicant identified the subject as an employee and said that he was no longer employed with the business. He also said that he has hired a new event staff, implemented a dress code, everyone (including employees) are checked for weapons before entering the establishment, and purchased a high-tech identification scanner.
  9. On 09/26/21 at 8:55pm, Milwaukee Police were dispatched to 7225 N. 76<sup>th</sup> Street for a shooting complaint. Investigation revealed that security kicked out a group of subjects and when they were outside, one of them retrieved a handgun and started shooting at the establishment. The group then entered their vehicles and started shooting at the building as they drove off. The actors performed two U-turns and shot at the tavern each time they passed. One person was shot during this incident. Officers were informed that the applicant was telling staff not to speak with officers and that security was seen leaving through the back door in order to avoid making a statement to police. The applicant did download the ID scanner information for officers. 37 casings were recovered from the scene.

10. On 12/13/21 at 1:30am, Milwaukee Police were dispatched to 7225 N. 76<sup>th</sup> Street for a theft complaint. Officers were met by the applicant who stated that the caller of the theft said security took her purse and he insisted that they did not. Investigation revealed that the caller took a pair of glasses she gifted to her x-boyfriend, who was security, and that security took her purse which contained the glasses. Police found the purse inside the business next to security and returned the glasses.
11. On 03/23/22 at 8:29pm, Milwaukee Police were dispatched to 7225 N. 76<sup>th</sup> Street for a "RES" compliant. Investigation revealed that a married couple were in an argument inside the parking lot of that location and one of the parties rammed their vehicle into the others causing them to fear for their safety.

12. On 07/31/22 at 9:30p.m., Milwaukee Police were conducting a license premise check at 7225 N. 76<sup>th</sup> St., when they were advised by an employee their vehicle had been broken into. The employee stated their purse along with a firearm were stolen. The establishment did not have surveillance cameras outside and there were no witnesses to the incident.
13. On 12/21/22 at 7:08p.m., Milwaukee Police conducted follow up regarding a walk-in Theft complaint that was received on 04/14/2022. The employee stated on 04/09/22 at approximately 8:30p.m., their cell phone had been stolen from behind the bar at 7225 N. 76<sup>th</sup> St. During the follow up it was determined the security cameras do not face the bar area.
14. On 01/29/23 at 8:42p.m., Milwaukee Police conducted a License Premise Check at 7225 N. 76<sup>th</sup> St. No violations were found.
15. On 02/02/23 at 8:05p.m., Milwaukee Police conducted a License Premise Check at 7225 N. 76<sup>th</sup> St. No violations were found.
16. On 02/16/23 at 1:11a.m., Milwaukee Police conducted an Investigation at 7225 N. 76<sup>th</sup> St. Investigation revealed a patron, who was drunk and disorderly, punched a window to the business, causing damage. Officers were later dispatched to a local hospital for a Sick and Injured related to the same incident. The agent did not want to prosecute for the damage and was cooperative with the incident.
17. On 03/27/23 at 1:34a.m., Milwaukee Police were dispatched to a Shooting at 7225 N. 76<sup>th</sup> St. Investigation revealed several patrons entered their vehicle and were exiting the parking lot, when a suspect vehicle started firing shots at the vehicle and the building. A security guard that was preparing the lot for bar close was shot, at which time another security guard exited the building and discharged their firearm at the suspect vehicle, when they also were shot. The occupants of the victim vehicle were all shot and drove themselves to the hospital for treatment. The officers located 15 casings in the parking lot; an unspent casing near the entrance, and one bullet fragment inside the establishment. A subject who identified themselves as "head of security" became uncooperative during the investigation and was cited for their actions.

18. On 04/02/23 at 9:20p.m., Milwaukee Police conducted a License Premise Check at 7225 N. 76<sup>th</sup> St. Officers observed a low capacity crowd and 3 security officers on scene. The agent was on scene and stated they would be closing for the evening as business had been slow since the previous incident. The agent stated their security staff is unarmed and does utilize a metal detector. The agent stated they did provide video surveillance to Milwaukee Police for the previous incident. The agent was advised to request extra patrol if needed.
19. On 04/06/23, Milwaukee Police held a meeting with the agent of 7225 N. 76<sup>th</sup> St., regarding the shooting that occurred on 03/27/23. The Captain of the District was present as well as other entities relevant to the license and operations. The agent stated they have six interior cameras, one of which is operational at the front door, and no operational exterior cameras. The agent stated they are currently in the process of making sure all interior cameras, as well as four exterior cameras are in working order. The agent stated they hire private security and have a minimum of four security officers on scene and call in more, if they are needed. A Milwaukee Police Sergeant that was at the scene of the shooting discussed that security were less than cooperative during the incident and also were not identifiable due to not being dressed in proper attire. Multiple security measures were provided to the agent to avoid any further incident.

2022, I, assigned to Squad 4467, conducted a "Business Check" at 7225 N. 76th St. which is Prime Social Bar and Restaurant. This is located in the City and County of Milwaukee.

As I patrolled the parking lot of this location, Marangely HERNANDEZ (h/f, 03-23-92) stated someone broke into her vehicle while she was working. I located HERNANDEZ' vehicle parked to the south side of the business where the employees are designated to park broken into. The point of entry was through the drivers side window. HERNANDEZ owns a 2011 gray Infinity G37S, WI Auto Plate 527-WAS. This vehicle lists to HERNANDEZ but she does not have insurance.

HERNANDEZ stated she is missing her blue purse worth \$30, miscellaneous cards, WI DL and her purple 9mm Ruger firearm. On Monday, March 27, 2023, at approximately 1:34 am, Multiple Milwaukee Police Officers responded to a SHOOTING complaint at the address of 7225 N 76th St (Prime Social Restaurant and Bar). This address is located in both the City and County of Milwaukee, WI. Multiple callers of this complaint stated that multiple shots were fired outside of the club and two people were shot inside of the club.

### **INVESTIGATION**

On the mentioned date, Prime Social was open and operating at a business capacity with multiple patrons inside of the location. As three patrons exited the building and walked to a gray Dodge Charger. As the three males entered the vehicle and proceeded to exit the parking lot, security guard Deundre O. Pigott walked out of the main entrance door to prepare the lot for let out. PIGOTT stated that he observed a white vehicle drive northbound on N 76th St and make a u-turn at W Clinton Ave and proceeded back south on N 76th St. PIGOTT stated that that he observed the white vehicle fire shots towards the building and also the gray Charger. PIGOTT was struck in both of his lower legs and was assisted into the building. Security guard Tajidden R. THOMAS exited the main entrance door to assist PIGOTT and discharged his firearm at a vehicle that he observed discharging a firearm in his direction. THOMAS sustained a gunshot wound below the left armpit area and was assisted back inside of the building.

The three occupants of the dodge Charger drove themselves to Froedtert Hospital to receive treatment for multiple gunshots to each victim and were expected to survive their injuries.

Officers located 15 casings in the parking lot of the location. Officers also located an unspent cartridge near the front door of the location and a bullet fragment inside the location. The building was struck by gunfire.

PO GOHMANN who was on the exterior of the building and in the parking-maintained crowd control during the investigation. While conducting crowd control PO GOHMANN had male, Joshua E ALDRIDGE (M/B 01/07/99), who identified himself as the "head of security" act in a disorderly manner and attempted to obstruct the investigation. ALDRIDGE was issued a citation regarding his actions.

Present for the meeting was District Four's Captain Schlei, PO Tracey Geniesse, Sgt. Sean Mahnke, Esmerelda Cruz from Safe and Sound, Sgt. Guadalupe Velasquez, Sgt. Adam Grochowski, Agent Ashley Schnering (DOR), ADA Joy Hammond and Odean Taylor (Owner of Prime Social)

Introductions were conducted and Captain Schlei explained why we were having the meeting. He advised Taylor that the Police are a resource for him and his business. Taylor stated he has owned the building for five years and it's operational for four years. He stated he is considering doing a rebuild and doing development at this location. His capacity is currently set for 375 and his licenses and permits are current and valid until August of 2023.

Security operations that are currently in place are as follows, has six interior cameras of which one is operational at the front door of the location and no working cameras on the exterior that are in working order. He is currently in the process of having all six cameras in working order along with four exterior on each corner of the building. The entrance has a metal detector, ID scanner with a counter, that is manually reset daily, wand and physical pat downs, which all security measures are conducted on everyone that enters his establishment. Taylor stated his lighting is good and the property is well lit during the hours of darkness. During outdoor events, he will rent additional lighting for the area. Taylor stated his business is open for business Wednesday from 5p-12a, Thursday 5p-12a, Friday 5p-2a, Saturday 5p-2a and Sunday 12p-9p. Due to being a restaurant after 9pm is considered "Adult time". After 9pm, the age is 21 and older and he is not interested in changing the age limit to his establishment. He stated it doesn't matter because even the older ages cause problems at businesses as well. Taylor stated he has a minimum of four security guards at Prime Social, it all depends on the event or the amount of people who attend Prime. He stated he will call in other guards if they are needed. He does not have a contracted business but hires private security personnel. He stated only one of his guards is a CCW holder and carries a firearm, the others are all unarmed. Some of his methods that are currently in place for his guards are using a training manual that he personally goes over with the guards and does a background check (CCAP) on each one that he hires, and he also stated he does hire felons. Taylor did express that he is interested in hiring off duty officers for his establishment.

Sgt. Grochowski stated, when he was at the scene of the shooting, it did not appear that his security team was willing to work with the Police and were not cooperative during the investigation as well as not dressed in the proper attire to be identifiable to Law Enforcement.

Below are the following recommendations provided by MPD, provide a current list of Security personnel to District four, whether they are hired privately or contracted, create and provide MPD with their crisis plan, have a pre-shift meeting with security personnel with the expectations of the business, send a monthly calendar of events to District Four CLO's / Tavern car. Have one identifiable uniform for his security team. We requested to conduct a walkthrough of the establishment once all security measures are in place.


