If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 10/27/2021 at 9:21pm officers were dispatched to a Child Neglect at Chuck E. Cheese, 2701 S Chase Av. The officers interviewed the manager who stated he was closing the restaurant and he located a 2-3 year old child without any parents. While on scene the officers were advised a female was called and stated she was at Chuck E. Chees and could not locate he child. The parent was reunited with her child. The manager stated they use a hand stamp system to make sure the child leaves the restaurant with the right parent but they have no way of knowing how many children a parent should leave with.

2. On 01/14/23 at 6:20p.m., Milwaukee Police were dispatched to a Subject with Weapon at 2701 S. Chase Av. Investigation revealed a fight broke out among customers and one of the subjects involved dispersed pepper spray. Security was on scene and broke up the fight prior to police arrival and all the subjects were gone. Security did not use any pepper spray or force during the incident. The agent arrived on scene and chose to close the business for the evening due to the incident. The agent and all employees were cooperative with police.
3. On 02/14/23 at 11: 39p.m, Milwaukee Police were dispatched to a Fight at 2701 S. Chase Av. Investigation revealed a fight broke out between patrons and security struck two individuals with a baton and pepper sprayed another. The subject that was sprayed remained on scene

and stated it was unprovoked, however, security stated it was self-defense. No employees were able to provide video surveillance of the incident.

INITIAL INVESTIGATION

This report is written by PO Joseph ZINGSHEIM, assigned to District 6, Early Power Shift. On Saturday, 01-4-23 at 6:20 PM I (SQD 6225) responded to Chuck E Cheese, 2701 S Chase Ave, for a Subject W/ Weapon. SGT Brian LAROQUE (SQD 6211), PO Nathan GRAP and PO Robert Lawrence (SQD 6269) also responded. I was in a marked squad (Vehicle 615) and equipped with a body worn camera.

There was a physical fight at the location between customers and at least one of the subjects involved in the fight used pepper spray (oleoresin capsicum) spray on other subjects involved in the fight. The subjects that had been fighting had not been identified. Armed security from Advanced Private Police LLC were on scene, broke-up the fight, and began dispersing those involved prior of the arrival of police. Security did not deploy any pepper spray or use any other force during this incident.

None of the Chuck E Cheese employees were directly sprayed with pepper spray during this incident however Manager Anthony Diaz and assistant managers Nancy HERNANDEZ and Donovan G. CUSHINERY were affected by exposure to it in the air. DIAZ, HERNANDEZ, and CUSHINERY were treated on-scene by Milwaukee Fire Department Engine 7 and Med 15; a Sick and Injured report was filed regarding.

The business Agent, Gianfranco ROJAS-PERALTA responded to the location due to this incident and chose to close the location for the evening due to this incident. ROJAS-PERALTA, DIAZ, and the rest of the staff were cooperative, and I did not observe any licensed premise violations.

Upon our arrival we spoke with Armed Security, Morgan PEVOONKA THOMPSON (W/F 04-20-81) who stated that a fight broke out between customers and while trying to break the fight up she struck two individuals with her baton and pepper sprayed one female. Subjects who were struck were no longer on scene and the female that was pepper sprayed stated it was unprovoked. PEVOONKA THOMPSON stated the incident was provoked and she was defending herself. No one on scene was able to provide me with video footage of this incident and I was instructed to contact their corporate office. Upon reaching out to corporate my calls and voicemails went unanswered.

The above application has been made by the above named applicant(s). This requires approval from the Licenses Committee and the Common Council of the City of Milwaukee. The hearing before the Licenses Committee will take place on 7/18/2023 at 1:10 PM in Room 301-B, Third Floor, City Hall. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at <http://city.milwaukee.gov/citychannel>. Those wishing to provide oral testimony via phone or internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.


