Dear Mr. Jabbar:

This is to notify you that on Thursday, July 13, 2023, the City's Licenses Committee voted to recommend to the City's Common Council renewal with a fifteen (15) day suspension of the Class A Malt & Class A Liquor license based upon the preponderance of the evidence in the police report that demonstrates the operation results in a threat to health, safety or welfare of the public; for the premises located at 2643 W Atkinson Av. ("I Shop Supermarket").

On July 21, 2023, you were mailed a true and correct copy of the findings of fact, conclusions of law, and recommendations of the Licenses Committee with respect to the Class A Malt & Class A Liquor license in which the Committee recommended renewal with a fifteen (15) day suspension of the Class A Malt & Class A Liquor license based upon the preponderance of the evidence in the police report that demonstrates the operation results in a threat to health, safety or welfare of the public. You were further notified that the Milwaukee Common Council would consider the matter at its meeting of Monday, July 31, 2023, commencing at 9:00 a.m. in the Common Council Chambers on the third floor of City Hall, 200 East Wells Street, Milwaukee, Wisconsin. You were advised of the right to file written objections and to appear personally or by counsel to address the Common Council. At that date, time, and place, you did not file written objections to the report of the Licenses Committee, you did not appear in person and you were not represented by a counsel.

Following consideration of the report of the Licenses Committee, the Common Council voted to renew with a fifteen (15) day suspension, the Class A Malt & Class A Liquor license based upon the preponderance of the evidence in the police report that demonstrates the operation results in a threat to health, safety or welfare of the public. Said suspension is effective between 12:01 a.m. on July 31, 2023 until midnight on August 14, 2023.


Dear Mr. Lucht:


