


Proposed 2024 Budget (Levy)







Currently, there are 7 vacancies in the department.


- One Legislative Fiscal Analyst Lead vacant since 05.2022. (Unfunded in 2023).

### **Staffing Update**





#### Revenue

- Departmental revenues are estimated at \$8,304,000, an increase of 3.8% from 2023.
- Charges for Services decrease by \$203,000 while fees for Licenses and Permits increase by \$511,000.
- Increased revenue is related to continued COVID recovery and hosting the RNC.
- Cable Franchise Fee remains a major source of revenue at \$3,351,000.

# **Special Purpose Accounts**

The proposed budget provides for a modest increase of \$18,000 in SPAs. Notable increases occur in the Audit Fund, (4.14%) and City Memberships, (4.6%).

The Proposed Budget allocates funding for the following SPAs:

Audit Fund \$302,000
Econ. Dev. Comm. Fund \$20,000
City Memberships \$125,000
MKE Comm. Excellence Fund \$50,000

#### **Grants**

The Department receives no grant funding.

#### **Capital Programs and Projects**

The proposed budget allocates funding for one capital project - \$95,000 for highdensity shelving in the City Records Center.

# **Special Funds**

The Special Funds account is proposed to be funded at \$645,333, which is an increase of 1,088%. The increase is due primarily to the inclusion of translation services in the administration's One Milwaukee Fund Program and the inclusion of funding for the City Clerk's Big Clean MKE initiative.

#### **MAJOR PROGRAMS**

• In 2023, the City Clerk's Office finalized its 3-decade process of reducing the resource footprint of Council files by implementing paperless processes for Common Council files and Statements of Economic Interest. In addition to reducing paper waste, this change has freed up staff time and allows for a more efficient means of fulfilling public record requests.

- The License Division is set to launch business functionality on the Accela LMS platform in early 2024, enabling residents to apply for licenses from anywhere and at any time.
- The City Records Center is finalizing an agreement to securely store certain police records boxes in the primary records vault. This will improve access to and security of critical police case files
- The Historic Preservation Commission guided a citywide study of 20th-century religious architecture. Funding from the Wisconsin Historical Society allowed for the first major study of architectural Modernism in Milwaukee, much of it built by and for the Black community.

#### **CHALLENGES IN 2024**

- Maintaining continuity of support to the Common Council and the Republican National Convention (RNC), especially in the period just prior to and during the convention.
- The Public Information Division will be tasked with assisting Council members and City departments in marketing Milwaukee to a global audience, both before and during the RNC.
- The City Channel has undertaken to showcase the RNC by providing gavel-to-gavel coverage of the daily activities occurring on the convention floor.
- The Historic Preservation Commission staff will begin special enforcement duties in 2024 to address historic preservation issues at residential and commercial properties.
- Working within the confines of the prohibitions imposed by 2023 Act 12.
