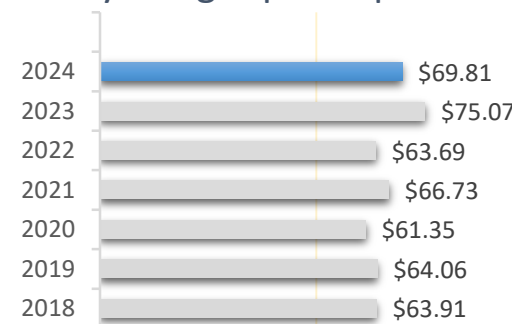
Requested 2024 Budget

Levy Budget per Capita



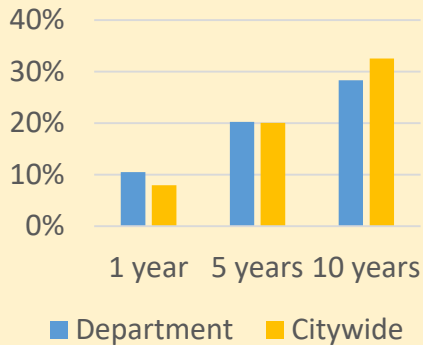

Staffing Vacancies

The department has 149 vacancies in 53 different titles, one less than last year. Six titles represent 40% of the vacancies:

1 - Street Repair Supervisor (Aux)

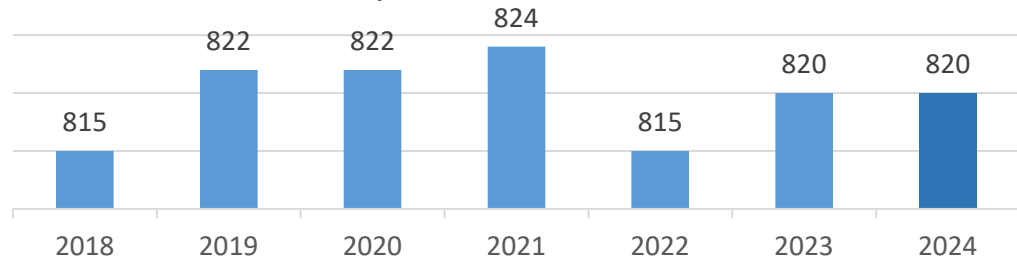
Eliminated Positions

Reclassified Positions

66 titles in the department were reclassified in DPW-ISD by Common Council files 230220 and 230454 to new paygrades and/or new titles. The reclassification was the primary contributor to the \$6.2 million increase in salaries from 2023.

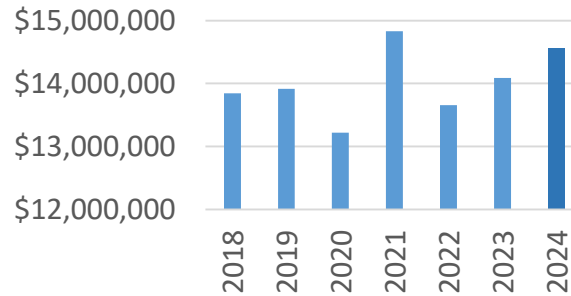

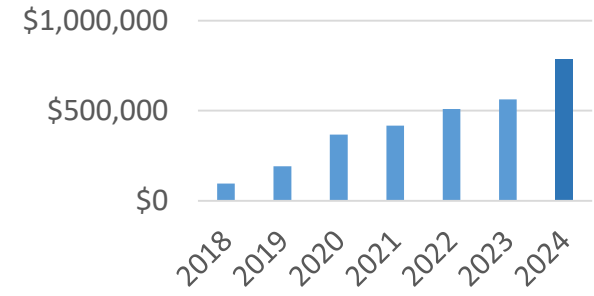

Contracting Challenges

Contractor shortages due to expanded federal infrastructure programs are expected to continue in 2024, resulting in higher bids. For some projects, there may be no acceptable bids. Long material lead times are expected to continue especially for traffic control items. Monotube traffic signal poles and signal cabinets take over a year to procure. Other items such as delineators are also difficult to obtain in a timely fashion.
