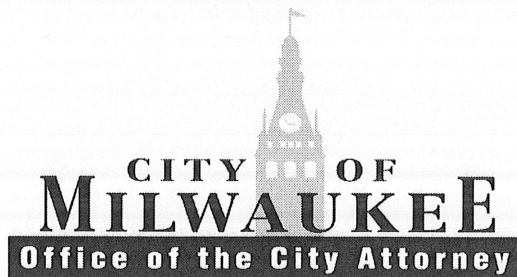

Dear Sir or Madam:

We have completed an investigation into this matter regarding damages sustained when a city tree fell on the property located at 3401 S. Delaware Avenue. Phillip Chavez and Mary Whalen own the property. Mr. Chavez and his insurer, Liberty Mutual Insurance submitted a damage claim in the amount of \$7,139.59, under the homeowners' policy. Ms. Whalen submitted an estimate for damages beyond insurance repairs for \$31,588.43.

Our investigation revealed that Forestry Services reported they responded to a call received in the call center on September 25, 2022, regarding a tree down at 3401 S. Delaware Avenue and a forestry crew responded. The subject tree was a green ash and appeared normal. The subject tree was removed from 3379 S. Delaware Avenue. Forestry reported there was no evidence of decay at the point of failure.

Further investigation revealed that the Forestry Section received 67 calls for broken branches and other storm related issues that day. Winds averaged 9.4 MPH with peak wind gusts to 35 MPH as recorded at General Mitchell.




Additional maintenance records reveal that on August 2, 2021, a contractor was hired to replace the sidewalk at 3379 S. Delaware Avenue to complete special provisions of arcing the walk and removing only the surface roots necessary to install a 5" concrete walk. Forestry further reported the removal of the surface roots at that time did not appear to affect the trees' stability.

It is our position that the City is not liable for damages and we recommend that the claims be denied.
