

EXECUTIVE SUMMARY



MKE Elevate: A <u>community-driven</u> plan to elevate our health, our community, and our future.

MKE Elevate is a plan to elevate the health of all Milwaukee residents. While countless individuals and programs work tirelessly to improve health outcomes citywide, this plan seeks to focus and align work to address priority issues selected by our community, for our community.

In 2022, the City of Milwaukee Health Department (MHD) was joined by Mayor Cavalier Johnson in launching a comprehensive, community-driven process to develop the MKE Elevate plan. The MHD provided leadership and oversight to the process, facilitating community input and participation.

The process began with the release of the City of Milwaukee Community Health Assessment (CHA), a report detailing over 40 data points across ten issue areas on the health status of Milwaukee residents as well as the conditions that impact these health outcomes. The CHA findings show that Milwaukee has higher-than-state-average rates of infant mortality, sexually transmitted diseases, cancer (breast, cervical, lung, and prostate), violence, teen pregnancy, childhood lead poisoning, and mortality due to unintentional injuries. These disparities stem from long-standing disadvantages and structural racism that have built upon and influence each other over time.

Using this data as a guide, the MHD sought feedback directly from community residents. Through an online and in-person survey, more than 2,000 people weighed in on what they viewed as Milwaukee's most pressing health issues. At the same time, a photo campaign asked residents to visually identify healthy and unhealthy aspects of city life and received nearly 100 submissions. CHA data and community survey results were shared at a series of four community meetings, where residents completed a prioritization activity. Resident input was combined with available data and potential evidence-based strategies to identify an overarching priority of **Racial and Health Equity** as well as 3 Priority Action Areas that not only address community-identified concerns, but also significantly influence safety and health:



Maternal and Safe and Supportive Child Health Communities

In early 2023, community members were then invited to join a steering committee and three action teams. MHD engaged community partners in a series of quarterly meetings, seeking to coordinate a response to the three community-identified priority areas for action. Meeting participants crossed sectors and silos to develop goals and objectives for action, as well as proposed strategies to support these objectives. The MKE Elevate Steering Committee came together to identify an updated vision and mission:

VISION

Environmen

A Milwaukee where all people are thriving in safe, healthy, and equitable neighborhoods.

MISSION

MKE Elevate supports a Milwaukee where all people are thriving in safe, healthy, and equitable neighborhoods free from oppression by aligning strategies and building power, partnerships, access to resources, and opportunities for collective advocacy in community-identified priority areas.

Using the community-developed goals, objectives, and strategies identified in this plan, MHD will continue to engage implementation partners to convene quarterly meetings, align efforts, and track results.

Together, we can improve the health of Milwaukee.



Elevar MKE: <u>Un plan impulsado por la</u> <u>comunidad</u> para elevar nuestra salud, nuestra comunidad y nuestro futuro

"Elevar MKE (MKE Elevate)" es un plan para elevar la salud de todos los residentes de Milwaukee. Mientras que muchas personas y programas trabajan incansablemente para mejorar los resultados de salud en toda la ciudad, este plan busca enfocar y alinear el trabajo para abordar los asuntos de prioridad seleccionados por nuestra comunidad, para nuestra comunidad.

En el 2022, el alcalde Cavalier Johnson se unió al Departamento de Salud de la Ciudad de Milwaukee (MHD, por sus siglas en inglés) para lanzar un proceso integral impulsado por la comunidad para desarrollar el plan "Elevar MKE". MHD proporcionó liderazgo y supervisión al proceso, facilitando la participación y la opinión de la comunidad.

El proceso se inició con la publicación de la Evaluación de Salud Comunitaria (CHA) de la Ciudad de Milwaukee, un informe que detalla más de 40 puntos de información a través de diez áreas en cuestión sobre el estado de salud de los residentes de Milwaukee, así como las condiciones que afectan estos resultados de salud. Los resultados de la CHA muestran que Milwaukee tiene tasas más altas que el promedio estatal en mortalidad infantil, enfermedades de transmisión sexual, cáncer (mama, cuello uterino, pulmón y próstata), violencia, embarazo en adolescentes, envenenamiento infantil por plomo y mortalidad por lesiones no intencionales. Estas disparidades se derivan de las desventajas que han persistido y el racismo estructural que se ha acumulado y la mutua interacción a través del tiempo.

Utilizando esta información como guía, MHD solicitó comentarios directamente de los residentes de la comunidad. A través de una encuesta en línea y en persona, más de 2,000 personas opinaron sobre lo que consideraban los problemas de salud con mayor urgencia de Milwaukee. Simultáneamente, una campaña fotográfica solicitó a los residentes identificar de manera visual los aspectos saludables y no saludables de la vida en la ciudad recibiendo casi 100 respuestas. Los datos de la evaluación CHA y los resultados de la encuesta comunitaria se compartieron en una serie de cuatro reuniones comunitarias donde los residentes completaron una actividad de prioridades. Las aportaciones de los residentes se combinaron con los datos disponibles y las posibles estrategias basadas en la evidencia para identificar una prioridad general del racismo y la equidad en la salud, así como tres áreas de acción prioritarias que no solo abordan las preocupaciones identificadas por la comunidad, sino que también influyen significativamente en la seguridad y la salud.

A principios del 2023, miembros de la comunidad fueron invitados a unirse al Comité Directivo de MKE y a tres equipos de acción. MHD involucró a los socios de la comunidad en una serie de reuniones trimestrales, buscando coordinar una respuesta para las tres áreas de acción prioritarias identificadas por la comunidad. Los participantes de la reunión cruzaron información para desarrollar metas y objetivos para la acción, y proponer estrategias para apoyar estos objetivos. El Comité Directivo de "Elevar MKE" se reunió para identificar una visión y misión actualizadas:

VISIÓN

Un Milwaukee donde todas las personas prosperan en vecindarios seguros, saludables y equitativos.

MISIÓN

Elevar MKE apoya un Milwaukee donde todas las personas prosperan en vecindarios seguros, saludables y equitativos libres de opresión al alinear estrategias y desarrollar poder, asociaciones, acceso a recursos y oportunidades para la defensa colectiva en áreas prioritarias identificadas por la comunidad.

Utilizando las metas, objetivos y estrategias desarrolladas por la comunidad y que han sido identificados en este plan, MHD continuará involucrando a los socios para su implementación convocándolos a reuniones trimestrales con la finalidad de alinear esfuerzos y rastrear resultados.
