## Good Morning Alderman Bauman

I noted there's a meeting with DPW this morning which include discussion regarding snow removal operation. I would like to take the time to express my disappointment with the snow removal operation in the recent snow storm. Please note my prior email which I listed my concern which include street being snow plowed, the 1100 block of 29<sup>th</sup> street not passable due to vehicles parked on both side of the street, individual not moving vehicle in 24 hour period and snowed in creating greater issues. Also individuals just leaving there vehicle parked in the street. One incident was on Saturday, January 20, 2024. I left home around 9pm and noted vehicle in front of 2902 W Juneau Ave parked perpendicular to the parking spot. A number vehicles have gotten stuck here. I contacted parking enforcement (C2402879) because there was no one in the vehicle and it appeared abandon. At 6:00am the vehicle was still in the same spot blocking the roadway. I contacted the police who showed up and had the vehicle towed.




