- - The Milwaukee Police Department participates in the Milwaukee Metropolitan Drug Enforcement Group, a multi-jurisdictional task force including the Milwaukee County District Attorney's Office, and South Milwaukee and West Allis Police Departments. The grant funds a portion of salary/fringe benefits for one Sergeant and two Police Officers assigned to the MMEDG task force to reduce controlled substances in the metro area through targeted interruption of large-scale drug trafficking.
- Relationship to City-Wide Strategic Goals and Departmental Objectives: 2.
  - The Milwaukee Metropolitan Drug Enforcement Group grant aligns with the goal to reduce crime and enhance quality of life by reducing the volume of controlled substances in the Milwaukee area. Task force officers target large-scale drug trafficking to interrupt distribution of cocaine, heroin, fentanyl, and other drugs, all of which significantly increases violent crime and overdose deaths.
- Need for Grant Funds and Impact on Other Departmental Operations (Applies only to Programs): 3.
  - The grant amount of \$180,264 (35%) will fund a portion of salary/fringe benefits for one Sergeant and two Police Officers assigned to the Milwaukee Metropolitan Drug Enforcement Group Task Force. The Department will fund the salary/fringe benefits balance of \$328,372 (65%) for these positions. Position authority will expire 12/31/2024 unless the MMDEG grant is extended.
