5. On 10/09/23 at 6:22p.m., Milwaukee Police were dispatched to a Shooting at 200 E Center. Investigation revealed a suspect entered the store and attempted to purchase a tobacco product, however, the cashier refused the sale, without an ID. An argument ensued between the cashier and the suspect and the cashier called for the victim (agent's spouse) to come to the store. The victim and the suspect begin to argue and point firearms at each other. Eventually the suspect agrees to leave and the victim followed the suspect out of the store, out of camera view, however, returned with a gun shot wound to the shoulder. Officers observed blood both inside and outside the establishment. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident, which depicts the incident as it was relayed to officers. The victim was a felon and should not have had a firearm.

On Thursday, June 8, 2023, at approximately 6:54p, I, P.O. SCHILLING-MESS, and two Public Safety Cadets (Ashleigh CONTRERAS w/f, 8/8/2006 (16yrs old) & Jerri Dawson 6/3/06 (17yrs Old) conducted a compliance check at 200 E Center (Palmer Center Foods) located in the City and County of Milwaukee. This was in partnership with the Memorandum of Understanding with Community Advocates, Coalition Coordinator the City of Milwaukee Tobacco-Free Alliance, Charlie Leonard. Wisconsin Wins Campaign (WI WINS is an intervention program designed to help the State of Wisconsin come into and stay in compliance with requirements of the federal Synar Regulations. The two teens were trained in the WI WINS program protocol Saturday, April 11, 2023.

CONTRERAS and DAWSON entered Palmer Center Foods attempting to purchase products for sale, not intended for minors. The goal was for the organization to request identification and turn the minors away after they find out both were teens and ineligible for the sale. CONTRERAS requested the sale of a pack of Newport 100's in a box at the cost of \$11.00 from the cashier. The cashier did not request identification for proof of age. The transaction was completed, and the youth returned to the squad and provided me a description of the cashier that sold them the product.

I then entered the location and spoke to the cashier matching their description that was provided. It should be noted that only a few minutes passed since DAWSON and CONTRERAS exited and I entered. I requested the license to the location and identification of the cashier. The subject pointed to the licenses they were posted behind the counter and elevated level out of reach. She then stated that she did not have an ID, but verbally provided me the name Chirrapa KEERTHI (F/U, 9/21/2000). A check with DOT/Wants revealed that she was not on file. I provided the cashier my Community Contact Card and requested that the owner/agent contact me regarding the incident since they were not at the location. I was unsuccessful in making contact with the agent for the business.

On Monday October 9, 2023, at approximately 6:22p.m., I was dispatched to the address of 200 E Center St located in the City and County of Milwaukee for a shooting at the location. This location was a corner store called Palmer Food Market. The additional squad that responded to the incident at 6:22p.m. was squad 5240 (PO RIVIERE, PO WOOD).

Upon arrival at the residence, I observed blood on the ground inside of the store near the entrance and the cashier counter. The front door was locked so in order to enter the store and investigate, the front door was broken to allow access. Upon entrance into the location, I observed a black handgun sitting on the counter of the cashier counter, and additional blood inside of the store in front of the cashier counter. My partner PO BYFIELD, squad 5240 (PO RIVIERE, PO-WOOD), and then cleared the inside of the incident location to secure the scene and to locate any possible injured individuals. The building was cleared, and no subjects were located inside of the building. During the investigation, supervisors and Detectives from CIB reported to the incident location to investigate the incident. At 8:25p.m., Squad 5230 (PO LINDSEY, PO PIASECKI) also responded to the incident location to assist with the investigation in attempting to locate casings outside of the incident location.

INTERVIEW OF SIMRANPAL S. MANN

An employee of the store identified as Simranpal S. MANN (I/M, 11/2/1994, 6310 Sycamore St) was at the incident location during the investigation. Simranpal stated that his mom, Ja'tinder MANN called the police regarding the incident. Simranpal also stated the black handgun inside of the store sitting on the front counter belongs to his mother, Ja'tinder MANN. Simranpal was cooperative with CIB and their investigation.

WITNESS INTERVIEW OF NITISHA YANALA

On Monday October 9th, 2023, Detective Michael LEES of General Crimes Div. CIB interviewed Nitisha YANALA (I/F, 08/08/2000) at St. Mary's hospital. During that interview, YANALA reported she arrived at Palmer Foods at approximately 5:30p.m because she worked there. Around that time, there were three kids in the store and one of them took a drink to the counter. YANALA described this subject as a b/m, 16-17 years old, square jawed, white hood, black pants, and had a black small gun with a silencer attached. This subject attempted to purchase a Baby Dutch and YANALA asked for his ID. The subject did not have an ID and became verbally abusive towards YANALA. YANALA then informed the subject that he was no longer allowed in the store and threatened to call her uncle. The subject stated he would wait for YANALA's uncle and beat his ass. YANALA called her uncle Rupinder MANN (I/M, 09/20/1968), and MANN arrived at the store shortly after.

When MANN arrived at Palmer Foods, YANALA reported the subject showed MANN his firearm. MANN then pointed a gun at the subject and ordered the subject to put his gun down. At this time, the two other individuals in the store exited the store. The subject then exited the store and MANN followed the subject outside. YANALA then heard a gunshot outside and went outside. When YANALA was outside, she found MANN with a gunshot wound to his right bicep. YANALA

and MANN then got into MANN's vehicle and drove to AJ Liquor store to pick up MANN's wife. YANALA, MANN, and MANN's wife then drove to St. Mary's hospital.

WITNESS INTERVIEW OF JA'TINDER MANN

On Monday October 9th, 2023, Detective Michael LEES of General Crimes Div. CIB interviewed Ja'Tinder MANN (I/F, 07/05/1975) at St. Mary's hospital. Ja'Tinder reported her and Rupinder MANN were working at AJ Liquor store where they arrived at around 3:15p.m. Rupinder was upstairs working at AJ Liquor. Ja'Tinder went upstairs to check on Rupinder and Rupinder was no longer there. Ja'Tinder then learned that something had happened at Palmer Foods. Ja'Tinder reported that moments later, she received a phone call from YANALA stating Rupinder had been shot. Ja'Tinder then met with Rupinder and YANALA and they drove to the hospital.

SECURITY CAMERA FOOTAGE

Video was recovered from Palmer Center Foods by F.I. Paul CERVERA and uploaded to Evidence.com

Interior Camera 6:10:08 P.M., - Unknown SUSPECT and two unknown Subjects, Subject #1 (B/M 18 y/o, 5'7", 140lbs, dark blue face mask (eyes and nose visible), off-white hooded sweatshirt with "Angel" write on the front, and wings on the back of it with blue coloring, with the hood up, dark pants, and white and dark colored shoes), and Subject #2 (B/M 16-18 y/o, 5'7", 140lbs, black Nike sweatshirt, white NIKE decal on upper left chest with the hood up, gray sweatpants, gray shoes) enter the store.

Cashier Camera (No Timestamp, approximately 6:11:30 P.M.) - Subject #1 approaches the counter to purchase items to including a "Dutch" cigar. The SUSPECT also would like to buy a "Dutch", but the cashier, Natasha YANALA (W/F 8-08-00) tells the SUSPECT that he must show an ID or buy somewhere else, and a verbal argument ensues.

Cashier Camera (No Timestamp, approximately 6:14 P.M.) - SUSPECT tells YANALA "Fuck you", and the YANALA tells the SUSPECT next time he comes into the store, that she is going to hit him. YANALA then begins dialing on her cell phone, tells the SUSPECT to "Stay here", that her Uncle is going to come, the SUSPECT states that he will stay, and when YANALA's Uncle comes that he will "Buss his ass. Imma buss his ass down.

This verbal altercation continues for several minutes inside of the store, while the SUSPECT appears to be holding something inside of his front right coat pocket, with that elbow bent outwards from his body.

Exterior Camera 6:17:45 P.M. - MANN arrives at the location and parks his White 4Dr sedan outside of Palmer Center Foods on N Palmer St, on the same side of the street at the business facing northbound. MANN exits the vehicle and walks into the store, at this time MANN does not have a firearm in his hand or visible.

Cashier Camera (No Timestamp, approximately 6:19 P.M.) - SUSPECT can be heard asking YANALA is the person walking through the door is her Uncle.

Interior Camera 6:18:10 P.M. - Rupinder MANN enters the store with nothing in his hands, the SUSPECT now has what appears to by a black pistol in his right hand. MANN walks towards the SUSPECT and the SUSPECT walks backwards into the main aisle of the store, MANN then draws his firearm from his back waistband and points it at the SUSPECT and begins giving him demands to drop the weapon and get on the ground.

Over the next approximately 50 seconds, MANN and the SUSPECT exchange words, and at time point firearms at each other. The SUSPECT states that he does not have a gun, that he wants to leave, and eventually exits through the front door.

Exterior Camera 6:19:11 P.M., - The SUSPECT and the two other Subjects exit the building, the SUSPECT who does not appear to be holding a firearm, runs to the curbline on E Center St, and then walks eastbound on E Center St. Approximately 5 seconds later, MANN walks out of the store without a firearm visible

The SUSPECT walks up a grass hill in a vacant lot to the immediate east of the Palmer Center Foods business and out of sight. A few seconds later MANN follows him up the hill and out or frame but returns a few moments later with an apparent gunshot wound to his right shoulder and walks back inside of the store.

Several seconds later MANN exits the building and follows the SUSPECT out of the surveillance video frame.

A few seconds later MANN walks back into the frame walking westbound on the 200 block of E Center St, now suffering from an apparent gunshot wound to his right upper arm.

CANVASS

I spoke with the resident of 2674 N Palmer St who I identified as Clantha WUNDER (b/m, 04/16/2000, PH: 414-739-9078). WUNDER stated she was at the address of 2674 N Palmer St when the incident occurred. WUNDER reported she heard one or two bangs but did not know exactly what those noises were and did not immediately associate the noises to gun shots.

No other information was obtained during this investigation.

INVESTIGATION

All witnesses to the incident were cooperative with the investigation.

Palmer Food Market had a functional security camera footage inside the store which was accessed during the investigation by CIB and captured the incident that occurred inside of the business. The business does not have security.

Those wishing to provide oral testimony via phone or internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
