On 05/04/2018 a 16-year-old working in conjunction with the Milwaukee Police and the WI WINS Tobacco Initiative was able to purchase a Mango Swisher Sweet cigar from the clerk at Citgo Gas station, 2627 W. Capitol Dr. The clerk did ask for ID but made the sale anyway. The clerk stated he looked at her ID but thought it showed her old enough so he made the sale. The applicant was issued a citation for the incident.

3. On 11/01/19 at 10:36pm, Milwaukee Police were dispatched to 2627 W. Capitol Drive for a fight complaint. Upon arrival, Officers interviewed the caller/employee who stated that 5 to 6 subjects entered the establishment and he thought that they were going to steal items because there have been a lot of thefts as of late. The employee left his secure area, went to the entrance, and tried to get the group to vacate the store. As the individuals were leaving, one of them began to "Shadow Box" in front of the employee causing him to fear for his safety. The individuals then left without further incident and the employee was told by police not to leave his secure area anymore.

- 4. On 06/20/20 at 1:57am, Milwaukee Police were dispatched to 2627 W. Capitol Drive for a shot spotter complaint. Investigation revealed that two casings were recovered in the parking lot and video surveillance showed a large group of vehicles in the parking lot but the employee did not see or hear anything. The lights to the business interior and exterior where turned on and the doors were locked.
- 5. On 12/19/20 at 11:23pm, Milwaukee Police conducted a license premise check at 2627 W. Capitol Drive. Investigation revealed two cans of coffee and one sandwich which were expired and the employee removed from public view. The business also had unarmed security on site.

6. On 04/07/21 at 12:33am, Milwaukee Police were dispatched to 2627 W. Capitol Drive for a shot spotter complaint. Police dispatch updated the call to 2 people being shot and 20 shots being fired. Police arrived on scene and located two persons that were deceased in the parking lot of the gas station. Additional police arrived to the location to assist on the active scene. Investigators spoke with the store clerk who stated that some subjects were fighting in the gas station. The subjects then moved out of the store to the parking lot of the gas station. The clerk then stated he heard loud noises and people running from the area. Investigators reviewed the video, which showed 2 subjects arguing in the store near the entrance/exit, one of the subjects is armed with a hand gun. During the altercation, a third subject starts arguing with the other 2 subjects. The three subjects exit the store towards the parking lot. Shots are then fired and patrons are observed running from the location.

- 7. On 04/28/23 at 2:59am, Milwaukee Police were dispatched to 2627 W. Capitol Dr for a shooting complaint. Officers arrived and located the victim who had a gunshot wound to the left thigh. The business was cooperative and officers reviewed video footage which showed the victim and suspect walk to the side of the business. A conversation took place and the suspect brandished a handgun, then shot the victim in the leg area.
- 8. On 04/29/23 at 5:26am Milwaukee Police were dispatched to 2627 W. Capitol Dr for an armed robbery complaint. Officers spoke to the victim, at her residence who stated that her vehicle was taken at knife point. The victim stated that she was at the business with her passenger a known subject. The two get in an altercation and the suspect made her exit her vehicle at knife point. The suspect got in the driver side of the vehicle and left the location. Officers reviewed video footage from the business which showed the incident.

- 9. On 11/01/23 at 10:30pm, Milwaukee Police were dispatched to 2627 W. Capitol Dr for a shooting complaint. Officers responded to the location initially for a shotspotter ping. Upon arrival officers observed the front door of the business being shout out. When offers entered the business officers observed a victim inside the business with gunshot wounds. Officers called for medical attention and spoke with the victim. The victim stated that he was putting up his bike and heard 5 gun shots. The victim stated that he realized he had been shot but never saw the shooter. The business was cooperative with the investigation and provided video of the incident.
- 10. On 11/11/23 at 11:00am, Milwaukee Police working with Wisconsin WINNS tobacco prevention, conducted a compliance check at 2627 W. Capitol Dr. The minor buyer was allowed to purchase a cigar without being ask for identification. Officers spoke with the clerk regarding the sale. The clerk apologized for the sale and stated that he will ask for identification regarding tobacco sales in the future.

Upon arrival, located a 57 year old m/b shooting victim who had one gun shot wound to the left thigh. Later, we spoke to staff of The Citgo Mart, who readily provided to us access to their security camera footage.

Camera footage showed the Victim and Suspect walk to the side of the building. There is a conversation between the two do them. The Suspect brandishes a firearm at the victim and shoots him in the leg.

On Saturday April 29, 2023, Squad 5320 (P.O. Luis MENDOZA and I, in full Milwaukee Police Department uniform, while in a marked MPD squad car (#532), while wearing our department issued Axon Body

Worn Cameras) was dispatched to an Arm-Robbery Complaint.

Officers were advised by the victim that a known actor, intentionally and without consent, while armed with a pocketknife, forced her out of her vehicle. The suspect then fled in her vehicle. It should be noted that after taking the initial report at 4076 N Elmhurst Rd, we then changed location to where the incident occurred, 2627 W Capitol Dr.

At approximately 7am I was able to review surveillance video of the incident in the parking lot of the Citgo Gas Station. In the video I observed a white Kia pull into the parking lot at approximately 2:20 am and observed JONES and BOLDEN inside the vehicle to what appeared them talking. A couple minutes later the white Kia was shaking violently consistent with the victim's statement of JONES putting his hands on her and pulling on her hair. I then observed JONES exit the passenger side door where he was seated in the vehicle with what appeared to be a shiny object in his right hand. BOLDEN stated JONES had pulled her out of the vehicle with her pocketknife in his right hand. It should be noted I notified P.O. MENDOZA however I mentioned JONES pulling BOLDEN by the hair out of the driver seat but not through the passenger side of the vehicle. In the video I observed JONES drag BOLDEN by the hair around the front of the Kia followed by JONES tossing BOLDEN into the middle of the parking lot and dumping what appeared to be BOLDEN'S purse. I then observed JONES go to the front of the vehicle, pick up an item and enter the driver side of the vehicle. At this time, I observed BOLDEN run around the rear of the vehicle and attempt entering the rear passenger side door. JONES is then observed reaching over the driver side of the vehicle to close the front passenger side door. BOLDEN is then observed to be exchanging words with JONES as JONES attempts to operate the vehicle with BOLDEN partially out of the vehicle before BOLDEN exits the vehicle. I then observed JONES operate the vehicle out of the gas station at a high rate of speed heading towards the north side of the parking lot. BOLDEN stated she did not recall what direction of travel was taken by JONES. It should be noted the whole 15 minute altercation was captured on video.

This report is written by P.O. Angelo LOPEZ, assigned to District 5, late power shift, with my partner P.O. Delia CARRILLO, squad 5436. In operation of a marked Milwaukee Police Department Squad Vehicle and in full duty uniform with Axon Body Worn Cameras.

On Wednesday, November 1st, 2023, at approximately 10:30 p.m. we were dispatched to the address of 2627 W CAPITOL DR. located in the City and County of Milwaukee, for a shotspotter complaint.

Upon our arrival I observed the front doors of the Citgo gas station were shot out. While walking up to observe the damages, I observed droplets of blood outside that lead to the inside of the gas station where I located one of the victims from the incident, identified as Carl E. SIMON (B/M 2-5-1968.) SIMON stated he had been shot, at which point I notified dispatch that the shotspotter would be a shooting and to send medical.

The following squads arrived as backup:

Squad 5220 (P.O. Nicole BECERRA-RIVERA + P.O. Harold YOUNG)

Squad 5241 (P.O. Kesha LINDSEY + P.O. Steve XIONG)

Squad 5460 (P.O. Danyatta BROWN + P.O. Tyler SEELOW)

I spoke with the victim, SIMON, who gave me a brief description of the incident. I asked SIMON what had occurred, and he stated he went to the gas station and put up his bicycle. SIMON stated he then heard approximately 5 gunshots and realized he had been struck. SIMON stated he then went to the back of the gas station. SIMON stated he did not see who had shot at him.

The employees working at the time are listed as follows. Lakha SINGH (I/M 7-24-1975) and SINGH Kamaljit (I/M 6-11-1990.) Both employees were helpful and cooperative during the investigation and complied in everything that was asked of them.

There was video surveillance footage. The footage recorded on the surveillance system shows the incident in entirety, but it was recovered and reviewed by detectives.

The above application has been made by the above named applicant(s). This requires approval from the Licenses Committee and the Common Council of the City of Milwaukee. The hearing before the Licenses Committee will take place on 3/5/2024 at 3:00 PM in Room 301-B, Third Floor, City Hall. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony via phone or internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
