(3) The requirements set forth in said detailed plan attached to this Common Council Fite as Exhibit A, constitute the zoning regulations for the area contained in such planned development district described, provided further, that the elfect of the approval of such detailed plan is that such plan shall limit and control construction, locateraired prants that such prants had limit and control construction, loca-tion, use and operation of all land and structures included within the detailed plan to all conditions and limitations set forth in such detailed
