There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. It is the intention of the Common Council to suspend or non-renew the licenses if objectors provide testimony related to the factors enumerated in MCO 85-4-4 that the Common Council finds to be true by a preponderance of the evidence and/or police reports are found to be true by a preponderance of the evidence. The police reports and other attached documents relating to objections to the license are a part of this notice and expressly incorporated in this notice. The licensee should be prepared to address these matters at the hearing.

Notice for applicants with warrants or unpaid fines:

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing. You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

This report was written by PO Nora BURLO, assigned to District Five, Late Power Shift. On 8/23/23, I was assigned to Squad 5468 along with my partner PO James TERRELL. On the listed date, at approximately 10:23 PM, PO TERRELL and I conducted a Licensed Premise (Tavern Check), at the address 3941 N Teutonia Av. The listed address is a Tavern (Bar1000) in the City and County of Milwaukee (District Five).

Upon our arrival at the listed address, PO TERRELL and I observed one male subject standing outside of the main entrance. He was wearing a black shirt with white lettering on the back "SECURITY". PO TERRELL and I introduced ourselves and identified him as **Tommy D FORREST (b/m, 6/4/94)**. FORREST stated he works for a security company called "East Side Security". He stated he has worked for the company since May of 2023 and was immediately assigned to Bar1000. He stated he works six (6) days per week from 4PM until 1AM. He stated he is one of two security guards working for East Side Security assigned to Bar1000. FORREST indicated the other security guard was inside of the location.

PO TERRELL and I observed a male subject exit the location and stand in the doorway, directly in front of us. Again, PO TERRELL and I identified ourselves and our purpose at the location. The second male subject identified himself as the DJ at the location. We then entered the bar and I continued speaking with the male subject who identified himself as **Anthony L MOORE (b/m, 8/1/78)**. MOORE stated he is the DJ at the location. He stated he has worked at the bar since May 12th, 2023, when it opened. MOORE stated he works four (4) days per week from approximately 8 PM to 1 AM.

While I continued speaking to MOORE, PO TERRELL walked to the bar and immediately began speaking to the bartender. He identified one female bartender as **Tanisha E SPEARS (b/f, 4/18/88)**. SPEARS was

not able to produce her bartending license. SPEARS stated the owner of the bar has her license in a folder in his office which is not accessible to her. The second bartender, identified as **Jeanice TYLER-BELL (b/f, 7/2/91)**. TYLER-BELL stated she is currently working on becoming the manager at the location. She attempted to locate her bartending license however she was unable. She stated the physical copy of her license is also in a folder in the owners office which she is unable to access. TYLER-BELL stated she has worked at the location since it's opening on May 12th, 2023. She stated she works five (5) days per week from approximately 4:30 PM to 8 PM.

As I conducted a walk-through of the location, PO TERRELL conducted a check of the bar area. He checked every liquor bottle for any kind of bugs and observed two bottles that did in fact contain fruit flles. he instructed TYLER-BELL that the liquor needed to be poured out and the bottles disposed of properly.

While PO TERRELL and I were making our observations, TYLER-BELL approached me and stated she was speaking to the owner via cell phone. She asked if I would like to speak with him and I informed her that I would.

I then spoke with a male subject who verbally identified himself as **Timothy M BEA (b/m, 3/21/84)**. BEA inquired as to why PO TERRELL and I were inside of the location. We informed him that we hadn't made contact with him yet, and as the official "Tavern Squad" we wanted to introduce ourselves. BEA stated he is the owner of the listed location. I informed BEA that there should always be invoices (for approximately two years) on hand at the location. BEA stated he does have invoices however they were currently in the upper unit of the location, where his office is. He stated that is where he keeps the bartenders' licenses as well. I informed him they should be in a place that is accessible to whoever is in charge of the bar when he is not present. I also informed BEA that video "poker" machines are no longer legal and pointed out that there were two visible to officers. I advised him of the potential penalties if he decides to keep them on scene. He stated he understood and thanked me for advising him. We then ended the call.

I then walked to the bar area where PO TERRELL was checking bottles. As he finished checking the bottles, TYLER-BELL again approached me and motioned for me to take her cell phone. When I did, BEA again identified himself and questioned why PO TERRELL was checking the bottles at the bar. BEA became upset as he raised his voice and began telling me that PO TERRELL and I were harassing him. I informed BEA that we were conducting a regular check of the premises and BEA responded by telling me that he would be contacting Alderwoman Coggs. I informed him that he has every right to contact her and that she is aware of who PO TERRELL and I are and what our assigned duties are, in District Five. BEA continued to raise his voice while speaking with me. I informed him that his bar is nicely kept and things were all in order, aside from the video "poker" machines and the records not being available to officers. Due to BEA's continued agitation, I informed him I would leave a contact card for him with TYLER-BELL, I then ended the phone call.

PO TERRELL and I left the location at that time.

On Wednesday, February 7th, 2024 at approximately 11:29PM during business hours, we conducted a Tavern check at 3941 N. Teutonia Ave (Bar 1000) which is located in the City and County of Milwaukee, WI.

We spoke to the manager who was identified as TYLER-BELL, Jeanice (B/F, DOB- 07/02/91) who stated there haven't been any issues lately. TYLER-BELL stated they were having a private event and not currently open to the public in which she also stated the private event just ended.

The hearing before the Licenses Committee will take place on 3/26/2024 at 10:50 AM in Room 301-B, Third Floor, City Hall. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at <http://city.milwaukee.gov/citychannel>. Those wishing to provide oral testimony via phone or internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.
Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
