Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, lottering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 01/31/23, the applicant was charged with OWI in Washington County Circuit Court. On 03/02/23, he was convicted and his license was revoked for 1 year for Implied Consent.
- 2. On 03/23/23 at 1:51p.m., Milwaukee Police were dispatched to a Fight in the area of 107/Granville. On arrival the officers observed a vehicle in the parking lot of 8762 N. Granville Rd. Investigation revealed this was a civil dispute regarding child custody.
- 3. On 04/23/23 at 8:51p.m., Milwaukee Police were dispatched to a Fight at 8762 N. Granville Rd. On arrival the officers interviewed the agent who denied a fight took place inside, but seemed irritated by the officer's presence. On arrival officers observed a vehicle in the driveway of the business with steering column damage, running and unoccupied. On Monday, March 23rd, 2023, Squad 4272 (PO NOWAK and I) were dispatched to the area of N 107th St/W GRANVILLE RD for a fight complaint. This address is in the city and county of Milwaukee. PO NOWAK and I were in full Milwaukee Police uniform and equipped with body worn cameras.

Upon arrival, I observed the Silver SUV baring WI plates ARH9895 in the parking lot of Irie Palace bar and grill. I spoke to a B/F, later identified as Jaqualla KAZEE (B/F, 10/03/95) who stated that she and her child's father, Deshawn HUDSON-BRITTON (B/M, 09/24/94) were arguing about child custody. KAZEE stated the argument never turned physical. KAZEE stated she did not fear for her safety. HUDSON-BRITTON stated that he and KAZEE got into an argument, and he only wanted to take custody of his child. HUDSON-BRITTON stated nothing physical occurred and he did not fear for his safety.

NATURE OF CALL/JUSTIFICATION

On Sunday, April 23, 2023, at approximately 8:51pm, I (Squad 4467) was dispatched to a "Fight" complaint at the address of 8762 N. Granville Rd. located in both the City and County of Milwaukee, WI. This business is The Irie Palace.

INVESTIGATION

Upon arrival I entered the business and approached the main bar. I observed that the business was open and operating in a business capacity with 4 patrons inside of the bar. I observed zero security guards inside and zero outside. I observed that the interior lights as well as the exterior lights were on and functioning properly. I did not observe the business licenses and occupancy permit visibly anywhere.

I spoke with Deshawn L. HUDSON-BRITTON (b/m, 09-24-94) regarding a fight that allegedly occurred at the location, and he stated "No fights here. Who called yall?" I asked HUDSON-BRITTON if he was ok and if he needed medical (as they were staging) and he replied "No. I wasn't fighting." I asked to review the cameras at the location and HUDSON-BRITTON stated they did not work. I asked HUDSON-BRITTON for his business licensing paperwork and occupancy, and he provided them after finding them in a folder inside a drawer behind the bar. I notified HUDSON-BRITTON that he is required to have this paperwork visible inside the location at all times. HUDSON-BRITTON posted the licensing on the wall behind the bar.

It should be noted that HUDSON-BRITTON seemed to be upset or irritated with police and acted as if he was being accused of something. I explained to HUDSON-BRITTON that the police were called to the location for a fight, and we were simply there to investigate it. HUDSON-BRITTON stated nothing happened and he was just "Trying to run his business." Police observed no fighting on scene, and no one appeared to be disheveled or injured. Nothing appeared to be out of place, and no one was outside upset. I contacted the caller who stated she was a patron inside the location and saw a woman fighting a man, but she left. The caller stated she already told the operator what happened and hung up on me.

On Sunday, December 31st, 2023, at approximately 4:42PM, Squad 4246 (myself, in full duty uniform, marked police, vehicle and activated body worn camera) responded to a Stolen Vehicle Call at 8762 N Granville Rd, which is in the City and County of Milwaukee.

Upon arriving the entry drive of the location I observe a grey 4 door Hyundai Sonata (WI LP # AMM-8963), parked in the middle of the drive, running and unoccupied. Upon approaching the vehicle I observed that the steering column was damaged and the front driver side windows was broken out.

A check of LP #AMM-8963 revealed no entries in NCIC for a stolen auto, however based on my training and experience, this vehicle was likely a freshly stolen auto.

A check revealed that the listed vehicle was owned by Zachariah P GEORGAKAKIS (w/m, 07-14-99). There were no MPD records to contact GEORGAKAKIS via phone.

While on scene I spoke with caller, Deshawn L HUDSON-BRITTON (b/m, 09-24-94) who stated he is the owner of the location (Erie Palace Bar and Grill). HUDSON-BRITTON stated that he is unaware of the subjects who left the vehicle in his driveway and did not seen any subjects. HUDSON-BRITTON stated he last knew his lot to not have that particular vehicle parked in it at approximately 2:45PM. HUDSON-BRITTON stated that when he went out to the vehicle he saw the steering column was damage and then called the police.

HUDSON-BRITTON was cooperative with the investigation.

Those wishing to provide oral testimony via phone or internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
