This report is written by Police Officer Penny Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 10/07/23 at 6:59p.m., Milwaukee Police were dispatched to a battery at 7613 W Good Hope Rd. Investigation revealed a customer ordered a pizza and when asked to pay for the pizza, became argumentative. While the manager was attempting to call the GM, the suspect reached over and intentionally scratched the employee, causing injury. The employee provided the officer with the corporate office phone number to gain access to the video surveillance. (Note: this incident occurred 01/07/2024 but what approved with incorrect dates- 10/07/2023 and 01/07/2023 on the licensed premise report)
- 2. On 10/07/23 at 1:27a.m., Milwaukee Police were on patrol and heard 5 gunshots coming from the area of N 76th and W Good Hope Rd. The officers were then advised by dispatch of a shots fired at 7613 W Good Hope Rd. Investigation revealed the caller went to the location to confront employees about throwing a rock, when employees began to shoot at the occupied vehicle. The manager on scene was uncooperative with the police and denied any knowledge of the incident. The victims were able to point out the employee who fired shots at them. The manager on scene was uncooperative and denied any knowledge of the incident. The officers were able to obtain video surveillance of the incident from a neighboring business, which depicts the employee previously identified, shooting at the victim's vehicle, then picking up the casings. The employee was arrested on scene and Regional Manager was notified of the incident.

3. On 01/29/24 at 4:57p.m., Milwaukee Police were dispatched to a Subject with Weapon at 7613 W Good Hope Rd. Investigation revealed a customer was unhappy regarding the refund process and began to make threats, causing a disturbance. The employee eventually gave the customer cash, and they left the scene.

This report was written by P.O. Brittany GALLOWAY, assigned to District Four, Late Power Shift, Squad 4430, with P.O. Michael SMITH.

Dispatch Call Type and Detail:

On Monday, January 7th, 2023, while in full duty uniform, equipped with an axon body worn camera, activated, and in a marked squad, responded to a battery complaint, at the location of 7613 W Good Hope Rd. (Domino's Pizza), which is located in the City and County of Milwaukee, at approximately 6:59 PM.

PC Statement:

I spoke with JONES, Makayla M. (B/F 10/02/1995), who stated on Monday, January 7th, 2023, at approximately 6:40 PM, inside her place of work, at the location of 7613 W Good Hope Rd. (Domino's Pizza), an unknown actor, who JONES was unable to identify intentionally and without consent scratched her in the face with her nails. JONES stated that the scratch caused her pain, and visible injury. JONES stated that the actor was upset because they asked her to pay for her food. JONES described the actor as a B/F, 5'6-5'7, slim build, dark complexion, black hair in a ponytail, with blonde highlights, pink nails, wearing a black puffer coat, dark blue jeans.

Initial Observations:

Upon arrival, I observed the caller to have three large abrasions, going across her right eye, vertically. The abrasions were approximately 3-4 inches long, red, and swollen.

Interview of Victim, JONES, Makayla M. (B/F 10/02/1995 262-510-5879): JONES stated on Monday, January 7th, 2023, at approximately 6:00 PM, she was at her work place at 7613 W Good Hope Rd. JONES stated that she is one of the managers at Domino's Pizza. JONES stated that an order came in at approximately 6:49 PM, for a small hand tossed pizza, with light cheese, pepperoni, and sausage. JONES stated that the name placed on the order was Tori Kendrick with the phone number 414-748-2263. JONES stated that this name and number has placed multiple orders in the past two months, and have not paid for their food. JONES stated they will show up to the store, argue about not paying their food, and sometimes the general manager caves in and gives them their food for free. JONES stated that the two subjects came in approximately a few minutes later attempting to pick up their food. JONES stated that the subjects once again argued about not paying for their food. JONES stated that the subjects kept telling her that she was not the manager, and to call the real manager. JONES stated that she stayed behind the register, where they have glass with an opening between the employee and the customer. JONES stated that as she was calling the general manager on speaker phone, the female subject reached in the opening of the glass, and attempted to grab her phone. JONES stated that the female subject missed, and then intentionally and without consent, scratched her in the face attempting to knock her glasses off. JONES stated that the subjects ran out the store, jumped in their vehicle and fled the scene. JONES described the female subject as JONES described the actor as a B/F, 5'6-5'7, slim build, dark complexion, black hair in a ponytail, with blonde highlights, pink nails, wearing a black puffer coat, dark blue jeans. JONES then described

the male subject as a B/M, 5'10, medium build, dark complexion, afro, with a bass hat, wearing a green puffer coat with fur on the hood, with a black shirt, unsure of pants.

P.O. Observations of victim:

I observed the caller to have three large abrasions, going across her right eye, vertically. The abrasions were approximately 3-4 inches long, red, and swollen.

BELL 405 arrived on scene, and rendered first aid to JONES. JONES declined getting transported to the hospital.

Interview of witness, JOHNSON, Kaniijah R. (B/F 06/13/2004 414-982-0563):

JOHNSON stated she was working in the kitchen at Domino's on Monday, January 7th, 2023 at approximately 6:30 PM. JOHNSON described the subject that hit her manager as a B/F, 5'6-5'7, slim build, dark complexion, black hair in a ponytail, with blonde highlights, pink nails, wearing a black puffer coat, dark blue jeans. JOHNSON then described that male subject as a B/M, 5'10, medium build, dark complexion, afro, with a bass fishing hat, wearing a green puffer coat with fur around the hood, with a black shirt. JOHNSON stated to police that she observed the incident and is willing to be a witness, however was unable to go into detail because they had received a plethora of orders, and were very behind due to the incident. JOHNSON did state that she was able to capture the LP# of the vehicle suspects drove off in, LP# provided is ANK5772.

JOHNSON described the vehicle as a blue Mazda CX-5 with tinted windows.

I attempted to speak with other employees, however they all stated that they were in the kitchen and did not see anything.

Evidence:

JONES explain to us that she does not have access to her store's camera's, only the corporate can look at cameras upon request. JONES provided the phone number to corporate, which will be contacted regarding video.

P.O. SMITH took photos of the victim's injuries regarding.

I attempted to retrieve footage at the location of 7155 N 76TH St, which is the gas station Domino's is attached too, however you do not see the car in their camera's.

This report is written by PO Lacy WOURMS assigned to District 4, Late Shift, Squad 4360.

On Saturday October 7, 2023, at approximately 1:27am PO Andrew KELLER and I were on patrol in the 6400 block of N. 76th St., which is located in the City and County of Milwaukee, when we heard 5 gun shots coming from north of our location. We estimated the location to be approximately N. 76th St. and W. Good Hope Rd. We went to investigate this incident when dispatch received a call from a female who stated her vehicle had been shot into at the Domino's Pizza which is located at 7613 W. Good Hope Rd. She further stated the shooter was wearing a Domino's uniform.

ARRIVAL ON SCENE:

Upon our arrival we made contact with a subject taking out trash at Domino's, Todd A. CLAYTON, M/B 09 -18-1991 who stated that he had heard shots fired and saw a gray sedan leave the area. CLAYTON was wearing a black sweatshirt with a gray Domino's t-shirt over it and black pants. When we asked who was shooting, he stated that he did not know. As we continued our investigation, we were approached by Takeya L. WARRENS, F/B 06-30-1987 who stated that her daughter had called and stated that her vehicle was struck by gunfire from the employees at Domino's.

INTERVIEW WITH VICTIMS/WITNESSES:

WARRENS' daughter, Tashawna L. BALDWIN, F/B 04-14-2006 did arrive back at the scene after a short time and stated that she had an argument with staff at this location because the delivery driver who brought her pizza also threw a rock through the window and broke it after she refused to pay for the food. BALDWIN stated that she got into her car, (Silver 4Door 2019 Chevy Malibu WI Auto ATX-1137) which was driven by her friend, Jazmarie A. WHITE, F/B 11-18-2003 and also occupied in the rear passenger seat by her other friend, Shaniah S. DOLTON, F/B 05-25-2006. BALDWIN stated that the three of them went to the Domino's Pizza to confront the delivery driver regarding the broken window. She

stated there was a heated exchange of words and denials by the general manager and the driver but no resolution. BALDWIN stated that she was yelling at the driver when she started hearing gunshots. DOLTON stated that she saw the driver produce a black handgun and start firing at their vehicle. She stated that they then fled the scene and called police. BALDWIN stated that she did not see the subject shoot but that she heard the shots and told WHITE to drive away. WHITE stated that she drove when she started hearing gunshots.

During our investigation the General Manager of the store returned to the scene. When asked for his identifying information he was uncooperative and asked why he needed to give that information. We explained that other employees identified him as being on scene during an incident where shots were fired into an occupied vehicle and asked why he was refusing to assist us in our investigation. He stated that he did not see anything, even though he was standing approximately 10 feet from the subject shooting while shots were being fired and stated that he never saw who was shooting. He did identify himself as Donnell D. RASH, M/B 03-03-1996 and when asked if we could view the video footage, he stated that he's only been working at the location for two months and does not have access to view the cameras. It was clear that RASH was not cooperating with our investigation and that he did not want police at the store.

During our investigation we observed several employees coming and going from the location and when asked none of them stated they saw or heard anything. They stated that they females came to the store and were disruptive but none of them saw anyone shooting.

SUSPECT IDENTIFICATION:

While we were attempting to speak to the victims, CLAYTON came out of the store, where he had been for some time, and all three of the victims began yelling, "That's him!" making statements that CLAYTON was the person who shot at their car. CLAYTON walked back into the store where we followed, and we detained him at that time. CLAYTON denied any involvement in the incident and did grant us permission to search his vehicle. No gun was located inside the vehicle.

EVIDENCE COLLECTION:

We did observe cameras inside the Domino's store and outside on the building. RASH refused to allow us access to the cameras inside the store, so we went to 7605 W. Good Hope Rd., which is the Andy's Gas Station. We spoke to the clerk who allowed us access to the video footage from the exterior of the building. We observed the victim's vehicle driving in the parking lot and stop by the side employee door where CLAYTON, wearing a black hooded sweatshirt and gray t-shirt over it and black pants exit the employee door with other employees of the business. He proceeds to raise his right arm up toward the direction of the vehicle and you can see him holding a dark colored object. The car begins to drive away, and you can see flashes come from the raised hand indicating shots being fired at the sedan. CLAYTON and other employees then walk to the area the shots were fired from and begin looking at the ground with the flashlights from their phones. CLAYTON then begins to pick up items from the ground, we believe he was picking up the casings that were ejected from the firearm. We did not locate the casings after an extensive search. CLAYTON was taken into custody with two live rounds from a handgun in the pockets of his pants.

We processed BALDWIN's vehicle, which had four bullet strikes to it. The first was near the front driver's side quarter panel and entered near the engine compartment. The second was into the driver's door at an angle which entered into the passenger compartment and struck just below the steering wheel. The third struck the driver's side near the B frame. The fourth entered into the rear taillight on the driver's side. We recovered bullet fragments from the driver's floorboard and behind the dash under the steering column. Additionally, we recovered a bullet fragment from the taillight. These items were placed on MPD inventory: 23032277.

The signed consent form was also placed on MPD inventory: 23032276.

Sgt. Charles CARABELLI responded to this scene and took 78 photos of the vehicle, scene, and suspect clothing.

Forensic Investigator Clayton AMBORN also responded to the scene and recorded a video of the security footage and that was uploaded to evidence.com.

FOLLOW UP:

PO KELLER notified the regional manager of Domino's regarding this incident. The firearm was taken back into the building after the shots were fired and then RASH is seen leaving the building moments later appearing to be holding something and leaves in his vehicle before later returning. We have not been able to view the footage from inside the store.

Additionally, follow up will have to be conducted regarding the employees at Domino's and their roles regarding the evidence destruction that occurred. Not all employees were identified during our initial investigation.

CLAYTON was arrested on scene and conveyed to District 4 for booking and processing.

This report is being written by P.O. Devin BERG, Assigned to District Four, Early Power Shift.

On Monday, January 29th, 2024, my partner P.O. NOURI and I (Squad 4272) were dispatched to a Subject with Weapon complaint at the location of 7613 W. Good Hope Rd. (Domino's Pizza) which is in the City and County of Milwaukee, at approximately 4:57 PM.

Upon arrival, I observed an employee inside waiting for police arrival. Upon entry of the location, I did not observe anyone inside causing a disturbance. Officers were allowed in back to speak to the caller later identified as Donnell D. RASH (B/M, 03/03/1996) who is the manager of this location.

RASH stated an unknown female was inside of the location on 01/28/2024. RASH stated the female was unhappy with her food, so they gave her a refund. RASH stated the female used a Cash App card to pay so they refunded the money to the card. RASH stated the female became upset when she found out the refund takes 3-5 business days to complete. RASH stated the female completed for a short amount of time, but eventually left. RASH stated on today's date 01/29/2024 at approximately 4:40 PM, the same unknown female entered the location and began demanding a refund again. RASH stated the female was threatening him and causing an issue inside the location. RASH stated one of his employees finally gave the female the money she wanted, and she left the store on food with a baby stroller. RASH stated he believed the female got onto the City Bus and left the location. RASH stated he doesn't think there will be further issues with the female and stated he didn't need anything done legally. RASH stated he would call the police if the female ever returned. RASH was cooperative with police.

While on scene, I observed the licenses posted and they were up to date. During my investigation. I did not observe any violations in the licensed premise.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
