- 6. On 09/27/18 at 10:00am, Milwaukee Police, along with a State of Wisconsin Department of Revenue Agent, conducted a license premise check at 6330 W. Silver Spring Drive (Citgo). The agent did an inspection on the tobacco products and found the invoices on scene did not match the stock on hand. The tobacco products were confiscated.
- 7. On 10/06/18 a 17 year old working in conjunction with the Milwaukee Police Department and WI WINS Tobacco initiative, was able to purchase a 2 pack of Swisher Sweet Cigars at 6330 W. Silver Spring Drive, The sales clerk admitted to selling the item and the station was mailed a MARTS enrollment packet.

- 8. On 07/09/19 at 4:35pm, Milwaukee Police were dispatched to 6330 W. Silver Spring Drive for a battery complaint. Upon arrival, officers interviewed the caller/employee who stated that 3 subjects entered the establishment and took items from the store in an attempt to steal them. While they were leaving the station, one of the subjects threw candy at the employee, striking him in the left side of the face. The subjects fled and were not apprehended. The applicant was cooperative during the investigation.

Officers interviewed the manager on duty who stated he was not aware of a fight and allowed the officer to view video surveillance. No fight was observed on the surveillance cameras. No violations were observed

12. On 10/25/21 at 3:25am, officers were dispatched to Citgo, 6330 W. Silver Spring Dr., for a Subject with Weapon. Officers were advised by the employee/caller there was a subject attempting to gain entry to the business utilizing tools, however, during late hours, customers must use a service window. Officers made contact with the subject and advised him of the service window. The subject stated he understood and left on foot.

13. On 03/21/23 Milwaukee Police were dispatched to 6330 W. Silver Spring Dr, for a robbery complaint. Officers spoke with the employee who stated that the known suspect, repeat shoplifter, took items without paying for them. The suspect struck the employee's face before fleeing with the items. The employee received medical treatment, and a warrant was placed on the suspect.

- 14. On 03/27/23 Milwaukee Police were dispatched to 6330 W. Silver Spring Dr, for a theft complaint. Officers spoke to the caller who stated that two subjects came to the location and took items without paying for them. The employee recognized one of the subjects as a repeat shoplifter. One of the subjects had a gun in his waistband at the time of the incident. The subjects left the location on foot.

Silver Spring Dr, pumping gas. The suspect approached her and struck her in the face demanding her keys to her vehicle with another suspect nearby. The victim screamed for help and was able to get in to her vehicle and drive away. Officers responded to the location to retrieve video surveillance of the incident. The video recovered showed the incident its entirety.
- 16. On 04/13/23 Milwaukee Police were dispatched to 6330 W. Silver Spring Dr, for a subject with gun complaint. Officers spoke with the caller who stated that she observed a juvenile standing outside the location possibly with a hand gun. The caller observed the juvenile gesture as if he was going to pull the possible hand gun from his back pack. The juvenile then walked away from the area. Officers checked the area but could not locate the juvenile.
- 17. On 04/20/23 at 1:00pm, Milwaukee Police conducted a meeting at District 4, with the owners and operators of the Citgo gas station located at 6330 W. Silver Spring Dr. The meeting was regarding the business being a soft target for thefts and robberies. The business stated that they are working to hire security guard with a different company. The business shared their current business practices and the officers offered suggestions on how to deal with current issues.
- 18. On 05/07/23 at 2:55pm, Milwaukee Police were dispatched to 6330 W. Silver Spring Dr, for a theft complaint. The employee stated that a subject took items from the business without paying for them. Officers spoke with the employee who was cooperative with the investigation and provided information to file a police report.
- 19. On 08//26/23 at 5:05am, Milwaukee Police were dispatched to 6330 W. Silver Spring Dr, for an injured/sick complaint. The caller stated that a male was in the parking lot slumped over in a blue vehicle. Officers arrived and located the subject in the vehicle. The subject was then arrested. The business was not contacted regarding the assignment due to a third party caller.

This report is written by P.O. Khalid MAJEED assigned to District #4, Late Power Shift. On Tuesday, March 21, 2023, my partner P.O. O'Neal STAMPS III and I, assigned to Squad 4467, were dispatched to a "Robbery" complaint at 6330 W. Silver Spring Dr. This is located in the city and county of Milwaukee.

At approximately 7:30pm at the above listed location Javea D. WILLIAMS (b/m, 09-24-03) intentionally and without consent struck Sukhwinder S. BABA (w/m, 09-07-72) who is an employee at Citgo Gas Station two times to the left side of his face causing him pain. Curtis 313 arrived on scene and cleared BABA on scene. BABA refused to go to a hospital and was given an ice pack for his left eye.

WILLIAMS along with 6 other unknown b/m's took items past the final point of sale and exited the store depriving the business of their property. WILLIAMS and the unknown males entered the gas station, took items, left out of the store and came back inside to do the same thing two more times.

WILLIAMS is known to come into this establishment every day and is captured on camera stealing just about every day. WILLIAMS has multiple warrants and open cases regarding. The business does not know the exact value of property taken to date.

Squad 4441, PO CAUL and TUCHEL checked for WILLIAMS at 5662 W. Silver Spring Dr., but he was not home. Squad remains in area checking for the subject.

PO STAMPS III placed a Temp Felony Warrant (23-TFW-0696).

I gave BABA a MPD Community Contact Card regarding and a PV-17.

The business has working cameras and was cooperative.

This License Premise report is written by PO Yengkong SAYAOVONG, assigned to District 4, Late Shift, Desk PO.

On Monday, March 27, 2023, at 5:55pm, Saipavan MACHINENI (a/m DOB 11/26/1999) was working behind the counter at the Citgo Gas Station 6330 W Silver Spring Dr.

IMACHINENI observed 2 subjects enter the store. Subject 1 is a black male, approximately 15 years old, 5'6", wearing a dark hooded sweatshirt.

Subject 2 is a black male, approximately 10 years old, wearing multicolored clothing.

MACHINENI recognized Subject 2 as a frequent shoplifter.

MACHINENI observed Subjects 1 and 2 collect items throughout the store and shove them into an open backpack worn by Subject 2.

MACHINENI exited from behind the enclosed counter area and approached the subjects while holding a wooden stick approximately  $2' \times 2''$ .

Subject 1 quickly shoved the items in Subject 2's backpack, reached for his waistband, and placed his hand over the grip of a pistol.

MACHINENI saw the pistol and retreated behind the counter.

Subject 1 and Subject 2 left on an unknown direction.

There are no witnesses on scene. There is footage of the incident.

This report is written by PO William BILTY assigned to the District 4, Early Shift. On 03/29/2023 I was assigned to Squad 4299/Desk PO. I was dressed in my Full Milwaukee Police Department-issued uniform.

On 03/29/2023 at approximately 10:30 P.M. Maria GOMEZ-MARTINEZ(h/f, 03/25/1986) walked into the

District 4 lobby to report an attempted strong-armed/carjacking that occurred at approximately 10:00 P.M. At the Citgo gas station located at 6330 W Silver Spring Dr (which is located in the City and County of Milwaukee). GOMEZ-MARTINEZ stated while she was pumping gas on the north side of the gas station, she was approached by a black male approximately 14-15 years old 5'3 wearing a colorful jacket. GOMEZ-MARTINEZ stated the suspect approached her and punched her in the face 2 to 3 times telling her to "give up her keys". GOMEZ-MARTINEZ stated after she was struck, she began yelling for help and screaming loud to stop. GOMEZ-MARTINEZ stated this made the suspects walk away west towards 64th St. GOMEZ-MARTINEZ stated there was a second suspect she described as 15-17 wearing all black and approximately 6 ft tall. GOMEZ-MARTINEZ stated the suspect that punched her yelled to the suspect to "help me" and "grab the keys."

The suspects were unable to get her keys. GOMEZ-MARTINEZ stated she drove off then went home and realized she lost her glasses during the incident. GOMEZ-MARTINEZ returned and retrieved her glasses then came to District Four to report the incident. Video obtained by Squad 4220 showed suspect 1 in a yellow and blue jacket approaching the victim, striking her in the face. The suspect then went towards the car door before running off. The video showed suspect 2 wearing all black. Suspect 2 did not strike the victim.

I PO BILTY noticed the suspects are similar to the suspects committing thefts at 6330 W Silver Spring Dr and 6410 Silver Spring Dr. They also look similar to an armed robbery that occurred IR# 23-090-0143. I PO BILTY sent out still and video to all sworn at District Four that also includes video of the thefts sent out by CLO Tracy GENIESSE.

#### PO Observations:

I PO BILTY could see redness and swelling around GOMEZ-MARTINEZ's eyes/ forehead area. The victim was visibly shaken and was tearing up while recounting the event. GOMEZ-MARTINEZ refused medical at the time but said she would let me know if she got medical attention for her injuries the next day.

#### CST:

Squad 4293/CSO Kendra DELANEY captured 14 photos at 11:02 P.M. CSO DELANEY took photos of the victim's injuries and the car she was driving at the time. 2004 Honda Pilot(WI, AAR7575).

Squad 4220 PO Benjamin MARSHMAN and Matthew DEGLEY obtained video of the incident and loaded it to evidence com.

GOMEZ-MARTINEZ was given a PV-17 and community contact card.

On Thursday 04/20/23 at 1pm, we held a meeting here at District Four in regard to the incidents that the Citgo stations located at 6330 W. Silver Spring Dr and 6410 W Silver Spring Dr, of which both locations are owned by Balvir Singh. Mr. Singh was unable to attend the meeting due to being out of the country. Present was Myself, Captain Schlei, Sgt Velasquez, ADA Joy Hammond PO Resnick, in the place of Mr. Singh was Ravinderjit Singh and Surgit Kaur.

Introductions were done and Captain Schlei began the meeting stating, issues occurring at the Citgo's located at 6330 W. Silver Spring Dr and 6410 W. Silver Spring Dr., which are both owned by Mr. Singh is the reason for this meeting. Captain Schlei explained the business is a soft target for criminals to walk in and take items from the businesses. Three robberies occurred within a short amount of time and two subjects have been taken into custody. Captain Schlei asked both Surgit and Ravinderjit, what are the issues they are seeing in the neighborhood. Surgit showed the group a video from her phone, of several subjects stealing items from the store, she then followed them to a residence located at 6512 W. Sheridan. She stated the group of individuals in the photo on the porch of this property are constantly walking into the businesses and stuffing their backpacks and pockets and leaving the stores without any attempt to pay for the items.

We asked what the current security measures are at the businesses and she stated she has a private armed security guard who is supposed to work from 7a-12a all seven days of the week, but he doesn't show up all of the time. They are currently looking at a few security companies to hire one. The hours of operation at 6330 is open 24hrs a day. After 6pm- they utilize the window only and doors/ locked lobby until 5am. There is only one person during these hours. Hours of operation at 6410 is 7a-12a. Captain asked if there was a specific time of the day the group of individuals enter the store. Surgit stated they come at all different hours. She is willing to work with MPD D4 to find a solution to the problem. We advised her to call the non emergency number when the individuals are walking to the businesses. They have posted No Loitering signs on the building, have decent lighting and cameras. Willing to share any videos and photos with MPD.

This concluded the meeting.

The caller to police, Curtis, stated that two subjects had taken items from the gas station and fled west bound on West Silver Spring Drive.

While enroute, I called the caller/reporting person, "Curtis" who confirmed he was still onscene but at the gas station across the street which is another Citgo Gas Station located directly across the street to the east at the location of 6333 West Silver Spring Drive. I advised the caller that I would meet him at this location.

Onscene, I spoke to the caller/reporting person, verbally identified as Curtis L Hurt b/m 09-30-1968. Hurt stated he works security at both of the gas stations and was at the location of 6410 West Silver Spring Drive when this incident occurred. He also informed me that the same suspects had also shop lifted at both gas stations first stealing from the gas station located at 6330 West Silver Spring Drive and then the gas station 6410 West Silver Spring Drive immediately after before fleeing west bound.

Hurt stated that from the first gas station at 6330 West Silver Spring Drive the suspects intentionally took various miscellaneous sodas in plastic bottles, three loaves of large white Butternut bread and various potato chips. The suspects exited the business without making payment. The same two suspects took items from the second gas station including various food items, paper plates, three boxes of tissues and aluminum foil before fleeing west. No payment was made.

Hurt described the suspects as following:

Suspect #1: black male, 40's, 5'08", stocky build, dark complexion, wearing a blue in color baseball cap, and black jacket.

Suspect #2: black female, late 30's, medium build, medium complexion, wearing hair in a ponytail, and red coat.

Suspect Vehicle: orange in color 4 door "sport car", unknown make/model with possible partial registration plate number "811"
