3. On 09/19/2021 at 9:25pm officers were monitoring the crowd at Prime Social, 7225 N. 76th St., when they heard about 20-25 gun shots at the gas station at 7616 W. Good Hope Rd. The officers responded there and located a vehicle that was shot. The applicant arrived on scene and provide officers with video of the incident. While investigating a victim of the shooting arrived at St. Joseph's Hospital.

- 4. On 02/26/23 at 3:43p.m., Milwaukee Police were dispatched to a Call for Police at 7616 W. Good Hope. On arrival all citizens denied requesting police and the caller could not be located.
- 5. On 03/09/23 at 9:11a.m., Milwaukee Police were dispatched to a Hold Up Alarm at 7616 W. Good Hope. Investigation revealed the alarm went off erroneously.
- 6. On 08/15/23 at 4:32a.m., Milwaukee Police were dispatched to a 7616 W. Good Hope. Investigation revealed the victim was adding oil to their vehicle, when they were approached by the suspects, pointing a firearm and demanding property. The victim's property was later recovered due to an arrest involving a different incident. The business did have security cameras, however, the employee on scene was not able to access them.
- 7. On 12/27/23 at 11:52p.m., Milwaukee Police were dispatched to a Shooting at 7616 W. Good Hope Rd. On arrival officers located the victim and performed life saving measures, however, the victim succumbed to their injuries. The officers did locate a firearm in the victim's vehicle with blood on it. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident, however, it was determined the video surveillance was not recording at the time of the incident.

Upon arrival, officers spoke to cashier Chaudhry I ALI (w/m 05/20/57) who stated that he received a call from the alarm company regarding a silent hold up alarm at the gas station.

ALI stated that he was sitting down doing paperwork when the silent alarm was pressed. ALI stated that he did not activate the alarm and was sitting about four feet away from the button. ALI further stated that there was no possible way he could have activated the alarm and insisted that it was a fault in the system.

ALI was cooperative with the Police during this investigation.

This report is written by PO Lacy WOURMS assigned to District 4, Late Shift, Squad 4332.

On Tuesday August 15, 2023, at approximately 4:32am, PO Andrew KELLER and I responded to 7616 W. Good Hope Rd., which is located in the City and County of Milwaukee, for an armed robbery complaint.

Upon arrival we spoke with the caller, Oyeyemi O. ABIOLA, M/B 10-09-1985, who stated that he pulled into the gas station at this location and went inside to buy oil for his vehicle. ABIOLA stated that while he was starting to put oil into the engine, two B/M's approached him in the parking lot, pointed a black handgun at him and took property from his pockets. He stated that they obtained a wallet w/credit cards, car keys, house keys, and a white IPhone 11.

He stated that the subjects fled the location in a green Mazda sedan with an unknown plate or model westbound on W. Good Hope Rd.

ABIOLA described the two subjects in the following manner:

Suspect 1: B/M, 25-28 y/o, 5'7" thin build, wearing a black hooded sweatshirt, black pants and armed with a black handgun.

Suspect 2: B/M, 25-28 y/o, 5'7" medium build, wearing a red hooded sweatshirt.

This location does have cameras that are operational, but the employee on scene is not able to review footage without a password. He stated that the employee who comes in at 7am may be able to view them. The employee, Oliver O. ONTIGBUO, M/B 12-29-1964, stated he did not see this incident occur.

There were no other witnesses on scene at the time of this incident.

We checked the area briefly westbound on Good Hope but did not locate the vehicle described.

During our investigation into this incident, two additional armed robberies were reported in District 4, those incidents also had video footage with suspects described in this initial report. Those incident report numbers are 23-227-0020 and 23-227-0024. During investigation into those two incidents a vehicle operator was identified and taken into custody. He was conveyed to Central Booking for processing regarding these incidents.

During our investigation we were able to locate ABIOLA's vehicle keys and wallet which were returned to him at his residence.

This report was written by Police Officer O'Neal STAMPS III, assigned to District Four, Late Power Shift, wearing a full duty uniform, assigned to squad 4467.

NATURE OF CALL/JUSTIFICATION

On Wednesday December 27th, 2023, at approximately 11:52 pm, P.O. Khalid MAJEED and I squad 4467, were dispatched to a SHOOTING complaint, located at the address of 7600 W. Good Hope Rd. (Which is located in the city and county of Milwaukee WI).

Upon arrival PO MAJEED and I observed a subject later identified as (Aiden D. MISURACO W/M 05-30-2005), unconscious and not breathing, with one Gunshot wound to the center of his chest. PO Hunter TUCHEL and PO Roy CAUL (Squad 4441) and I immediately began CPR on MISURACO and P.O. MAJEED, was able to speak with a witness on scene. The witness identified himself as (Phillip A. GRIESE W/M 10-27-2005). PO MAJEED placed GRIESE into the back seat of our fully marked squad car (65427) while PO CAUL and I rotated positions as we performed chest compressions on MISURACO. PO TUCHEL located an exit wound on the back of MISURACO and applied a sterile gauze to the area in an attempt to control the bleeding. PO CAUL and I continued to perform life saving measures until relieved by the responding Milwaukee Fire Department personnel.

MFD attempted to continue life saving measures but were ultimately unsuccessful. MISURACO was pronounced deceased on todays date at 12:15 by DOC 014.

I located a black semi automatic Glock firearm, serial #BVXD504 on the ground near the front driver side tire of a red sedan that was registered to MISURACO. I observed that the firearm was fired to lock back and had blood splattered on the top and side of the I remained with the recovered firearm until it was photograph and collected by the responding Forensic Investigator and Detectives from CIB.

During the investigation I spoke to the clerk in regards to viewing the security camera footage. The clerk identified him self as Chaudhry I ALI (W/M 05/20/1957). ALI directed me to a rear storage room where the DVR for the security camera system was located. Once access was gained for the system it was revealed that the DVR system was not actively recording video footage and this incident was not captured on this day. Further investigation revealed that the last video footage recorded on the device was on December 20, 2023 at 10:00 am. ALI stated that the business owner Shabbir QADIA (W/M 08/15/1979) was currently out of town but will be back the following day to see what happened to the security camera system.

I then remained on scene conducting scene security as family members and associates arrived on scene attempting to enter the scene.

The hearing before the Licenses Committee will take place on 3/26/2024 at 1:25 PM in Room 301-B, Third Floor, City Hall. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony via phone or internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.
